

- Based on substantive work by its drafting Group of experts (CAHENF-IT) in 2016-2017
- Involving an inclusive drafting process by key stakeholders:
 - experts from member and observer States,
 - parliamentarians,
 - international organisations,
 - international non-governmental organisations,
 - academia,
 - the private sector, and
 - children.
- Currently available in nearly 20 languages
- Now being complemented by the Handbook for policy makers – launched today

Key features of the Guidelines:

• Promoting children's human rights and fundamental freedoms online, in a context where the digital environment is reshaping children's lives in many ways

- Pointing to some of the gaps of previous legislation and policies:
 - provision rights, such as access and freedom of expression,
 - children's privacy and data protection,
 - child participation,
 - long-term perspectives,
 - coordination between national stakeholders.
- Addressing both the opportunities and risks of digital technologies for children in a balanced manner







The Guidelines – proposing a consistent checklist

The Council of Europe programme

for policy makers on various "operational principles":



- have you consulted children?
- have you considered and reviewed the evidence?
- have you engaged all relevant stakeholders?
- have you considered vulnerable groups, e.g. children with disabilities?
- have you provided specific remedies for children?

The Guidelines – also addressing business enterprises asking them to:

- Develop, apply and regularly review and evaluate child-oriented industry policies, standards and codes of conduct
- Perform child-rights risk and impact assessments
- Actively engage children to participate meaningfully in devising, implementing and evaluating policies, mechanisms, practices, technologies and resources
- Provide children with information on their rights, including participation rights and access rights to available remedies, in a way they can understand and that is appropriate to their maturity and circumstances

FINAL KEY RECOMMENDATION Member States shall examine the implementation of the recommendation and guidelines every 5 years at least (next time in 2023) and if appropriate even at more frequent intervals
