







# THE ORGANISERS

The rejection of the death penalty is one of the Council of Europe's founding principles: it is legally abolished in almost all member states, and no death penalty has been carried out in the geographical sphere of the Organisation for more than twenty years.

The abolition of capital punishment is a universal trend. Unfortunately, in May 2025, 85 countries still practice it or uphold it in their legal texts<sup>1</sup>.

No right, no democratic advance is ever acquired for ever. Human rights are the result of centuries of struggle by women and men for dignity. Their universality and respect depend on the capacity of each generation to appropriate and develop them. The death penalty is an attack on human dignity and justice. Its existence constitutes a serious attack on a universal culture of human rights everywhere. The resurgence of a prodeath penalty discourse is disturbing and must be fought.

It is with the aim of **creating a network of young ambassadors**, who will continue the fight towards abolition throughout the world, that the Council of Europe, Together against the death penalty and the German Coalition for the abolition of the death penalty, with the support of the Permanent Representation of France to the Council of Europe, are organising the third edition of this training/meeting, based on an idea from the French Ministry of Europe and Foreign Affairs. This training event is thus intended to be repeated and to gradually expand in terms of both the number of participants and their geographical origin.

### THE COUNCIL OF EUROPE

The Council of Europe and its 46 member states have been creating a death penalty-free zone for almost a quarter of a century, with the last execution on its territory taking place in 1997.

In the early 1980s, the Council of Europe became a pioneer in the abolition of capital punishment, considering it to be a serious violation of human rights. The organisation's Parliamentary Assembly has gradually persuaded governments to help Europe become the first region in the world to ban the death penalty once and for all. A ban on the death penalty has also been a precondition for accession since the 1990s.

In 1983, the Council of Europe adopted the first legally binding instrument providing for the unconditional abolition of the death penalty in peacetime: Protocol No. 6 to the European Convention on Human Rights (ECHR). This text has now been ratified by all 46 Member States.

In 2002, the Council of Europe adopted Protocol No. 13 to the ECHR concerning the abolition of the death penalty in all circumstances, i.e. also in times of war or imminent threat of war. Reservations and derogations from the Protocol are not possible. The Protocol entered into force on 1 July 2003. To date, it has been signed and ratified by 45 Member States.



### **ECPM (TOGETHER AGAINST THE DEATH PENALTY)**



ECPM (a non-governmental organisation established in France since 2000) works to combat the death penalty worldwide. The association promotes the universal abolition of the death penalty through advocacy programmes with public authorities, the strengthening of abolitionist civil society, the creation and dissemination

of publications, and support for death row inmates and their families.

ECPM (www.ecpm.org) brings together abolitionists in order to increase their effectiveness and accelerate the movement towards universal abolition of the death penalty. The association is at the origin of the World Congresses against the death penalty, which it organises every three years (Strasbourg 2001, Montreal 2004, Paris 2007, Geneva 2010, Madrid in 2013, Oslo in 2016, Brussels in 2019 and Berlin in 2022) in the presence of several thousand abolitionists from all over the world (civil society, politicians, lawyers, journalists, artists, students, etc.).

ECPM develops programmes to support the strengthening of local partners in many non-abolitionist countries, mainly in the regions of: North Africa, Central Africa, Southeast Asia.

### THE GERMAN COALITION TO ABOLISH THE DEATH PENALTY



The Initiative gegen die Todesstrafe e.V. (German Coalition to Abolish the Death Penalty) has been campaigning for the universal abolition of the death penalty since 1997.

The German Coalition is guided by the 1948 Universal Declaration of Human Rights, the International Covenant on Civil and Political Rights and its additional protocols, and other human rights conventions.

The German Coalition believes that the death penalty is a horrific form of punishment that violates human dignity. The members of the German Coalition respect the condemned person as a person without accepting his or her crime.

GCADP's work focuses on detailed educational work, non-partisan political engagement and support for prisoners.

All the organisers place young people at the heart of their action, because they are essential actors of change for themselves and bearers of evolution for society. Through an inclusive and participatory approach, offering spaces for engagement, ECPM aims to enrich their knowledge on human rights and values related to global citizenship, so that they are better able to develop autonomous thinking and to mobilise themselves on these subjects, as active citizens guaranteeing the fundamental rights!

Marie de L'Estoille worked in the diplomatic unit of the French Ministry of Justice, then was appointed as a judge at the French National Court of Asylum by the United Nations High Commissioner for Refugees, before joining the public prosecutor's office at the judicial tribunal in La Rochelle (France), as a legal expert in charge of juvenile criminal justice (juvenile offenders and violence against minors).

Advocacy officer, Amnesty International France



Aymeric Elluin is a legal expert in international public law and holds a master of science in disarmament and arms control law. In 2006, he joined Amnesty International France to coordinate the "Control Arms" cam-

Clare Ovey became the Director of Human Rights on 1 August 2024. Born in London, she studied Law at Cambridge University and qualified as a solicitor in England, working primarily in the field of criminal

law. After three years working in the criminal law team of the Law Commission of England and Wales, an independent statutory law reform body, she joined the Registry of the European Court of Human Rights in 1995. She started working on the execution of the Court's judgments in 2015 when she was seconded to the Secretariat of the Committee of Ministers, with primary responsibility for the Committee's human rights (DH) meetings. In April 2018 she transferred to the Department for the Execution of the Judgments of the European Court of Human Rights, where she became Head of Department in July 2020. She is the author of one of the leading English-language textbooks on the Convention system.



#### SÉBASTIEN POTAUFEU

Senior advisor for Human rights, Coordinator for the Abolition of death penalty, Council of Europe



Sebastien Potaufeu has joined the Council of Europe since September 2023 as Senior adviser for Human rights and Coordinator for the Abolition of the death penalty. Besides the implementation of the Reykjavik summit declaration

regarding the abolition of the death penalty, he is also dealing inter alia with NHRIs, Ombudspersons and national preventive mechanisms, and civil society. He is a career diplomat seconded to the Council of Europe, and previously worked as Deputy Permanent Representative in the French Permanent Representation to the Council of Europe where he, inter alia, coordinated the French Presidency of the Committee of Ministers. In the French diplomatic service, he garnered expertise in multilateral negotiations, human rights, European issues, law, security and defense.

#### **ANDRES PEREZ**

Human Rights Officer - Death Penalty, Prevention of Genocide; Office of the United Nations High Commissioner for Human Rights



Andrés Pérez is a lawyer and Human Rights Officer for OHCHR's Rule of Law and Democracy Section where he serves as the focal point for the death penalty and prevention of genocide. He has twenty years of experience working in international

human rights, criminal justice, and security sector reform, including five years as a lawyer for the U.N. International Criminal Tribunal for Rwanda where he worked on eleven cases at the trial and appellate levels. Andrés has also worked for the Public International Law and Policy Group (PILPG), the Royal United Services Institute (RUSI), and the U.N. International Commission of Human Rights Experts on Ethiopia where he served as Chief of Investigations. He is a citizen of Venezuela and the United States of America.

#### **NICOLAS PERRON**

Program Director,
Together against the death penalty



Nicolas Perron has worked for ECPM since 2008. As Director of Programs, he oversees all of ECPM's activities in France and internationally, particularly in the MONA region, sub-Saharan Africa and Southeast Asia. He

regularly represents the association in the field and participates in dialogues with political actors and intergovernmental organizations.

#### SHENAH RAZABI

KMMK-G Representative to UN and UE



Shena Razabi is a kurdish activist and human rights defender living in Finland. she moved to Finland with her family in 2001 through UNHCR. she has been working as a human rights activist since 2011 and has been

involved in organizations that promote human rights and the rights of kurds. currently, she represents kurdistan human rights association-geneva at the UN and the EU.

#### **MARYIA SLIAPTSOVA**

Human Rights Expert, Directorate for Human Rights, Council of Europe



Maryia Sliaptsova is a human rights lawyer from Belarus, holding degrees in International Human Rights Law and Comparative Constitutional Law. She has more than a decade of experience working with Belarusian civil soci-

ety organisations, providing legal expertise, and consulting on various issues of advocacy and capacity building. For several years, she had been involved with the "International Law in Advocacy in Belarus" (ILIA-By) educational program for lawyers and human rights defenders. Prior to her placement with the Council of Europe, where she is working with the Coordinator for the Abolition of the death penalty, she coordinated international advocacy efforts for the Belarusian human rights organization Respect-Protect-Fulfill.



#### SAMAN YASIN

Kurdish rap artist, former political prisoner, former death row prisonner in Iran in 2022



Kurdish rap artist, former political prisoner, former death row prisoner In Iran In 2022 Saman Yasin is a Kurdish rap artist from Kermashan. He is a survivor of the repression of the Women, Life, Freedom

movement in Iran in 2022. He was arrested and sentenced to death, charged with 'declaring war on God' and 'crimes against state security.' His death sentence was later overturned due to international pressure."

After his arrest, Yasin endured extreme torture. He was subjected to inhumane treatment, including both physical and psychological violence, and was held for extended periods in a cold cell. He was coerced into confessing to crimes he did not commit, including alleged participation in an armed protest. He also experienced what is known as a "mock execution," a method where prisoners are made to believe they are about to be executed — a tactic used by Iranian security forces to break their will and instill fear.

In December 2024, he escaped from Iran with the help of a smuggler, traveling through Iraqi Kurdistan before finally arriving in Germany in January 2025. Since then, Yasin has shared his experiences with the United Nations Human Rights Committee in Geneva and is now focused on continuing his music career in Germany.

#### ME. RENIS ZAGANJORI

Lawyer, Directorate of Jurisconsult, European Court of Human Rights



Renis Zaganjori joined the jurisconsult's Department of the European Court of Human Rights in 2020, where he has held various positions in the CHRKnowledge Sharing and Research Unit and in the Case

Law Monitoring Unit. Since 2023, he has been coordinator of the latter, which is responsible for monitoring deliberations in the Court's five sections. He is also partly responsible for coordinating matters relating to Articles 2 and 3 of the Convention within the Division. Before joining the Court, Renis was a lawyer and was involved in the academic world in his home town of Tirana, Albania.

#### **CLAUDE WILD**

Ambassador, Permanent Representative of Switzerland o the Council of Europe



Né à Lausanne/VD en 1964 et originaire de Maur/ZH, est titulaire d'un diplôme en sciences politiques et relations internationales de l'Institut universitaire de hautes études internationales de Genève. À

l'issue de ces études, il a suivi un cursus complémentaire en politique de sécurité auprès de ce même établissement. Après avoir acquis plusieurs expériences professionnelles à l'étranger et en Suisse, il est entré au service du Département fédéral des affaires étrangères en 1992 et a effectué son stage diplomatique au sein de la Direction du développement et de la coopération ainsi qu'à Lagos. Il a ensuite été détaché pour une courte période à Vienne auprès du ministère autrichien de la défense, avant de rejoindre la centrale en 1994, où il a exercé la fonction de collaborateur diplomatique, puis de chef suppléant de la section Politique de paix au sein de l'ancienne Division politique III. En 1997, il a été transféré à Moscou, où il s'est occupé des affaires politiques et des questions relatives aux droits de l'homme en Fédération de Russie, en Arménie, en Azerbaïdjan et en Géorgie. En 2000, il est retourné à la centrale, où il a pris la tête de la section Politique et institutions au Bureau de l'intégration DFAE/DFE et participé aux négociations portant sur les Accords bilatéraux II entre la Suisse et l'UE. En 2004, il a été nommé chef de mission suppléant à Ottawa, avant d'accéder, en octobre 2007, au poste de chef de mission suppléant à la Mission de la Suisse auprès de l'Union européenne à Bruxelles. À partir d'août 2010, Claude Wild a assumé la fonction de chef (avec titre d'ambassadeur) de la division Sécurité humaine au sein de la Direction politique à Berne. En août 2015, il a été nommé représentant permanent (avec titre d'ambassadeur) de la Suisse auprès de l'OSCE, de l'ONU et des organisations internationales à Vienne. Depuis septembre 2019, il est chef de mission à Kiev et, à ce titre, ambassadeur de Suisse en Ukraine et en République de Moldavie.

# PRACTICAL INFORMATIONS



The European Youth Centre Strasbourg (EYCS) is an international training, education and conference centre which hosts participants attending activities organised by the Council of Europe's youth sector or any other entity of the organisation.

External event organisers can also request to hold meetings, seminars or training courses in the Centre's facilities, which include onsite accommodation and catering services.

These facilities can be used for the activities of any external organisation, association, institution, structure or youth network which respects and defends the Council of Europe's values.


### HOW TO GET TO THE EUROPEAN YOUTH CENTRE

CTS is Strasbourg's public transport company. Maps and a trip planner for getting around Strasbourg can be found on its website: https://www.cts-strasbourg.eu/en/

For the EYCS, get off at the stop called Parlement Européen.

Tickets can be bought from the ticket machines at tram stops, on the internet or via the CTS mobile application. Once validated, the ticket allows you to make as many connections as you like on the Strasbourg public transport network during 1 hour. Each time you change buses or trams, you need to validate your ticket again.

Be warned: it will be more expensive to buy your bus ticket on board a bus rather than before your journey.



From Strasbourg railway station: 16 minutes
A new route has opened: Bus H provides
a rapid transit connection between
Strasbourg railway station and the European
Parliament. It only serves 10 stops and runs
every 10 minutes during the day.

## From Strasbourg Airport, Entzheim: 55 minutes

Take the TER Alsace rail shuttle (TER means Regional Express Train) from the station right next to the airport.

The Tram+TER ticket allows you to travel to and from the airport and the CUS (Strasbourg Urban Community). This combined Tram-Bus-Train ticket can be used for 1.5 hours after validation

By taxi: 15 minutes from city centre

In town, you can get a taxi at the Railway Station or near the Homme de Fer tram stop. A taxi from Strasbourg city centre to the EYCS will cost 15-25 euros.

The organisers will only pay for public transport, which is essential for the workshop to run smoothly (i.e. one bus or tram ticket from the station/airport to the EYC and one bus or tram ticket from the EYC to the station/airport).
