






#### National level – 1<sup>st</sup> wave

#### Measures taken – March 2020

### **Prison management:**

- Body temperature checks and hand disinfection at entrances
- Obligatory face masks
- Isolation cells/rooms for symptomatic inmates
- Protective material (face masks, respirators, gloves, goggles, protective suits)
- Limitation of prisoner transfers
- Video conferences with courts and attorneys
- Limitation of entries of external workers (probation, NGOs, Churches,...)





#### Measures taken – March 2020

### **Prisoners:**

- Family visits and prison leaves suspension
  - Compensations:
    - Extension of phone call time
    - Video visits
    - Extra parcel
    - More money for purchase in prison shops
    - More outside time
    - Extended treatment program activities
- Obligatory face masks outside cells or bedrooms
- 14-day quarantine for new admissions
- Limited external employment (outside prisons)
  - Loss of 1,300 working places till October





#### Measures taken – March 2020

## Staff members:

- Body temperature checks and hand disinfection at entrances
- Obligatory face masks, respirators for certain positions
- Quarantine for people returning from abroad
- Online lessons and exams for recruits
- Home office where possible (HQ+administration)





#### Face masks – Prison Service production

#### March – June:

- 276,000 re-usable cotton face masks
- 1,1 mil single use nanofibre face masks
- Protective suits, face shields (3D printers)

• 300,000 nanofibre single use

• Firebrigades, MoJ and justice

• 72,000 cotton re-usable

#### **Prison Service:**

- Inmates cotton re-usable (exchanged and disinfected by PS)
- Staff members




#### Supply to other organizations: Current state

- Use of masks on stock
  - Restart of production expected in November – cotton re-usable only



  - More independence and responsibility
