

The launching event will present the findings of the report on the Impact of Covid 19 on Women's Access to Justice in Europe. The event will offer an opportunity to participants to discuss ways forward on addressing the persistent and emerging challenges for Council of Europe member States in ensuring equal access to justice for women and men, including in times of crisis. The event will be an opportunity for members of the Gender Equality Commission to reflect on the status of implementation, at national level, of the Council of Europe Gender Equality Strategy 2018-2023, and more particularly its third strategic objective on ensuring equal access of women to justice. Participants will also exchange on how to integrate the findings of the research in post pandemic policies promoting gender equality.

The participants will be representatives from the national authorities, relevant national stakeholders and civil society organisations, including legal professionals, involved in promoting and implementing the European Convention on Human Rights, as well as the Istanbul Convention standards.
