Promoting equality and combatting discrimination **Initiatives at the Council of Europe and in Italy**

High-level event of the Italian Presidency of the Committee of Ministers of the Council of Europe at the 5th meeting of the Steering Committee on Anti-Discrimination, Diversity and Inclusion (CDADI)

The promotion of equality, the fight against discrimination and the protection of vulnerable groups belong to the key priorities of the Strategic Framework of the Council of Europe for the years 2020 to 2025. Italy has, for its part, confirmed its commitment to fighting all forms of discrimination in the priorities for its Presidency of the Council of Europe's Committee of Ministers.

To encourage progress in these policy areas, the Council of Europe has set up the Steering Committee on Anti-Discrimination, Diversity and Inclusion (CDADI), which is composed of representatives of the 47 member states. During the first two years of its existence, the Committee developed ground-breaking standard-setting texts to promote comprehensive strategies against hate speech, uphold equality during the Covid-19 pandemic and implement multi-level policies and governance for intercultural integration.

The Committee of Ministers of the Council of Europe has mandated the CDADI to work on other ambitious deliverables over the four years to come. This includes standards for the active political participation of national minority youth, for combating hate crime, equality for Roma and Traveller women and girls, artificial intelligence systems and their discrimination risks, the equality of rights of intersex persons, and on desegregation and inclusive education.

This Presidency event, which marks the beginning of the second biennium in the work of the CDADI, will highlight the work already finalised and the future priorities of the Committee. At the same time, it will point to achievements and initiatives under way in Italy in the fields of anti-discrimination, diversity and inclusion, in particular the inclusion of Roma and Travellers, intercultural integration of migrants and refugees, and combatting discrimination and intolerance on various grounds including religion or belief, sexual orientation or gender identity.
