#### Background

A gender perspective has rarely been applied in the analysis of the drug situation, interventions and policies, representing the drug phenomenon mainly as gender-neutral, despite the large gender differences in numbers, risk factors, behaviours, consequences of drug use and requested interventions. When gender has been taken into account in the drugs field, it has been from a binary perspective and with a focus placed on some women-specific issues (e.g. pregnancy and child care), without consideration of the diversity between and within genders.

This symposium is the first major event organised at European level on the topic of gender and drugs. Its aim is to shed light on the drug phenomenon from a gender perspective, by discussing recent developments in the current gender theories and their relation with drugs; findings from drug research and monitoring; key factors influencing gender pathways in drug use and addiction; recent developments in gender-sensitive related interventions. In the final session representatives of different stakeholders in the drugs field will discuss why and how to incorporate a gender perspective in the implementation of drug policies.

This event is the result of the work of the European group on Gender and Drugs (EGD), set up in preparation of LX Addiction conference 2019. The group is coordinated by the EMCDDA and the Pompidou Group of the Council of Europe, together with UNICRI (United Nations Interregional Crime and Justice Research Institute), EIGE (European Institute for Gender Equality) and several drug experts from different countries.

Due of time constraints it is not possible to include many of the diverse aspects of the gender and drugs topic; this will be the subject of future discussions and opportunities.

#### Objective of the symposium

- to discuss implications of the recent debate on gender for the drugs field;
- to present an overview of gender differences in the drugs field;
- to discuss key issues surrounding gender and drugs;
- to exchange knowledge on gender-sensitive interventions in the drugs field;
- to discuss possible approaches to incorporate a gender perspective in drug policy;
- to facilitate exchanges among experts around gender and drugs;
- to promote a systematic inclusion of a gender perspective in the drugs field.

#### Structure

The event is organised in five plenary sessions. Each session will start with a general presentation – not drugrelated – which will be followed by presentations focusing on drugs and gender in the areas of gender theories, drug epidemiology, gender-based violence and drug-related interventions. A final dialogue on how to incorporate a gender perspective in drug policy will take place with representatives of different stakeholders: policymakers, practitioners, users' organisations and scientists.

#### **Practical information**

The event will be held in person at Lisbon Congress Centre (Praça das Indústrias, 1300-307 Lisboa) on 22 November 2022 from 9.00 to 17.30- Room 5B. No online sessions are planned at the moment. In the evening there will be a social event and an exhibition on women's recovery pathways will be shown during the event. All presentations will be recorded and made available on the EMCDDA and PG-COE websites after the event.
