# 4<sup>th</sup> Periodic Meeting of the Network of Corruption Prevention Agencies

# Tunis, Tunisia 17-18 October 2019

### Minutes of the discussion

The meeting, the 1<sup>st</sup> regional event since the Network was created in 2018, aimed at enhancing cross-Mediterranean partnerships and exchange of good practices in the anti-corruption field saw the accession of Jordanian JIACC, Moroccan INPPLC and Tunisian INLUCC. Additionally, Tunisian Anti-corruption Authority (INLUCC) signed Memorandums of Understanding with its Moroccan and Jordanian counterparts. The Network now has 23 anti-corruption authorities. The Network continues to appreciate the Council of Europe and the GRECO Secretariat for the logistical and organizational support.

- 4) Technical Guide on Corruption Risk assessment. A discussion paper was presented by the Council of Europe. The Network commended this very professional paper. The Members have agreed in moving forward in the creation of guidelines on this topic.
- 5) Technical Guide on Codes of Conduct.

The final draft was presented to the Members, for concluding discussion. It was reminded that approvals by the Network happens by consensus, as opposed to unanimity. After discussion and presentation of the guide on the codes of conduct, the Members have consented to this draft, which was conditionally approved, pending no-objection from the 3 new Members.

#### 6) Technical Guide on Transparency

Complexity of the subject remains. Nevertheless, in order to tackle this issue and start developing a comprehensive guideline on transparency, the Network has decided that single issues should be analysed separately and re-aggregated in a second phase. So far, the following agencies have committed to advance and present single papers on:

- a. Transparency in the legislative process
- b. Asset declarations
- c. Whistleblowing + other sectors (including employment)
- d. Transparency in business sector

It was reminded that ideally there are 2 types of papers that can be prepared by the Network, namely:

- a) **Discussion papers**: these are studies for presentation of a subject to the Group, for further discussion and conclusion. These papers have no fixed framework.
- b) **Guidelines**: These are more structured documents, through which the Network recognize, raise, approve and/or suggest good practices and (non-binding) recommendations on single subjects, instruments and principles linked to the prevention of corruption. The guidelines should adhere, as much as possible, to the following structure:
  - 1. Background and justification
  - 2. Recommendations
  - 3. Challenges and solutions

- a. Defining the purpose and content of [subject]
- b. Defining the scope of application
- c. Reach effective implementation
- 4. Monitoring high standards of [*subject*]
  - a. Who is responsible for monitoring compliance?
  - b. Monitoring Tools
  - c. Reporting mechanisms
  - d. Building awareness
- 5. Basic conditions for successful implementation of [*subject*]
- 6. Relevant readings
- 7) Presentation of results and discussions on on-going projects:
  - a. Mapping of anti-corruption agencies internationally
  - Small facilitation payments
  - Perceptions of corruption in relation to prevention of corruption
- 8) Roundtable discussion: "Challenges faced by anti-corruption authorities in institutional transition processes & how to overcome them?"

The Group discussed about the subject of independence and stability of the anticorruption agencies. The Members of this Network are particularly sensitive and attentive to the independence of ACAs vis-à-vis undue political pressure. Therefore, it was decided to start a discussion paper (called "Jakarta principles and beyond") on the Jakarta Statement on Principles for Anti-Corruption Agencies (of November 2012, see at <a href="https://www.unodc.org/documents/corruption/WG-Prevention/Art\_6">https://www.unodc.org/documents/corruption/WG-Prevention/Art\_6</a> Preventive anti-corruption bodies/JAKARTA STATEMENT\_en.pdf).
