Thematic area: Formal and informal education on entrepreneuship

1.	The City should send an initiative through the Education Council of

2.	Once a year, the city should organize and finance a competition

6.	Creating a website that will be under the jurisdiction of the Entrepreneurial Center of banja luka with all the necessary information for potential entrepreneurs, by the end of the current year.	87.50 %
7.	Creating a database of video materials for the purpose of educating potential entrepreneurs by successful entrepreneurs.	100.00 %
8.	Creating a special plan and program by the Entrepreneurial Center of banja luka, in cooperation with professionals, which would be adapted to people with developmental difficulties and which would be located on the website of the entrepreneurial center. The purpose of the customized plan and program is to inform and support people with disabilities in the realization of their entrepreneurial idea.	91.67 %
9.	The website of the Entrepreneurial Center of Banja Luka should include the promotion of all events in the field of entrepreneurship, a database of donors and potential investors, accumulated data and performed analysis for the need of labor in the city of Banja Luka, as well as contact details of all relevant offices and institutions related to this topic.	95.83 %

Thematic area: Fund for support to young entrepreneurs

No.	Recommendation	Support
10.	To form a financial fund in the budget of the city of Banja Luka, which will include subsidies to young entrepreneurs for start-up capital and / or working capital under certain conditions.	91.67 %
11.	From the fund finance activities that are needed for the sustainable development of local self-government units (activities that have greater potential for growth and development, and employment) with different lines of financing for small and large independent entrepreneurs. In accordance with the recommendation, make an analysis of the market of activities necessary for the sustainable development of local self-	75.00 %

Thematic area: Public visibility of youth entrepreneurship – promotion

No.	Recommendation	Support
17.	Creating a special section on youth entrepreneurship within the official website of the City of Banja Luka for the purpose of promoting youth entrepreneurship where you could find all the necessary information and promote successful young entrepreneurs. Communication should be mutual, two-way. Questions and answers should be public and accessible to all visitors of the City Channel.	70.83 %
18.	The City of Banja Luka should initiate a request to the Public Service of the Republic of Srpska for the introduction into the program scheme of the show on entrepreneurship (eg My Business our business), with the obligation to show it through social networks of the public service.	70.83 %
19.	Inspection bodies should have an educational approach during the first controls of young entrepreneurs, and the formation of an educational center in the Department of Inspection Affairs and Communal Police of the City of Banja Luka.	70.83 %
