Dear Gudrun, Dear Gaye,

Following the conference in Saint Petersburg in 2018, the Governor of Khanty-Mansiysk Autonomous Okrug-Ugra sent a letter presenting a draft concept paper for setting up a Eurasian Association of Women – Regional Leaders "Eurasian Association of Women – Regional Leaders". The concept paper contained your name as representatives of the Congress to take part in a preparatory working group.

This letter was examined by the Bureau on 29 January in Paris. The Bureau considered that the Congress should not take part in this initiative, given the participation of politicians from Crimea and a reference to Crimea as a "part of the Russian Federation".

The Bureau entrusted me to inform you that a participation as Congress member could not be envisaged and that no reference to the Congress should appear on any related material.

I rely on your understanding and the respect of this decision.
