The Committee of the Parties (hereinafter referred to as "the Lanzarote Committee" or "the Committee") to the Council of Europe Convention on the Protection of Children against Sexual Exploitation and Sexual Abuse (hereinafter referred to as "the Lanzarote Convention" or "the Convention") held its 35th meeting remotely on the KUDO platform on 30 November – 3 December 2021.

- 1. Opening of the meeting, adoption of the agenda and up-date on ratifications/accessions to the Lanzarote Convention
- 1. The Committee adopted its agenda. It appears in Appendix I. The list of participants appears in Appendix II.
- 2. Monitoring of the implementation of the Lanzarote Convention
- 2.1. "The protection of children against sexual exploitation and sexual abuse facilitated by information and communication technologies (ICTs): addressing the challenges raised by child self-generated sexual images and/or videos"
- 2. The Committee dealt with all issues appearing as comments in documents T-ES(2021)36 (draft implementation report excluding its draft chapter I) as well as document T-ES(2020)23 rev.2 (draft chapter I on legal frameworks) and noted that only the section on sexual coercion and extorsion of draft chapter I remained to be examined during the next meeting (22-25 February 2022). In this regard, it also noted that this section will be reviewed by the Bureau during its meeting of 13-14 December 2021 and will be submitted to the Committee in January 2022.
- 3. The Committee then went through all recommendations in the above-mentioned documents where Parties are listed to verify whether, in light of additional information made available, Parties could be removed from such lists.
- 4. The Committee took note that the Russian Federation had asked to remove from the draft implementation report Recommendation I-5 which requires the criminalisation of the possession by adults of "child pornography", in light of the following concerns voiced by the State Duma of the Federal Assembly of the Russian Federation that indicated that "legislative changes according to this Recommendation, in modern conditions of information and communication technologies development may entail unjustified mass prosecutions, since if the proposed changes are made, they might lead to cases of storing materials or objects of pornography on media used by data transmission operators in the course of their activities, as well as items obtained as a result of measures to restrict the dissemination of illegal information; meanwhile, the telecom operator might not know about the content of the transmitted information".
- 5. The Committee decided nonetheless to retain this recommendation in its draft implementation report and to maintain the Russian Federation among the recipients of this recommendation as its current legislation is not in line with Article 20(1)e of the Lanzarote Convention.

- 6. It agreed that last additional information to seek to demonstrate compliance with the recommendations requiring or requesting given Parties to act could be submitted to the Secretariat (lanzarote.committee@coe.int) at the very latest by **10 December 2021**.
- 2.2. "Protecting children affected by the refugee crisis from sexual exploitation and sexual abuse": compliance procedure concerning the Lanzarote Committee's special report
- 2.2.1. Consideration of the following draft compliance reports in view of their adoption:
 - R11 on protection to child victims
 - R12 on prosecution of offenders
 - R15 on information and advice to children
 - R37 on a coordinated approach between responsible agencies
- 7. The Committee examined these four draft compliance reports thoroughly and, after having agreed on some modifications to them, adopted the compliance reports concerning Recommendations R12 on prosecution of offenders and R15 on information and advice to children.
- 8. It agreed that draft compliance reports concerning Recommendations R11 on protection to child victims and R37 on a coordinated approach between responsible agencies, as well as the drafts concerning Recommendations R7 on mechanisms for data collection, R13 on coordination and collaboration of different actors and R31 on child-friendly proceedings (which were not on the agenda of the current meeting) will be considered at its 36th meeting (22-25 February 2022) in view of their adoption.
- 9. The Committee agreed that additional information to seek to demonstrate compliance with these Recommendations (R7, R11, R13, R31 and R37) could be submitted to the Secretariat (lanzarote.committee@coe.int) at the very latest by **10 December 2021**
- 3. Exchange of information, experiences and good practices
- 3.1. Panel showcasing of Lanzarote Committee observers recent and up-coming work
- 10. Ms DE CRAIM (Chairperson of the Lanzarote Committee) pointed out that this panel is a first of what could become a regular end of the year initiative to give greater visibility to the relevant work carried out by the civil society observers to the Lanzarote Committee. She added that such a panel could be extended to also cover relevant initiatives by its participants. In addition, she clarified that this does not exclude that specific presentations be organised during other meetings if its observers, participants and members wish to share precise information during another meeting (other than the last one of the year).

ECPAT-International

11. Ms CZARNECKI (ECPAT Deputy Executive Director) presented the study carried out by her organisation in eight countries, across the European Union, to explore public

attitudes towards online child protection and privacy (Project Beacon).

- 12. She indicated that the research has shown widespread public support to give-up a piece of their privacy for the use of tools to identify child sexual abuse materials, and for the European Union to ensure longer-term changes to legislation that will keep children safe online. She highlighted that the key findings are:
 - 68% of respondents support plans by the European Union to introduce new legislation on the detection of child sexual abuse material by private companies;
 - 76% of respondents said that allowing online service providers to be able to detect and flag any signs of child online sexual exploitation or abuse is more or as important as their privacy online;
 - An average of 73% of adults believe children cannot go online without being approached by adults looking to harm them;
 - Nearly 7 out of 10 respondents feel that there is not much, if any, privacy online. Those who believe online privacy does not exist (68%) outnumber those who believe it does (25%) by more than two to one;
 - Over 3/4 of respondents believe protecting children from abuse is as important or more important than the protection of their own privacy.

The International Association of Internet Hotlines (INHOPE)

13. Mr HOWARD (INHOPE's Executive Director) reminded that there is always a victim behind any child sexual abuse material found online (which may remain accessible on the internet for decades) and that awareness, prevention, reporting and removal minimise the consequences for the child victim (even after becoming an adult). He explained what hotlines' role is for each of these four stages, and noted that national hotlines – which exist in nearly all Parties to the Lanzarote Convention – can be found on INHOPE's website.

Internet Watch Foundation (IWF)

- 14. Ms FEDOROVSKY (Policy and Public Affairs Assistant) informed the Committee about IWF work to raise awareness on self-generated child sexual abuse images/videos.
- 15. She emphasised, in particular, that, in a study carried out by IWF in October 2021, 67% of the reports received by IWF between 1 January and 30 September 2021 included self-generated child sexual abuse imagery, which was a 27% increase since 2020 (138% increase in the number of reports which include self-generated imagery of 11-13 years old children; 186% increase in the number of reports which include self-generated child sexual abuse of 7-10 years old).
- 16. The, she presented the following two prevention campaigns led by IWF in the United Kingdom and stated that they can easily be adapted to other national contexts:
 - Gurls out loud to help girls aged 11-13 recognise the actions of offenders, feel empowered to block, report and tell someone they trust;
 - <u>T.A.L.K.</u> to raise parental awareness of this criminality and motivate and educate them to help protect children, with, in particular, a shocking video to

make parents understand that without protection they leave their door open to online sexual offenders to access their daughters.

- 17. Ms FEDOROVSKY also described the <u>Report Remove</u> tool developed with NSPCC and in partnership with age verification app. <u>Yoti</u>, to support a young person in reporting sexual images or videos shared online and enable them to get the image removed if it is illegal.
- 18. Finally, she presented to the Committee the new tool <u>IntelliGrade</u>, which enables IWF analysts to accurately grade child sexual abuse images and videos, while automatically generating unique hashes (digital fingerprints) which are used to identify and eliminate these images wherever they appear. She highlighted that IntelliGrade allows to enrich these hashes with additional contextual metadata which are compatible with child sexual abuse laws and classifications in multiple legal jurisdictions around the world, and the Interpol Baseline standard

WeProtect Global Alliance

- 19. Ms SETTER (Head of Policy at WeProtect Global Alliance) presented the <u>2021</u> Global Threat Assessment report, which includes the results of a <u>survey of technology</u> companies.
- 20. She emphasised in particular, with regard to the 2021 Global Threat Assessment report that:
 - The US National Center for Missing and Exploited Children processes on average 60,000 reports of child sexual abuse online every day;
 - The Internet Watch Foundation saw a 77% rise in child 'self-generated' sexual material from 2019 to 2020.
- 21. As for the Survey of technology companies carried out on February-March 2021, she indicated that:
 - 84% of companies surveyed have at least partly automated processes for forwarding reports of child sexual abuse online, suggesting that report management is relatively efficient;
 - While most companies use tools to detect child sexual abuse material (87% use image 'hash-matching'), only 37% currently use tools to detect the online grooming of children. In addition, the use of advanced classifiers to detect video and livestream content, is less common despite the fact this category is becoming more prevalent;
 - Most reports are at least partly automated, and almost all companies have some form of reporting mechanism;
 - Prevention measures such as deterrence messaging and child safety resources are widely provided, but these are less common than use of hash-based detection, despite their potential to prevent abuse before it occurs;
 - Many companies use tools developed by others, but it is less common for them to develop tools in-house and share them;
 - Most companies do not yet publish transparency reports. However, of

companies that do, a large majority publish specific data on child sexual abuse and exploitation.

- 22. Ms SETTER then presented a <u>global survey</u> conducted with Economist Impact directed to 18 to 20 years olds in 54 countries worldwide about childhood experiences of online sexual harms, and pointed out, in particular, that:
 - 54% of respondents (18 to 20 years old) had experienced at least one of the four online sexual harms considered;
 - 1 in 3 (34%) of respondents were asked to do something sexually explicit online they were uncomfortable with during childhood;
 - 29% of all respondents had received sexually explicit content from an adult they knew or someone they did not know;
 - 25% of all respondents had an adult they know or someone they did not know ask them to keep part of their sexually explicit interactions online a secret;
 - 29% of all respondents had someone share sexually explicit images and/or videos of them without their permission (18% shared by a peer);
 - The age at which children are first exposed to sexually explicit content seems to be dropping. The average age of first exposure among 18-year-old respondents was 12.7 years old, almost a full year younger than the average age of first exposure among 20-year-old respondents (13.4 years).
- 23. To end on a positive note, she highlighted nevertheless that despite the challenges, there is hope since countries, companies and charities are all involved in tackling this crime and that even if the pace of change is not yet fast enough, it is happening, and that online safety technology is more accessible and advanced than ever. She acknowledged the many remaining issues to tackle to fight effectively against online child sexual abuse material, in particular child self-generated sexual images and/or videos, and the need to have a fuller understanding of the use of such images and/or videos by children themselves through child participation.
- 3.2. Presentation of the draft report on "Contribution to the Implementation of the Lanzarote Convention and Engagement with the Lanzarote Committee: A civil society perspective"
- 24. Ms CZARNECKI (ECPAT Deputy Executive Director) and Ms RUTAI (independent consultant) presented the draft report on "Contribution to the Implementation of the Lanzarote Convention and Engagement with the Lanzarote Committee: A civil society perspective", based on an online survey circulated among members of civil society organisations (CSOs). They drew the Committee's attention to the following preliminary findings:
 - The observer CSOs' role, function and possible impact on the work of the Lanzarote Committee are not clear for civil society organisations;
 - Mobilisation and coordination with regard to the representation at the Lanzarote Committee within the networks of the observer CSOs widely differs;
 - Civil society organisations would expect the observer CSOs to share information and good practices, open opportunities for engagement and ensure access to the Committee.

- 25. They also called on the Lanzarote Committee to share its views on how it may support:
 - A more active civil society contribution to the implementation of the Convention;
 - A more active civil society engagement in the monitoring of the Convention;
 - The observers' initiative to mobilise and organise civil society work against sexual exploitation and abuse of children.
- 26. Finally, they informed the Committee that the final version of this report would be adopted soon by a focus group and that it will be circulated to the members of the Lanzarote Committee in due time.
- 27. The Lanzarote Committee acknowledged the contribution of this report to its reflection on strengthening the effectiveness of the Lanzarote Convention monitoring mechanism and procedure and agreed to examine the final version of this report at a forthcoming meeting.

3.3. Introduction to the 2nd Additional Protocol to the Budapest Convention

- 28. Mr SEGER (Head of the Council of Europe Cybercrime Division) informed the Lanzarote Committee that the 2nd Additional Protocol to the Budapest Convention on enhanced cooperation and disclosure of electronic evidence was adopted on 17 November 2021 by the Committee of Ministers (opening to signature scheduled for 12 May 2022). The Committee took note that other language versions of the Additional Protocol than French and English are available in an appendix to a <u>Proposal for a Council Decision authorising Member States to ratify the 2nd Additional Protocol to the Budapest Convention (Document COM(2021)719 final ANNEX 2).</u>
- 29. Mr SEGER indicated that this new instrument was needed due to the increasing complexity of obtaining electronic evidence that may be stored in foreign, multiple, shifting or unknown jurisdictions. Thus, the Protocol will provide to States that will ratify it, a legal basis for disclosure of domain name registration information and for direct cooperation with service providers for subscriber information, effective means to obtain subscriber information and traffic data, immediate co-operation in emergencies, mutual assistance tools, as well as personal data protection safeguards.
- 30. In addition, Mr SEGER considered that this instrument will be useful, for States that will ratify it, also with regard to the fight against online child sexual exploitation and abuse since it aims at a more effective fight against all cybercrimes and any crime involving electronic evidence.
- 31. The Russian Federation wished to underline that States which have not ratified the Budapest Convention and its Protocols have other instruments and means to combat all cybercrimes and all crimes involving electronic evidence.
- 32. Finally, in response to a question on work in the pipeline of the Cybercrime

Convention Committee (T-CY) following the adoption of this Protocol, Mr SEGER referred to the setting up of a working group on undercover investigations and extension of searches.

- 3.4. Debriefings by Lanzarote Committee members having participated in meetings of Council of Europe bodies on the Lanzarote Committee's behalf and/or information on the preparation of the next Council of Europe Strategy for the Rights of the Child
 - Steering Committee for the rights of the child (CDENF) and its subordinate bodies
- 33. Ms LAMBRECHT-FEIGL (Co-Secretary to the CDENF) informed the Lanzarote Committee of the two webinars held on 22 November 2021 in the context of the CDENF series of webinars on COVID-19 and children's rights, on Children's Mental Health and on Intrafamily Violence (the latter was a Council of Europe Contribution to the 2021 Edition of the European Day for the protection of children against sexual exploitation and sexual abuse).
- 34. She also indicated that the new Council of Europe Strategy for the Rights of the Child (2022-2027) was adopted by the CDENF at its 4th plenary meeting (13-15 October 2021) and will be launched in a conference in Rome on 7-8 April 2022.
- 35. Finally, she informed the Committee about the state of play of the activities of the Committee of Experts on the rights and the best interests of the child in parental separation and in care proceedings (CJ/ENF-ISE) and of the Working Group on responses to violence against children (CDENF-GT-VAE), and about the work underway regarding the rights of children and children's participation in the decision-making process in the biomedical field, jointly with the Steering Committee on Bioethics (DH-BIO).

Cybercrime Convention Committee (T-CY)

36. In addition to the presentation made by Mr SEGER (see above under item 3.3), the Lanzarote Committee was informed by Ms CASTELLO-BRANCO (Vice-Chairperson, Portugal) of the Octopus Conference (16-18 November 2021), in particular her participation in a workshop on automated detection of child sexual abuse materials.

European Committee on Legal Cooperation (CDCJ)

- 37. Ms CASTELLO-BRANCO also referred to the <u>International Conference on "Statelessness and the right to a nationality in Europe: progress, challenges and opportunities"</u> (23-24 September 2021) during which a debate on child friendly Justice was held.
- 38. She informed the Committee that the CDCJ was having its 97th Plenary meeting on the same days as the current Lanzarote Committee meeting (1-3 December 2021) and

that its work included documents that could be of interest to the Lanzarote Convention Parties. She will provide information on the below documents at a forthcoming meeting of the Lanzarote Committee:

- A feasibility study on a legal instrument on the protection of the best interests of the child in situations of parental separation;
- A revised checklist for assessment of gender equality aspects and impact.

Exchange with the Council of Europe Secretary General and other heads of monitoring bodies

39. Ms DE CRAIM (Chairperson, Belgium) referred to her participation in the annual exchange with the Council of Europe Secretary General and other heads of monitoring bodies (25 October 2021) during which she presented the work of the Lanzarote Committee around the following three axes: synergies and co-ordination with other bodies; stronger impact through increased visibility; increased efficiency through innovative working methods.

Exchange of views with Committee of Ministers' Deputies

- 40. Ms DE CRAIM also informed the Committee of her exchange of views with the Committee of Ministers' Deputies held on 10 November 2021 during which she presented the most recent activities of the Committee.
- 41. She specified that 24 delegations took the floor in a very fruitful exchange, in particular to give their support to the work carried out by the Committee, provide information on their activities at national level and ask a variety of questions, in particular on the Lanzarote Committee's reflection to strengthen its monitoring procedure and to address the potentially global outreach of the Convention. She added that several questions concerned possible support to build Parties' capacities to prevent and combat sexual exploitation and sexual abuse against children through cooperation activities.

4. Council of Europe cooperation projects on the protection of children against sexual exploitation and sexual abuse and other relevant projects

- 42. Ms GASPARYAN (Senior Project Officer at the Children's Rights Division) informed the Lanzarote Committee on the state of play of the various children's rights <u>cooperation</u> projects having a link with the protection of children against violence.
- 43. Ms SCAPPUCCI (Executive Secretary of the Lanzarote Committee) recalled that further Council of Europe cooperation projects on the protection of children against sexual exploitation and sexual abuse, as well as capacity building activities, could be carried out should the Council of Europe receive specific voluntary contributions to this effect.

5. Procedural matters

- 5.1. Presentation and consideration of suggested amendments to the Committee's Rules of Procedure (document T-ES(2021)35) based on ideas last discussed in June 2021 when examining the Reflection Paper containing suggestions to strengthen the effectiveness of the monitoring mechanism and procedure in the short or medium term (document T-ES(2021)15)
- 44. Ms SCAPPUCCI recalled that, at its 32nd meeting (28-30 June 2021), the Lanzarote Committee "welcomed the offer made by Ms CASTELLO-BRANCO (Portugal) and Ms DOURTHE (France) to prepare, with the support of the Secretariat, draft revised Rules of Procedure, reflecting more concretely the main suggestions contained in the Reflection Paper to be examined and decided upon at a forthcoming plenary meeting" (see para. 32 of the list of decisions).
- 45. The Committee started examining the draft revised Rules of Procedure prepared by Ms CASTELLO-BRANCO (Portugal) and Ms DOURTHE (France) and decided to pursue the examination during its 36th meeting (22-25 February 2022) bearing in mind that only the following points were already agreed upon during the current meeting:
 - When a Party nominates a representative pursuant to Rule 2.1§2, it shall strive, insofar as possible, and within the limit of what is compatible with the representative's national duties, to nominate that representative for a term of office of at least two years;
 - The terms of office of the Chairperson, Vice-chairperson (Rule 3§1) and that of the members of the Bureau (Rule 4§2) shall be of two years, renewable once (thus no longer of one year renewable once);
 - The members of the Bureau may be up to five in addition to the Chairperson and Vice-chairperson (Rule 4§1 no longer up to three).
- 5.2. Up-date on reflection on possible follow-up to the recommendations of the report "Respecting human rights and the rule of law when using automated technology to detect online child sexual exploitation and abuse" / Debriefing of the Octopus workshop
- 46. Ms SCAPPUCCI informed the Lanzarote Committee of the rich discussions in the Octopus workshop related to this report's recommendations and the Committee agreed to pursue its discussion on these recommendations in light of the Bureau's reflection on them as decided during its 34th meeting (4-7 October 2021, see <u>list of decisions paras 27-29</u>).
- 5.3. Appointment of a Lanzarote Committee representative or substitute representative to various bodies
- 47. Due to lack of time, the Lanzarote Committee postponed the appointment of substitute representatives for:
 - the Steering Committee for the Rights of the Child (CDENF);
 - the Working Group on responses to violence against children (CDENF-GT-VAE);

- the Committee of Experts on the rights and the best interests of the child in parental separation and in care proceedings (CJ/ENF-ISE);
- the Cybercrime Convention Committee (T-CY).

6. Any other business

- 48. Mr NIKOLAIDIS (Greece) Informed the Lanzarote Committee of the launching of a National Action Plan for combating child sexual abuse in Greece with Ms RAPTI, member of Parliament and responsible for the Council of Europe "ONE in FIVE" Campaign in Greece, in the role of national coordinator.
- 49. Mr KLANČNIK (EUROPOL) presented recent EUROPOL activities, and, in this context, the Committee took note that:
 - In the framework of the <u>Internet Organised Crime Threat Assessment (IOCTA)</u> 2021 of <u>EUROPOL</u>, non-consensual sharing of explicit child self-generated material is an increasing concern, including as a result of confinement measures due to the Covid-19 pandemic;
 - The 10th Victim Identification Task Force (VIDTF) at EUROPOL took place on 25 October and 5 November 2021. This resulted in a total of 18 children being tentatively identified and two offenders apprehended, while nine of these young victims have already been rescued by the competent authorities, with investigations ongoing to safeguard the others (information sent to concerned countries for further appropriate action). The VIDTF is a Europol initiative which gathered specialists from 26 countries and partner agencies to identify victims and offenders depicted in child sexual abuse material;
 - EUROPOL held an Annual Expert Meeting on 22-24 November 2021 both in person and with online participation. This meeting was organised on the occasion of the European Day for the protection of children against sexual exploitation and sexual abuse (18 November 2021). Law enforcement from Europe, US and Australia gathered and exchanged knowledge in the operations and strategic matters in the fight against sexual exploitation of children;
 - The <u>Europol Stop Child Abuse Trace an Object</u> initiative, active since 2017, resulted in over 26,800 tips sent by the general public, 12 children victim of child sexual abuse having been identified from so-called cold cases and removed from harm, and 4 offenders having been identified and prosecuted.
- 50. Mr KLANČNIK also recalled the existence of the <u>helplinks.eu</u> initiative (<u>Police2Peer</u>) and invited members of the Committee to contribute to it.
- 51. In addition, the Lanzarote Committee agreed that it would be interesting to be informed at a further meeting about the #ReDirection project of <u>Protect Children Finland</u>.
- 52. The Lanzarote Committee noted that its next meetings are scheduled as follows:
 - 36th meeting, 7-10 March 2022 (Strasbourg/hybrid)
 - 37th meeting, 29 June 1 July 2022 (Strasbourg/hybrid tbc)
 - 38th meeting, 29 November 2 December 2022 (Strasbourg/hybrid tbc)
