The Committee of the Parties (hereinafter referred to as "the Lanzarote Committee" or "the Committee") to the Council of Europe Convention on the Protection of Children against Sexual Exploitation and Sexual Abuse (hereinafter referred to as "the Lanzarote Convention" or "the Convention") held its 36th meeting remotely on the KUDO platform on 7-10 March 2022. The agenda and the list of participants are appended (Appendices I and IV).

1. Opening of the meeting

1. Ms CASTELLO-BRANCO, Vice-Chairperson of the Lanzarote Committee, opened the meeting in the absence for sick leave of Ms DE CRAIM, Chairperson, wishing her well on behalf of the Committee.

2. Before starting with the agenda, she gave the floor to Mr SCHOKKENBROEK, Director at the Council of Europe, who explained the consequences of the decision taken by the Committee of Ministers of the Council of Europe on 25 February 2022 to suspend the Russian Federation from its rights of representation in the Committee of Ministers and in the Parliamentary Assembly as a result of the Russian Federation's armed attack on Ukraine. He explained that this suspension did not affect the Russian Federation's position as a contracting party to those conventions – such as the Lanzarote Convention – that were concluded in the context of the Council of Europe without reservation in respect to ratification. He however also pointed out that questions concerning the modalities of the Russian Federation participation in the work of the bodies set up by such conventions had not been considered yet.

3. Ms ILCHUK (Ukraine) drew the Committee's attention to the situation in her country and, in particular, the increased risks resulting from the armed attacks on children's rights in general and to safety and protection against violence in particular, including against sexual exploitation and sexual abuse. She also referred to the very worrying situation of children having to flee the country.

4. In response to her intervention, during the course of the meeting, the Lanzarote Committee agreed to adopt a <u>statement on protecting children from sexual exploitation</u> and <u>sexual abuse resulting from the military aggression of the Russian Federation against</u> <u>Ukraine</u> (see Appendix II), whereby the relevance of its urgent monitoring round findings were reiterated in the current context. After the discussions and adoption of this statement, Ms ILCHUK asked to read a statement of her authorities and to have it appended to this meeting report, which was agreed by the Committee (see Appendix III).

1.1. Adoption of the list of decisions of the 35th meeting

5. The Vice-Chairperson recalled that, contrary to usual practice, it was not possible to adopt the list of decisions at the close of the 35th meeting and it had therefore been decided to do so by written procedure. The list of decisions would have been considered adopted if no substantial comment was received within a week, otherwise adoption would have to take place at the opening of the next meeting. As the Russian Federation

submitted a substantive comment, the list was not adopted by written procedure. The Bureau met on 13-14 December 2021 and decided that the Russian Federation's comment could be included in a meeting report. It thus asked the Secretariat to prepare a succinct list of decisions (just with actual decisions) and to include the rest of the elements appearing in the longer list of decisions which had circulated as well as the point raised by the Russian Federation in a meeting report. On 26 January 2022 the Secretariat submitted these two documents to the members of the Lanzarote Committee with the indication that the list of decisions would be adopted at the start of the 36th meeting and that the Bureau had considered that the draft meeting report reflected discussions and did not require further examination.

6. The Vice-Chairperson recalled the above process during the current meeting and the Secretariat read out the draft list of decisions, the Lanzarote Committee adopted the <u>list of decisions of its 35th meeting</u>. This list, as well as the 35th meeting report, are available on the <u>website of the Committee</u>.

1.3. Up-date on ratifications of/accessions to the Lanzarote Convention

7. Ms SCAPPUCCI, Executive Secretary to the Lanzarote Committee, informed the Committee that she met with the Director of the Treaty Office of the Israeli Ministry of Foreign Affairs on 14 December 2021, to reply to some questions on the Lanzarote Convention and Israel's desire to become a Party to it. Consideration of accession is thus underway.

2. Monitoring of the implementation of the Lanzarote Convention

Evaluation procedure

- 2.1. "The protection of children against sexual exploitation and sexual abuse facilitated by information and communication technologies (ICTs): addressing the challenges raised by child self-generated sexual images and/or videos"
- 2.1.1. Review of the last section of the legal frameworks chapter of the 2nd monitoring round draft implementation report (document T-ES(2022)02, see paras 86-109) on "Sexual extortion of children involving self-generated sexual images and/or videos"

8. The Lanzarote Committee held a last in-depth reading of the section of the legal frameworks chapter dedicated to "Sexual extortion of children involving self-generated sexual images and/or videos" (document T-ES(2022)02, see paras 86-109) and agreed on a few changes in this section.

2.1.2. Consideration of any last amendments to the draft implementation report submitted by 17 February 2022

9. The Committee then went through the remaining issues still open in the various

chapters of the draft implementation report and agreed on several changes to the text.

2.1.3. Adoption of the 2nd monitoring round implementation report

10. The Lanzarote Committee adopted its 2nd monitoring round implementation report on Thursday 10 March 2022 and took note that the report would be made available online in English and French after a final linguistic editing.

Compliance procedure

2.2. "Protecting children affected by the refugee crisis from sexual exploitation and sexual abuse": compliance procedure concerning the Lanzarote Committee's special report

2.2.1. Consideration of the following draft compliance reports in view of their adoption:

- R7 on mechanisms for data collection (document T-ES(2021)25)
- R11 on protection to child victims (document T-ES(2021)27)
- R13 on coordination and collaboration of different actors (document T-ES(2021)23)
- R31 on child-friendly proceedings (document T-ES(2021)28)
- R37 on a coordinated approach between responsible agencies (document T-ES(2021)24)

11. The Committee examined these five compliance reports thoroughly and adopted them, after having agreed on some modifications. The adoption of these remaining reports concluded the compliance procedure concerning its special report "Protecting children affected by the refugee crisis from sexual exploitation and sexual abuse". The 10 compliance reports evaluating the follow-up given by Parties to the recommendations considering that Parties should implement the Convention are available on the <u>Committee's website</u>, together with the report assessing the follow-up given by Parties to the five recommendations urging them to implement the Convention (which was adopted by the Committee on 6 June 2019).

3. Exchange of information, experiences and good practices

3.1. Up-date on the forthcoming High-level Launching Conference for the new Strategy for the Rights of the Child (2022-2027) "Beyond the horizon: a new era for the rights of the child" (Rome, 7-8 April 2022)

12. Ms JENSDÓTTIR, the Council of Europe's Children's Rights coordinator, informed the Committee that the new Council of Europe <u>Strategy for the Rights of the Child (2022-2027)</u> had been adopted by the Committee of Ministers on 23 February 2022. The new Strategy focuses on the following six priority areas to guarantee the rights and the best interests of the child:

- 1. Freedom from violence for all children
- 2. Equal opportunities and social inclusion for all children
- 3. Access to and safe use of technologies for all children
- 4. Child-friendly justice for all children
- 5. Giving a voice to every child
- 6. Children's rights in crisis and emergency situations

13. The Committee was informed that the Strategy would be launched during a Highlevel Conference "*Beyond the horizon: a new era for the rights of the child*", co-organised by the Council of Europe and the Italian Presidency of the Committee of Ministers, to be held in Rome on 7 and 8 April 2022. The Conference would provide an opportunity for high-level representatives of member States and other international organisations to express their commitment to the Strategy and present their visions for the implementation of the rights of the child over the next six years. Ombudspersons, civil society representatives and international children's rights experts, as well as a number of young delegates from different Council of Europe member States who had already contributed to the preparation of the Strategy would also contribute to the Conference.

14. It was highlighted that during the Conference there would be a thematic session dedicated to "*Protecting children from online sexual exploitation and sexual abuse*" during which Ms CASTELLO-BRANCO, Vice-Chairperson of the Lanzarote Committee, would present the main findings of the monitoring report adopted during the current meeting.

3.2. Debriefings by Lanzarote Committee members having participated in meetings of Council of Europe bodies on the Lanzarote Committee's behalf:

Steering Committee for the rights of the child (CDENF) and its subordinate bodies

15. Ms LAMBRECHT-FEIGL (Co-Secretary to the CDENF) informed the Lanzarote Committee that the Working Group on responses to violence against children (CDENF-GT-VAE) was working on a draft Recommendation on reporting mechanism on violence against children.

16. She also informed the Committee about the state of play of the activities of the Committee of Experts on the rights and the best interests of the child in parental separation and in care proceedings (CJ/ENF-ISE) and about the work underway regarding the rights of children and children's participation in the decision-making process in the biomedical field, jointly with the Steering Committee for Human Rights in the fields of Biomedicine and Health (CDBIO).

3.3. Participation of Lanzarote Committee representatives in outside events

17. Mr POUTIERS (Secretary to the Lanzarote Committee) informed the Committee that he had participated in the 12th edition of the European Forum on Bioethics (*Forum européen de bioéthique*), Strasbourg, France, and had made a presentation on 5 February 2022 during the workshop discussing taboos around incest (*« Le tabou de l'inceste est-il*)

tombé ? Parlons-en ! »). The video recordings of the workshop are available on the website of the Forum.

3.4. Presentation of the #ReDirection project of <u>Protect Children Finland</u>

18. Ms OVASKA (Protect Children Finland's Legal Specialist) presented the <u>#ReDirection project</u> carried out by her organisation from September 2020 to September 2021 on child sexual abuse material users on the dark web. The aim of the project was to have a better understanding of the thoughts of those who go to the darknet, with a view to better protect children. She indicated that more than 16.000 such users responded to a survey addressed to them (in 17 languages). The findings of the project have been published in a <u>report</u> and peer-reviewed <u>article</u>. One key finding is that 42% of the respondents reported that they had sought direct contact with children through online platforms after viewing child sexual abuse material on the internet. The Re-Direction Self-Help Programme was set up further to this research and is currently providing an anonymous training in English and Spanish to approximately 9,000 users. The training also provides information on face-to-face programmes available for offenders. The training programme is currently being translated into Norwegian, Finnish, and Russian.

19. The Vice-Chairperson complimented Ms OVASKA for the extremely interesting approach of this project which leaves an open door to hope.

3.5. Presentation of the ECPAT and WeProtect Global Alliance report <u>"Child sexual</u> <u>exploitation and abuse online: Survivors' Perspectives"</u>

20. Ms BUCHOWSKA (ECPAT International) presented the joint <u>project</u> "Voices of survivors of child sexual exploitation" carried out by ECPAT International and WeProtect Global Alliance. The project has been implemented in different countries in Eastern Europe (<u>Albania</u>, <u>Bosnia and Herzegovina</u>, and <u>the Republic of Moldova</u>) and Latin America (<u>Colombia</u>, <u>Mexico</u> and <u>Peru</u>) as a means to include the voices of survivors of sexual exploitation and sexual abuse online.

21. She explained that the project included both the opinions and experiences of survivors and professionals working directly with survivors. 42 survivors aged 18-23 and 413 frontline social workers providing direct support to survivors contributed to the project. The findings include information concerning gender of children, trends on support to children who have been victims of sexual abuse and sexual exploitation, reporting mechanisms, difficulties experienced by the survivors. A <u>video</u> was shown to complement the presentation. ECPAT International plans to extend the research to other European countries (see full report <u>"Child sexual exploitation and abuse online: Survivors' Perspectives"</u>).

3.6. Information about the <u>Survivors' call on German Chancellor Scholz & G7 Heads</u> of State and Government to lead action to end childhood sexual violence

22. Ms SCAPPUCCI provided information on a recently established global movement, the <u>Brave Movement</u>, which brings together survivors of child sexual exploitation and

abuse from all over the world, and is supported by allies. She also explained that the movement was preparing a <u>Global Survivors' Summit</u> on 27th April 2022 and was aiming to put forward a statement to end childhood sexual violence as a contribution to the G7 Summit in June. She recalled that, further to the <u>1st Global Survivors' Forum</u> organised by ECPAT and hosted by the Council of Europe on the occasion of the <u>second edition of the European Day (2016)</u>, the Lanzarote Committee had committed to find ways to include survivors' perspectives in its work and recalled the occasions when this was done in the past. She suggested the Committee might wish to consider asking a representative of the Brave Movement to participate in one of its forthcoming meetings.

23. The Lanzarote Committee welcomed this new initiative which brings survivors together. It agreed to invite the Brave Movement to present their work at a next meeting and to ask it to consider requesting observer status to the Lanzarote Committee.

4. Council of Europe cooperation projects on the protection of children against sexual exploitation and sexual abuse

4.1. Up-date concerning on-going projects' development

24. Ms GASPARYAN and Ms BUREL (Senior Project Officers at the Children's Rights Division) informed the Lanzarote Committee on the state of play of the various children's rights <u>cooperation projects</u> having a link with the protection of children against violence. They highlighted that the <u>Barnahus project in Slovenia</u> is coming to an end, with the premises being officially inaugurated in May. As for the <u>Barnahus project in Finland</u>, the Lanzarote Action Plan would be launched in April.

4.2. Information about up-coming projects

25. Ms GASPARYAN and Ms BUREL indicated that the projects in Ukraine and in Moldova had to be adapted following the Russian Federation's military aggression in Ukraine its consequences in its neighbouring countries. Finally, they informed the Lanzarote Committee that the Council of Europe was awarded two new projects on Barnahus, in Spain and Ireland.

26. Ms SCAPPUCCI recalled that further Council of Europe cooperation projects on the protection of children against sexual exploitation and sexual abuse, as well as capacity building activities, could be carried out should the Council of Europe receive specific voluntary contributions to this effect.

4.3. State of play concerning the Voluntary Contribution dedicated to the "Lanzarote Convention monitoring mechanism project"

27. Mr POUTIERS explained that the main source of funding for the activities of the Lanzarote Committee comes from the ordinary budget of the Council of Europe. However, there is also the possibility of financing the Committee's work through voluntary contributions, i.e. sums of money paid voluntarily by Council of Europe Member states to

support specific areas of work of the Council of Europe. With regard to work related to the Lanzarote Convention, a project was launched two years ago entitled "Lanzarote Convention monitoring mechanism project" to call on Member states to make voluntary contributions to enhance the Committee's monitoring work. Belgium and Ireland made contributions in this context. These have allowed the financing of temporary contracts to hire staff to assist the Secretariat of the Lanzarote Committee in carrying out increasing tasks identified by the Committee as relevant.

28. Mr POUTIERS highlighted that the funds available for the above project were coming to an end thus putting at risk the possibility of undertaking any new activities (i.e. the development of country profiles/overviews and awareness raising factsheets on monitoring findings). He therefore invited the Lanzarote Committee members to consider, together with their authorities, the possibility of making a voluntary contribution to continue to support its Secretariat.

5. Procedural matters

5.1. Continued consideration of suggested amendments to the Committee's Rules of Procedure (document T-ES(2021)35 rev.)

29. The Lanzarote Committee continued examining the amendments to the Rules of Procedure prepared by Ms CASTELLO-BRANCO (Portugal) and Ms DOURTHE (France). In addition to the points already agreed upon during its 35th meeting (30 November – 3 December 2021), the Lanzarote Committee agreed on the following:

- On Rule 7 (Venue of meetings):
 - in the first paragraph, "normally" was replaced with "as a general rule";
 - a new paragraph 3 was included: "If deemed appropriate, the meetings of the Lanzarote Committee may be held by videoconference or in a hybrid nature, in conditions permitting confidentiality of discussions and also interpretation in the Council of Europe's official languages."
- On Rule 10 (Documents, list of decisions and meeting reports): the following text was added to paragraph 7: "In this connection, videoconference tools may be used as indicated in rule 7§3."
- On Rule 18 (Voting): a new paragraph 6 was added to specify that: "Voting may take place online as long as it is in conditions permitting confidentiality."
- On Rule 20 (Hearings): various new paragraphs were agreed and the full text now reads:

1. The Chairperson, the Bureau or the Lanzarote Committee may decide to organise hearings with any qualified persons, including from civil society, who are in a position to contribute to the work of the Lanzarote Committee within the limits of resources available.

2. These hearings may also serve as a means of receiving contributions from children in the form of views expressed by them on the themes covered by the Committee's monitoring round.

- 3. The hearings of children carried out pursuant to paragraph 2 shall:
 - respect the geographical balance of the Parties to the Lanzarote Committee
 - be based on voluntary participation by children and conducted without discrimination on any grounds including race, ethnicity, colour, sex, language, religion, political or other opinion, national or social origin, property, disability, birth, sexual orientation or other status.

30. The Lanzarote Committee decided to examine any possible other amendment to its Rules of Procedure during its 37th meeting (29 June - 1 July 2022).

5.2. Exchange of views on the suggestions put forward by civil society organisations to strengthen cooperation with the Lanzarote Committee as put forward in their report on "A civil society perspective on the contribution to the implementation of the Lanzarote Convention and engagement with the Lanzarote Committee"

31. Ms CASTELLO-BRANCO (Vice-Chairperson of the Lanzarote Committee) recalled some of the main ideas put forward in the report "A civil society perspective on the contribution to the implementation of the Lanzarote Convention and engagement with the Lanzarote Committee", which had been presented at the 35th meeting of the Lanzarote Committee.

- 32. She indicated that the report:
 - Recalls that the Lanzarote Convention foresees engagement with civil society organisations (CSOs) through: cooperation, education for children, capacity building, engagement with the Lanzarote Committee including in the context of the compliance procedure, implementation of policies and victim assistance and support;
 - Highlights some of the fundamental ways in which CSOs are working to advance the implementation of the Lanzarote Convention, including trying to push national legal agendas; and other areas that can be further developed;
 - Identifies the need to clarify the roles and responsibilities of observer CSOs to the Lanzarote Committee; and
 - Identifies the need to agree on ways to strengthen the collaboration between the Lanzarote Committee and CSOs.

33. The Lanzarote Committee examined the final version of this report and entrusted its Bureau and the representative of ECPAT having coordinated the preparation of the report to agree on a set of initial concrete actions (possible workplan) to strengthen civil society's cooperation with the Lanzarote Committee, for consideration at a forthcoming meeting.

5.3. Information on the preparation of pilot Country profiles, presentation of a template and exchange of views on the way forward

34. Ms GUERREIRO (Lanzarote Committee Secretariat) presented an overview of progress with the preparation of pilot Country profiles, including the Template available, as a possible awareness raising tool to be considered by the Lanzarote Committee.

35. She explained that the aims of the Country profiles are to facilitate the awareness raising of readers through information on the national regulatory framework, information concerning the implementation of the Convention, as resulting in particular from the monitoring findings, and examples of measures, initiatives and other advancements related to the protection of children against sexual exploitation and sexual abuse and the prevention of related phenomena. She also presented the structure and drafting process, as well as, how the Lanzarote Committee may collaborate with its Secretariat to prepare Country profiles for each of its 48 Parties. The Italian and Portuguese members of the Lanzarote Committee then shared their experience of participating in the first two pilot Country profiles and said that they considered this a very useful tool for the Lanzarote Committee.

36. The Lanzarote Committee held an exchange of views on the possibility of preparing Country profiles for all Parties and discussed the following issues:

- The Lanzarote Committee welcomed this initiative and emphasised that it would be a very helpful and interesting tool;
- The Lanzarote Committee called for the need to raise funding for this exercise to guarantee a swifter preparation of Country profiles covering all the 48 Parties to the Lanzarote Convention. It was pointed out that a process to update the Country profiles, would also have to be contemplated and agreed upon;
- The need to bear in mind the <u>WeProtect Model of National Response</u> when drafting the Country profiles was pointed out.

37. The Lanzarote Committee agreed to continue testing the preparation of the Country profiles and asked the Secretariat to prepare two or three more pilot Country profiles in order to refine the pilot process carried out so far, which would then be presented at the 37th meeting of the Lanzarote Committee (29 June – 1 July 2022), together with a work schedule and information on required resources to prepare all 48 Country Profiles. It also invited Parties interested in being pilot countries to inform the Secretariat as soon as possible (lanzarote.committee@coe.int).

5.4. Adoption of the list of decisions of this meeting

38. At the end of the meeting, the Lanzarote Committee adopted <u>the list of decisions</u>.

6. Any other business

Draft European Union legislation on child sexual abuse

39. While it was foreseen in the initial draft agenda of the meeting that the European Commission would present the proposal for a new European Union Regulation on child sexual abuse, in particular on the detection of online sexual exploitation and abuse of children, this had to be postponed since the proposal was not yet adopted.

40. The Secretariat will organise such a presentation in due time when the proposed Regulation will be made available.

Appendix II

Lanzarote Committee Statement on protecting children from sexual exploitation and sexual abuse resulting from the military aggression of the Russian Federation against Ukraine (adopted on 10 March 2022)

Recalling that the unjustifiable and unprovoked military aggression of the Russian Federation against Ukraine, in violation of international law and human rights, including the rights of the child, has been strongly condemned by the Council of Europe,

Affirming that the safety and protection of all children should be a priority and that children in vulnerable situations such as unaccompanied and missing children are at a higher risk of sexual exploitation and sexual abuse,

Noting the increasing number of refugee, migrant and internally displaced children and recognising the urgent need for safe passages,

The Lanzarote Committee solemnly reaffirms, in the current context, its <u>Declaration on</u> <u>protecting refugee and migrant children against sexual exploitation and sexual abuse</u> adopted on 28 June 2018, which calls upon the States Parties to the Convention to:

- 1. uphold the rights and best interests of the child at all times, regardless of their migration status;
- ensure that follow-up is given to the recommendations contained in its urgent monitoring round report on "Protecting children affected by the refugee crisis from sexual exploitation and sexual abuse";
- 3. take measures to address the specific risk of exposure to sexual exploitation and sexual abuse of migrant and refugee children, taking into account the increased vulnerability caused by factors such as deprivation of liberty, family separation, inadequacy of reception and care and lack of effective guardianship systems;
- 4. cooperate with relevant stakeholders in Europe and beyond to:
 - prevent the exposure of migrant and refugee children to the risks of sexual exploitation and sexual abuse;
 - provide appropriate support and assistance to child victims of sexual exploitation and sexual abuse in their physical and psychosocial recovery;
 - fight against the impunity of sexual offenders.

Appendix III

Statement by the Ukrainian member of the Lanzarote Committee

Dear members of the Committee!

Now it is really not the time for long speeches.

But my country is on fire, my country is in blood and death. Yesterday, the Russian Federation bombed a clinic and a maternity hospital in Mariupol.

They are brutally killing Ukrainian women, children and the elderly.

They continue to ruin our towns and villages by rocket and bomb attacks.

I hope you know about these facts.

Ukrainians appreciate very much for all support which the world is giving to us these days.

However right now, I want to remind you that Ukraine has been a part of the Lanzarote family since 2012.

Normally of course, if something is happening to someone in the family, others help or try to help as much as they can.

So, if you accept us as equals in this family, now is exact moment to help us. We need it.

Yes, the Committee has a mandate which regulates our activities and responsibilities. Ukraine accepts it absolutely without any counterarguments.

That is the reason why I am not addressing the Committee as it is, but to each of you.

I invite you to say your own word, express your personal position, in supporting of my country today.

I invite you in any way to join those whose demands are to close the Ukrainian sky and save Ukrainians.

I absolutely understand that you may have some instructions and recommendations as official representatives of your countries.

But at the same time, I urge you not to be afraid of demonstrating your human allegiance to the ideals of freedom and democracy.

I invite you in any way to make a personal contribution to the rescue of Ukrainian children.

I ask you to fix my statement in the Protocol of the meeting.

And finally I stress it will be everyone's choice how to act, but I invite.
