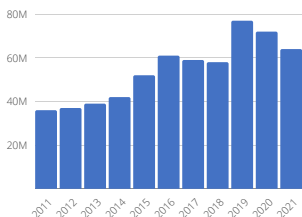


# RESOURCE MOBILISATION AT A GLANCE

From 2011 to 2021, voluntary contributions increased by 76%.



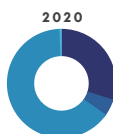
## FUNDING SOURCES

The **European Union** remained our **largest donor** in 2021 while **Norway** remained our largest bilateral donor. **37** of the 47 member states contributed in 2021.

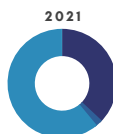

## SPOTLIGHT 2021

**Finland joined the group of donors contributing more than €1 million in the year**

Since 2015, Finland has supported the **Council of Europe Action Plans for Ukraine** with non-earmarked contributions. Finland has seconded **gender mainstreaming advisors** making an important contribution to the gender mainstreaming dimension of the Ukraine Action Plan, and the Council of Europe's work as a whole. Finland is also a member of the **Human Rights Trust Fund (HRTF)**.

## STRATEGIC PARTNERSHIPS

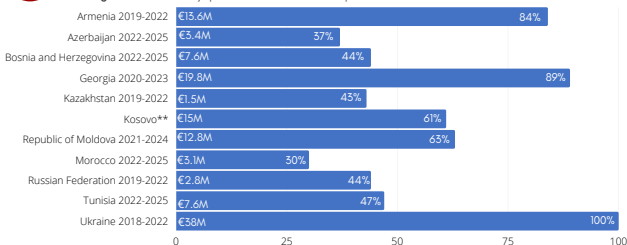
