This risk assessment is prepared by Child Rights Connect to evaluate the risks that children might be exposed to by taking part in the Mid-Term Review Conference of the Strategy for the Rights of the Child of the Council of Europe, held in-person between 2-4 of April 2025 in Strasbourg, France. Prevention and mitigations measures are recommended below in relation to each risk identified.

In the framework of the Council of Europe Programme "Building a Europe for and with Children", operating since 2006, the fourth Strategy for the rights of the Child (2022-2027), hereafter the Strategy, was designed to enhance the protection and promotion of the rights of the child across Europe. Before the event				
The child may have questions and concerns about the event since this will be their first time in a conference where most of the participants are adults. They may not know how to prepare for their role and their interventions.	The children will be proposed several preparatory online meetings online to ensure that they understand the full scope of their participation and the context of the event in question. One of these preparatory meetings will focus on safeguarding. Child-friendly information will be shared with the			
	children to explain the event and topics discussed. Close communication with the supporting organizations and parents will be maintained throughout the weeks leading up and after the event to ensure that they can best assist the children with their participation.			
Online preparatory meetings via zoom: not authorized persons are participating at the meeting.	Ensure access to zoom is password protected and only invited and authorized persons are participating (by using the waiting room feature).			
The children need to travel internationally to a potentially unknown country and navigate the city to attend the different activities. Delays or cancellation of flights or train might happen, luggage might get lost.	The children will be accompanied by their chaperones and a staff member of Child Rights Connect with whom close communication will be maintained. The children will also receive a child-friendly welcome pack with essential information for their trip which will be discussed in one of the online preparatory meetings. Throughout their trip, the children will be accompanied by their chaperones.

The children could feel uncomfortable, stressed or overwhelmed during the event depending on the kinds of issues, examples and challenges	We make sure that the child participants feel empowered and confident going into the conference. This involves various preparatory calls,

	We will discuss the kinds of issues and themes that might be raised during the interventions from the participants of the conference and how they might feel about these, whether there would be any triggers. We will discuss how we might deal with these kinds of situations and how the children can be best supported.
	The adult participants of the conference will have to accept the Safeguarding Policy and Procedure at the time of their registration and the Code of Conduct will be shared among the documents of the conference. The moderator will share an announcement at the beginning of each session where children are present about child safeguarding and how to ensure a safe and meaningful dialogue space for everyone.
	Safeguarding Focal Point will be appointed and introduced to the children at the beginning of the conference and available throughout the event.
Unknown venue for the children which is not child-friendly. Children might not find a space to relax whenever they feel like.	We will support the children to familiarize themselves with the venue at the day before the conference. During the conference, separate child-friendly space will be available for them.
Language used by the adult participants is not accessible and children might feel lost.	The children will be empowered to intervene if they don't understand something during the sessions and the adults will be reminded by the moderator's announcement to use accessible language.
The Permanent Mission (PM) and other officials of the country of origin of the children may attend the conference, take note or object certain statements or criticism made by the children in relation to their government or	The children will be informed about this possibility and provided with guidance on how to present their statements in a respectful and objective manner.
