The Ministry of Public Works, Development and Administration has the mandate to set out the principles, objectives and activities that pertain to the spatial planning system in Romania. The cornerstone of spatial planning activities is Law no.350/2001 which has been continuously updated by the Ministry in order to reflect European practices and policies. Thus, through this specific legislation, the Ministry lays out how landscape management can play a strategic role for sustainable development.

In addition, the Ministry of Public Works, Development and Administration designed and promotes the National Strategy for Territorial Development (at present in Parliament for approval procedure) which upholds measures that preserve and improve landscape components, considering that landscapes provide amenities for sustainable local development of both rural and urban areas, increasing their attractiveness when properly managed and promoted, they support recreational, residential and productive activities. The Strategy moves forward the role of spatial and urban planning as a tool for improving attractiveness of places, based on tailored interventions. In this view, territorial attractiveness is an issue of growing importance for national, regional and local governments during last years, requiring the integration of landscape matters into overall spatial planning.

The Ministry of Culture and National Identity is the central authority that designs policies and strategies for the cultural heritage. The Institute for National Heritage and the National Institute for Cultural Research and Training assist the Ministry in activities aiming to protect, research and restore the cultural heritage in Romania.

The Ministry of Public Works, Development and Administration is currently working on setting up the national Urban Planning Code. During this process, the urban planning regulatory framework is being aligned with the legal provisions on cultural heritage protection that are updated and consolidated by the Ministry of Culture and Identity through the Cultural Heritage Code.

Protected natural areas - terrestrial and / or aquatic zones that contain species of wild plants and animals, biogeography, landscape, geological, paleontological, speleological elements and formations with an ecological, scientifically or cultural special value, and enjoy a special legal protection and conservation status

Natural parks correspond to IUCN Category V of Protected Landscape/Seascape, representing a protected area where the interaction of people and nature over time has produced an area of distinct character with significant ecological, biological, cultural and scenic value: and where safeguarding the integrity of this interaction is vital to protecting and sustaining the area and its associated nature conservation and other values.
