OPINION OF THE EXTERNAL AUDITOR

We have examined the budgetary management accounts of the Council of Europe for the year ended 31 December 2023 which include the statement of expenditure and revenue of each budget and subsidiary budget of the Council of Europe, including the Fund Support for European Cinema (Eurimage) and the European Centre for Global Interdependence and Solidarity ("North-South Centre"), as well as partial agreements and special accounts, and their explanatory notes.

The Secretary General of the Council of Europe is responsible for the preparation and correct presentation of the budgetary management accounts in accordance with the provisions of Articles 61 and 63 of the Financial Regulations of the Council of Europe and for the establishment of a control adequate internal procedure for the preparation of budgetary management accounts free from material inaccuracies, whether of fraudulent origin or due to an error.

It is our responsibility to express, on the basis of our audits, an opinion on these budgetary management accounts in accordance with Article 72 of the Financial Regulations of the Council of Europe. We conducted our work in accordance with applicable international auditing standards and the provisions of Article 71 of the Financial Regulations of the Council of Europe. Our work was organized and carried out in such a way as to obtain reasonable assurance that the budget management accounts do not contain any material inaccuracies. We proceeded to the examination, on the basis of surveys, of the amounts and other data appearing in the budgetary accounts. We examined the accounting principles followed, as well as the presentation of the budget management accounts. We consider that the checks carried out constitute a reasonable basis on which to base our opinion.

Our opinion is that the budgetary management accounts correctly reflect the financial records and transactions of the Council of Europe for the year ended 31 December 2023 and that they have been prepared in accordance with the Financial Regulations.

In accordance with Articles 71 and 72 of the Financial Regulations, we have also drawn up a report for the Committee of Ministers recording our observations on the budgetary management accounts of the Council of Europe.

Resolution EPAS/Res(2024)01 concerning the budgetary management accounts of the Enlarged Partial Agreement on Sport (EPAS) for the year ended 31 December 2023

(Adopted by the Statutory Committee on 14 August 2024)

The Statutory Committee, under the terms of Article 5.4 of the Statute of the Enlarged Partial Agreement on Sport (EPAS), and in its composition restricted to the representatives of the States members in 2023 of the Enlarged Partial Agreement on Sport,¹

Having regard to Resolution $\underline{\text{CM/Res}(2010)11}$ establishing the Enlarged Partial Agreement on Sport as amended by $\underline{\text{CM}(2015)4}$;

Having regard to Article 68 of the Financial Regulations;

Having regard to the budgetary management accounts of the Enlarged Partial Agreement on Sport for the year ended 31 December 2023, as presented by the Secretary General;

Having regard to the opinion of the External Auditor;

Having regard to the report of the External Auditor;

Having regard to the report of the Budget Committee,

Decides:

1. The budgetary management accounts of the Enlarged Partial Agreement on Sport for the year ended 31 December 2023 are approved (<u>CM(2024)100-add</u>, page 50).

- 2. The unexpended appropriations for the financial year 2023 before provisions amounting to €1 858.53 as shown in the budgetary management accounts presented by the Secretary General, are cancelled.
- 3. Agreed that the 2023 financial year net surplus of €1 965.49 will be credited among the members of the Enlarged Agreement as indicated in the appendix to this Resolution.
- 4. The share of the surplus of the Enlarged Partial Agreement budget due to each member will be applied to meet any additional contributions for which members may become liable, should supplementary appropriations be granted in the 2024 budget, any part of the share that remains being considered as an advance on its contributions for 2024 or subsequent years.
