Decisions

The representatives of the member states of the Enlarged Partial Agreement on Sport - EPAS (Albania, Andorra, Armenia, Austria, Azerbaijan, Belgium, Bosnia and Herzegovina, Bulgaria, Croatia, Cyprus, Estonia, Finland, France, Georgia, Greece, Hungary, Iceland, Italy, Latvia, Liechtenstein, Lithuania, Luxembourg, Malta, Monaco, Montenegro, Netherlands, North Macedonia, Norway, Poland, Portugal, San Marino, Serbia, Slovak Republic, Slovenia, Switzerland, Türkiye, Ukraine and Belarus, Canada, Israel and Morocco as non-member States of the Council of Europe).

- 1. approved the Scale of Contributions for 2023 and, consequently adopted Resolution EPAS/Res(2022)3 as it appears in Appendix I to this document;
- 2. having regard to Resolution EPAS/Res(2021)2 which provisionally approved this budget for 2023, approved the adjusted Budget of the Enlarged Partial Agreement for 2023, and consequently adopted Resolution EPAS/Res(2022)4 as it appears in Appendix II to this document;
- took note that decisions related to salary adjustment will be approved on the basis of a general decision taken by the Committee of Ministers in the framework of the Ordinary budget.

Resolution EPAS/Res(2022)3 of the Enlarged Partial Agreement on Sport Scale of contributions 2023

Resolution EPAS/Res(2022)4 of the Enlarged Partial Agreement on Sport Adjusted Budget for 2023

(Adopted by the Statutory Committee by written procedure on 10 October 2022)

The Statutory Committee, under the terms of Article 5 of the Statute of the Enlarged Partial Agreement on Sport (EPAS),

Having regard to Resolution CM/Res(2007)8 of 11 May 2007 authorising the establishment of the Enlarged Partial Agreement on Sport;

Having regard to Articles 19, 21 et 23 of the Financial Regulations;

Having regard to Resolution EPAS/Res(2021)2 approving the Programme for 2022-2025 and the Budget for 2022, as well as the Budget for 2023 on a provisional basis;

Having regard to the Programme and Budget 2022-2025 – adjustments for 2023, as submitted by the Secretary General (document CM(2021)130);

Decides as follows:

- 1. The Budget of the Enlarged Partial Agreement for 2023 with expenditure and receipts totalling €1 192 600 according to Table A appended to the present Resolution, is hereby approved;
- 2. Approval is hereby given to the apportionment, among the States members of the Enlarged Partial Agreement on Sport, of the contributions for 2023, totalling €1 192 600 according to Table B appended hereto;
- The total of the budget of receipts shall be a function of the total of collected receipts. The budget of expenditure and receipts shall be adjusted accordingly in the course of the financial year;
- 4. Took note that decisions related to salary adjustment will be approved on the basis of a general decision taken by the Committee of Ministers in the framework of the Ordinary budget.
