Discours de Mr Andrea Carletti, Vice-Président du Comité de direction de l'APES

The Enlarged Partial Agreement on Sport (EPAS), which now counts 40 member states in its Governing Board and 29 Consultative Committee organisations as well as the 40 delegations representing the Statutory Committee gathered here this morning, is proud to continue to uphold the values of the Council of Europe: the rule of law, democracy and human rights.

Despite the pandemic and ensuing restrictions in place throughout 2021, EPAS continued to stride ahead in its key priority working areas promoting safe sport, ethical sport and more inclusive sport. One of the key drivers of 2021 was the final conference meetings to close the 16th Ministerial Conference; these took place online on Friday 15 January and on Thursday 11 February. Owing to the pandemic the physical meetings programmed to take place in Athens in 2020, ended up being replaced by a series of 5 shorter online events, spread over a longer period of time from 5 November 2020 until 11 February 2021. This ability to change tack and format is a reflection of how EPAS has been able to adapt its working methods quickly to ensure that there was no hold up in the carrying out either of the work programme or the EPAS Priority Areas of Activity.

Two key Resolutions were adopted at the 16th Ministerial Conference and these have impacted on EPAS' work going forwards throughout 2021. These are:

1. Resolution No. 1 - A European approach to Sport policies: the revision of the European Sports Charter
2. Resolution No. 2 – Human Rights in Sport

The first Resolution confirmed that EPAS should progress with the revision of the European Sports Charter. I am delighted to announce that one of the EPAS highlights of 2021 was that under the careful steering of the EPAS Secretariat, in particular the Executive Secretary, Mr Stanislas Frossard, and with wise and active input from the Governing Board and in consultation with the Consultative Committee, the revised European Sports Charter was adopted on 13 October 2021.

This revised 2021 Charter promotes values-based sport, most particularly in the areas of: integrity; ethics; human rights and sustainability. It also promotes: the protection of human rights; good governance; the right to sport for all individuals; social and economic benefits of doing sport; and dual careers. Furthermore, it encourages the involvement of a wide range of stakeholders; including public authorities (local and regional) and transversal co-operation.

As with previous incarnations of the Charter, at its heart, it promotes “sport for all”. The Charter also maintains a broad definition of sport, namely: “all forms of physical activity, which help to maintain or improve physical fitness or mental well-being which help to form social relationships or to obtain results in competitions at all different levels.”

So not just elite sport competitions.

From 2022 onwards this revised European Sports Charter will be implemented and it is designed to be an active tool to guide European sports policy. In early 2022, an informal Session of the Committee of Ministers will be held to launch this revised Charter alongside the presentation of the Council of Europe's Strategic Priorities for the next four years in sport (2022-2025).

In light of the Second Resolution on Human Rights and Sport, which encouraged EPAS to promote human rights in sport in its ongoing work, EPAS organised a human rights forum on 1 June 2021. This forum focused on the following discussion areas:

- Right to a fair trial;
- Data protection;
- Media Freedom in Sport;
- Young migrant athletes and human trafficking;
- Economic and social rights of athletes;
- Combating racism and hate speech in sport; and
- Gender equality in sport;

In each of the areas EPAS invited Council of Europe colleagues with expertise in the particular area to present their work and to share ideas about how to move the debate forwards. Two areas: Combating hate speech in sport and Gender equality in sport, will now become the focus of joint

Council of Europe-European Union projects, both of which will start in 2022. The 2022 Gender Equality initiative will draw on EPAS work in the earlier All IN joint Council of Europe/European Union project and further develop the indicators established and extend their implementation. It will also take into consideration other ways in which that initiative can be expanded.

In the context of the aforementioned standards EPAS defines its work around 3 pillars: ethical sport, inclusive sport and safe sport.

Ethical sport

EPAS continues to be involved with the International Partnership against Corruption in Sport (IPACS) consisting of amongst other stakeholders – OECD, UNODC and the IOC. EPAS coordinates Task Force 3, and has developed common benchmarks with good governance indicators to support sport organisations and public authorities to address risks of corruption. EPAS continues to maintain a database of alleged corruption cases (DACCS).

As part of Action 3 of the Kazan Action Plan, which was adopted on 15 July 2017 at Unesco’s 6th International Conference of Ministers and Senior Officials Responsible for Physical Education and Sport (MINEPS VI), EPAS has prepared detailed integrity guidelines to improve sport integrity and has identified 5 policy areas in this respect:

1. Preserving the rights, safety and security of athletes, spectators, workers and other groups involved;
2. Preventing and addressing harassment and abuse in sport;
3. Fostering good governance of sport organisations;
4. Strengthening measures against the manipulation of sports competitions; and
5. Ensuring an adequate anti-doping policy framework, its implementation and effective compliance measures.

Now that the guidelines have been drafted their implementation is their next step and to kick this off an Integrity Conference jointly organised with the Italian Department for Sports, in the framework of the Italian Presidency of the Committee of Ministers will take place on 6-7 December in Rome and in hybrid version. I look forward to warmly welcoming speakers in Rome, but also invite all of you to join the conference remotely. It will provide the opportunity for experts to consolidate EPAS’ work in this area and plan the next steps.

Inclusive sport

On 20 September EPAS hosted its biennial Diversity Conference. This year the topic was on the promotion of the human rights of intersex and transgender athletes in sports competitions. Proceedings were opened by Ms Roxana Măracineanu, the French Minister responsible for Sport, and speakers were wide-ranging including representatives from the IOC, from Human Rights Watch, athletes, and other experts in this area. A study in this area is being prepared by EPAS to be published next year.

EPAS is also preparing its 2022-2024 All In joint project with the European Union as well as its participation at the 2022 IWG meeting, and is looking forward to continuing to protect the rights of women in sport on an ongoing basis.

Safe sport

In March 2021, the Council of Europe Recommendation on Extreme Martial Arts and Combat Activities was adopted. A number of EPAS member states are Consultative Committee bodies are studying the issue of concussion in sporting activities in this area.

Throughout 2021, EPAS continued its work in the area of child safeguarding in sport. EPAS has two concurrent running initiatives: the ongoing “Start to Talk” project and Child Safeguarding in Sport (CSiS).

1. Start to Talk was launched in April 2018 and is designed by the Council of Europe as a call for action to public authorities and the sport movement to stop child sexual abuse. By joining this call, governments, sports clubs, associations and federations, as well as athletes and coaches, pledge to take concrete measures to prevent and respond to abuse. It is about adults breaking the silence and lending children a voice.

2. The Child Safeguarding in Sport project is a joint initiative with the European Union which will run until early 2022. It has focused on 6 member states (Austria, Belgium, Croatia, Israel, Norway and Portugal) and its main aims are to guide and accompany countries in the development of more effective child safeguarding in sport policies, to ensure safe, positive and empowering sport environments for children. Each of the countries have prepared or are finalising their tailor-made roadmaps.

At the end of this Statutory Meeting we will hear more about Child Safeguarding in Sport from the Portuguese national co-ordinator Ms Cristina Matos Almeida.

Communication

In 2021 EPAS reinforced its communication work and from June brought in two consecutive communication colleagues: Ms Hawa Diallo and Ms Emma Zanichelli to assist our new colleague Ms Françoise Rui, who replaced Ms Heather Stewart in the summer. This reinforcement has meant that EPAS was able to continue to develop its dedicated webpages, and ensure that strong resource material in the different areas of activity of our work was uploaded.

Ms Francine Hetherington Raveney was also recruited as the Deputy Executive Secretary in May this year and has focused on working with the Consultative Committee, overseeing Communication and helping to organise the Diversity and Integrity conferences amongst other areas.

Co-operation with the sports movement

EPAS continues to co-operate with the sports movement, most particularly through its Consultative Committee, which gathers a diverse group of sports organisations from across Europe and beyond and which now numbers 29 bodies. The Consultative Committee has held two webinars in 2021 and this will continue into 2022.

The Memoranda of Understanding between the Council of Europe and FIFA and UEFA continue to ensure collaboration between our organisations. We will have the pleasure to hear from two FIFA colleagues at the end of this meeting in the area of safeguarding in sport, namely, Ms Gloria Viseras, who some of you will have heard speaking here 3 years ago, and her colleague Ms Marie-Laure Lemineur.

Other events

To conclude I would like to refer to the successful online plenary meeting of EPAS which, as usual, brought together the EPAS Governing Board and the Consultative Committee in June this year. EPAS also hosted a first round table on the complex issue of e-sports earlier this week, which was attended by a number of our Governing Board representatives. Work will continue in this area. Furthermore, an online meeting on the mapping of sports facilities will take place before the end of the year in collaboration with the Mulier Instituut.

So as you have heard in 2021 the work of EPAS was certainly not slowed down because of the pandemic even if we look forward to more in-person meetings and conferences from 2022 onwards. EPAS has continued to build a bridge between grassroots sports and national policy makers.

I would also like to close by paying tribute to the hard work carried out by Mr Stanislas Frossard, who has been the Executive Secretary of EPAS since 2007. He is leaving us to serve a two-year term as Chair of the Staff Committee and I would like to thank him for his contribution to EPAS over the years.
