#### National policies and international co-operation for the implementation of the European Landscape Convention

#### Introduction

Adopted in Strasbourg by the Committee of Ministers of the Council of Europe on 19 July 2000, the European Landscape Convention (ETS 176) was opened for signature by the Organisation's Member States in Florence on 20 October of that year. As the first international treaty devoted exclusively to all aspects of landscape, it addresses the Council of Europe's key challenges in the areas of human rights, democracy and the rule of law.

The Council of Europe Member States signatories to the Convention have declared themselves "concerned to achieve sustainable development based on a balanced and harmonious relationship between social needs, economic activity and the environment". The Convention is therefore the first international treaty devoted to sustainable development, with the cultural dimension a particularly relevant factor. Although each citizen must, of course, contribute to preserving the guality of the landscape, it is the authorities that are responsible for establishing the general framework that enables that quality to be assured. The Convention accordingly lays down the general legal principles that must guide the adoption of national landscape policies and the establishment of international co-operation in this area.

The Convention provides that existing competent Committees of Experts of the Council of Europe, set up under its Statute, are designated by the Committee of Ministers of the Council of Europe, to monitor its implementation. The Work Programme of the Convention adopted by the Council of Europe conferences on the European Landscape Convention and the Steering Committee for Culture, Heritage and Landscape (CDCPP) is implemented by the Secretariat General of the Council of Europe which transmits a report on the work carried out, and on the operation of the Convention, to the Committee of Ministers.

The Convention and the basic texts concerning its implementation contribute to promoting definition and legal recognition of the landscape, ensuring that the landscape dimension is taken into account in national and international policies, and developing international co-operation.

#### I. STATE OF SIGNATURES AND RATIFICATIONS

#### Summary

To date, 40 States have ratified the European Landscape Convention: Andorra, Armenia, Azerbaijan, Belgium, Bosnia and Herzegovina, Bulgaria, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Georgia, Greece, Hungary, Iceland, Ireland, Italy, Latvia, Lithuania, Luxembourg, Republic of Moldova, Montenegro, Netherlands, North Macedonia, Norway, Poland, Portugal, Romania, San Marino, Serbia, Slovak Republic, Slovenia, Spain, Sweden, Switzerland, Turkey, Ukraine and the United Kingdom. One State have signed the Convention: Malta.

In 2019, Iceland became the 40th State Party to the European Landscape Convention. #### II. IMPLEMENTATION OF THE WORK PROGRAMME

The main objectives of the Work Programme of the Convention (Part 2 of this document) are to promote participatory democracy, maintaining and deepening dialogue and co-operation between public authorities and civil society for the implementation of the European Landscape Convention by:

- 1. Organising biennial Council of Europe Conferences on the European Landscape Convention, according to the terms of reference of Committees of Experts set up under Article 17 of the Statute of the Council of Europe designated by the Committee of Ministers of the Council of Europe to be responsible for monitoring the implementation of the Convention (Article 10 of the Convention – Monitoring of the implementation of the Convention);
- 2. Organising annually one or several Council of Europe Meetings of the Workshops for the implementation of the European Landscape Convention;
- 3. Maintaining the Information System of the Council of Europe European Landscape Convention, and launching its Third Phase of activity, with the preparation of national and regional reports and thematic reports on public policies of Parties to the Convention (according to Recommendation CM/Rec(2013)4 on the European Landscape Convention Information System of the Council of Europe and its glossary, adopted by the Committee of Ministers on 11 December 2013);
- 4. Continuing the organisation of the Sessions of the Landscape Award of the Council of Europe in the framework of the Council of Europe Landscape Alliance Award and of the Forums on the national selections of the Landscape Award (according to the Resolution CM/Res(2008)3 on the rules governing the Landscape Award of the Council of Europe and to the Resolution CM/Res(2017)18 on the Landscape Award Alliance of the Council of Europe, adopted by the Committee of Ministers on 27 September 2017);
- 5. Continuing the preparation of thematic reports and draft recommendations of the Committee of Ministers on natural, rural, urban and peri-urban areas, considered as outstanding, of everyday life and degraded, inland and maritime waters being taken into consideration;
- 6. Establishing Working Groups supported by expertise, in order to prepare draft recommendations for the attention of the CDCPP and Committee of Ministers;
- 7. Promoting synergies on the themes of sustainable development (environment, society, economy and culture), democracy, human rights and rule of law;
- 8. Contributing to the global debates on sustainable development (United Nations 2030 Agenda for Sustainable Development) and habitat.

#### Summary

Regularly organised by the Council of Europe in the framework of the Work Programme of the European Landscape Convention, the Meetings of the Workshops for the implementation of the Convention aim to present new concepts and achievements in support of the implementation of the Convention. They represent a real forum for exchanging practices and ideas. Special emphasis is given to the experiences of the State hosting the meeting.

The Meeting was organised by the Council of Europe, in co-operation with the Ministry of Education, Culture and Sport of Spain, in partnership with the Council of Andalusia and the Municipality of Seville. The Meeting aimed to present experiences of public policies adopted, or being developed, concerning *water and marine areas*, considering Article 2 of the Convention (Scope). This states that the Convention "applies to the entire territory of the Parties and covers natural, rural, urban and peri-urban areas. *It includes* land, *inland water and marine areas*. It concerns landscapes that might be considered outstanding as well as everyday or degraded landscapes".

## 23rd Council of Europe Meeting of the Workshops for the implementation of the European Landscape Convention and Celebration at High Level of the Twentieth Anniversary of the European Landscape Convention on: "Landscape integration in sectoral policies", Lausanne, Switzerland, 19-20 October 2020

The events are being organised by the Council of Europe, in co-operation with the Swiss Federal Office for the Environment (FOEN) and the collaboration of the Canton of Vaud and the City of Lausanne.

The Meeting aims to present experiences of public policies adopted, or being developed, concerning the implementation of Article 5 d. of the European Landscape Convention on "General measures", according to which each Party undertakes "to integrate landscape into its regional and town planning policies and in its cultural, environmental, agricultural, social and economic policies, as well as in any other policies with possible direct or indirect impact on landscape".

The Celebration of the Twentieth Anniversary of the European Landscape Convention, organised at high level, will focus on the importance of integrating landscape in sectoral policies. A draft political Declaration on this subject will be prepared for adoption.

The results of these events will be presented at the 11th Official Council of Europe Conference on the European Landscape Convention (26-27 May 2021, Palais de l'Europe, Strasbourg), as well as at the 10th Meeting of the Steering Committee for Culture, Heritage and Landscape (CDCPP).

- the encouragement of transfrontier co-operation on local and regional level and, wherever necessary, the preparation and implementation of joint landscape programmes.

The Third International Landscape Day of the Council of Europe addressed "Landscape and Water", promoted the value of water in the landscape.

The European Landscape Convention applies to the entire territory of the States Parties to the Convention and covers natural, rural, urban and peri-urban areas. It includes "inland water and marine areas". It concerns landscapes that might be considered outstanding as well as everyday or degraded landscapes. The Convention states in its preamble that "the landscape is a key element of individual and social well-being and that its protection, management and planning entail rights and responsibilities for everyone". "Everyone" was thus invited to celebrate this International Landscape Day, dedicated to water in the landscape, in any country.

The European Landscape Convention was also taken into consideration in the framework of numerous other reports or events, national or international.

To ensure exchanges of information between the States Parties to the European Landscape Convention and its follow-up, a document setting out the landscape policies pursued in the Member States was produced on a regular basis by the Secretariat and presented on the occasion of the Council of Europe Conferences on the Convention.<sup>1</sup> The use of the European Landscape Convention Information System and its glossary, set up pursuant to Recommendation CM/Rec(2013)4 of the Committee of Ministers to Member States, permit online access to information concerning national and regional policies that have been developed.<sup>2</sup> Addressed to authorities, organisations or citizens seeking useful information on landscape policies, a glossary has been produced in order to explain certain terms employed. The <u>Glossary of the Information System of the Council of Europe Landscape</u> <u>Convention</u>, has been published by the Council of Europe publishing (Spatial planning and landscape Series, 2018, No. 106).<sup>3</sup>

The States Parties to the Convention are invited to make use of this Information System and its glossary in the context of their co-operation, to work together on developing it further and to continue to exchange information on all the matters covered by the provisions of the Convention, in order to promote an awareness of landscapes and the policies relating to them. A password to access the online questionnaire has been sent to the national Representative correspondents of the Information System (Appendix to this document). These Representatives have been invited to complete or update this questionnaire, with a view to preparing the National Reports on the implementation of the Convention. A "User Manual", available to national and regional representatives of the Information System (in paragraph 5 of the Manual), invites them if they wish to create passwords for "Delegates" responsible for completing the questionnaire. The Representatives also have the possibility to give passwords to their regional representatives.

National (and regional) reports are already available for several States. #### 4. Council of Europe's Landscape Award

#### Summary

The European Landscape Convention provides for a "Landscape Award of the Council of Europe" which recognises policy or measures which local or regional authorities or nongovernmental organisations have adopted: to protect, manage and plan their landscape; which have proved to be lastingly effective; and which can thus serve as an example to other territorial authorities in Europe. According to Resolution CM/Res(2008)3 of the Committee of Ministers on the rules governing the Landscape Award of the Council of Europe, the Award is given by the Committee of Ministers based on proposals from the Committees of Experts of the Council of Europe in charge of monitoring the implementation of the Convention.

#### 6th Session of the Landscape Award of the Council of Europe (2018-2019)

Twenty three <u>Applications</u> were presented by the States' Parties to the European Landscape Convention to the Secretary General of the Council of Europe. - take into account the landscape issue in the actions taken to promote good governance and democratic citizenship, notably through awareness-raising, training and education;

- apply the principles of human rights and democracy in landscape policies;

 guarantee the right to participation by the general public, local and regional authorities, and other relevant parties including non-governmental organisations, with an interest in the definition, implementation and monitoring of landscape policies;

- include the 'landscape', as defined by the Convention, in indicators of sustainable development relating to environmental, social, cultural and economic issues;

- implement the principle of non-regression in order to ensure that landscape policies can only be subject to continuous improvement."
