I. Indicator Framework on Culture and Democracy (IFCD)

Background

In 2013, the Council of Europe Conference of Ministers of Culture requested the development of an indicator framework on culture's contribution to democracy and the economic efficiency of financing culture.

The Hertie School of Governance, as consultant, and in co-operation with a research consortium, generated a complete IFCD with 37 indicators representing the culture and democracy domain based on 144 variables for 37 member States, a guidebook for policy makers and other interested parties, and a publicly available, interactive data explorer (online tool) for users to visit and analyse the IFCD data.

The IFCD¹ revealed strong relationships between a number of culture and democracy dimensions such as active cultural engagement and democratic openness; political engagement, trust in society and well-being. IFCD findings on the vibrancy of cultural participation in member States featured in the third and fourth Reports of the Secretary General on the State of Democracy, Human Rights and the Rule of Law in Europe (2016, 2017).

Recent developments

The first thematic report on Culture and Democracy focusing on Cultural Participation and Inclusive Societies (April 2017) was made available to CDCPP members for wide distribution at national level. The second thematic report on Digitisation, Culture and Democracy was presented to the CDCPP Bureau as a draft in April 2018, and will be launched at the CDCPP plenary session in June. It explores some of the ways Europeans are engaging in and with culture and politics *online*, and related opportunities and challenges. It appears from the findings that support for online participation in culture and politics could make a positive contribution to building and maintaining inclusive, democratic societies.

In 2017, a survey with CDCPP members on IFCD use and a peer review meeting with experts involved in international index exercises led to enhancing the IFCD interactive data explorer i.e. adding background information on indicator construction and methodology and enhancing the database with missing information on sectors or countries.

Following this, the IFCD was promoted at various cultural policy events, including the Compendium Authors' meeting in Prague in October, the 2017 World Forum for Democracy in November and through the European Cultural Foundation's and Culture Action Europe's information instruments, thereby reaching out to a wide interested public. As a matter of fact, the IFCD is starting to be quoted more and more by cultural stakeholders as a source of empirical evidence on the benefits of culture.

The 5th Report of the Secretary General on the State of Democracy, Human Rights and the Rule of Law in Europe (spring 2018) will quote IFCD findings, showing that where people are more involved in cultural life, especially by creating or performing art (both online and offline) and participating in cultural activities, confidence in political entities such as parliaments, governments and the judiciary tends to be higher.

Next steps

Given the suspension of Ordinary Budget resources for IFCD work – following the decision by the Committee of Ministers of the Council of Europe of 4 April 2018 – joint efforts by the Hertie School of Governance/University of Administrative Sciences Speyer and the Secretariat are concentrating on the preparation of a grant application under the EU's Horizon 2020 programme. This would enable follow-up to the Council of Europe's investment in empirically clarifying the relationships between culture and democracy, and further project development in the framework of an enlarged European research co-operation. The IFCD tool and data will remain available to users on the Council of Europe's website.

Co-operation opportunities with the European Union shall be further investigated, in line with the reference made to the IFCD with regard to supporting the development of evidence-based policies in the Draft Council Conclusions of March 2018.²

Action required

The CDCPP is invited to:

- stress the importance of the IFCD as an evidence-based instrument that can help member States to maximise culture's potential to effectively protect and promote democracy and, subsequently, give a tangible contribution to the realisation of the Council of Europe's core values;
- welcome the work carried out on the IFCD, including the 2018 thematic report on Digitisation, Culture and Democracy;
- advise on partnerships and sponsorship opportunities for the IFCD and invite member States to make voluntary contributions to this innovative project.

II. 5th Council of Europe Platform Exchange on Culture and Digitisation

Background

The 4th Council of Europe Platform Exchange on Culture and Digitisation took place on 19-20 October 2017 at the Center for Arts and Media in Karlsruhe. It highlighted the role of cultural digital tools in facing the challenges of populism, fake news, xenophobia and undemocratic political developments. The debates inspired the drafting of a Recommendation by the Committee of Ministers of the Council of Europe to member States on Culture's contribution to strengthening the internet as an emancipatory force. The draft text was examined by the Bureau of the CDCPP in April 2018 and subsequently consulted with the Steering Committee for Mass Media and the Information Society (CDMSI) and the Steering Committee for Education Policy and Practice (CDPPE).

The amended draft is available for consultation and adoption by the CDCPP at its plenary session as document CDCPP(2018)8.

Recent developments

The 5th Council of Europe Platform Exchange on Culture and Digitisation is planned to take place on 12-13 October 2018 in Rijeka, following the invitation by the Croatian Government to hold it in the framework of its Presidency of the Committee of Ministers of the Council of Europe. The event will be held in the format of a small and select expert seminar, opening up to interested policy makers.

Building on previous Platform Exchanges and specifically the Recommendation on "Big Data for Culture, Literacy and Democracy" ([Recommendation CM/Rec\(2017\)8](#)), and given current developments, the event would look at the challenges and opportunities of Artificial Intelligence in the field of intellectual, cultural, creative production and perception.

A first work meeting was held on 27 February 2018 with representatives of the Croatian Ministry of Culture, the IRMO Institute for International Relations and Representatives of Rijeka 2020 to start preparations for the event.

Next steps

The CDCPP will hold an exchange on AI and culture issues at its plenary session in June. The Director of Ars Electronica in Linz, Gerfried Stocker has been invited to introduce this subject that may be one of the key themes of future cultural life, and hence a most challenging subject for policy makers.

Preparations with the Croatian Ministry of Culture, IRMO and the conference partners in Rijeka will be pursued, and the event agenda as well as background documents will be made available on the Council of Europe's dedicated website.

It is expected that the seminar will generate relevant insights for cultural policy makers, who are faced with the tremendous speed of developments in the IT and AI sectors. It will also generate culture-specific input towards a Council of Europe conference on AI issues planned to take place in January 2019 under the Finnish Chairmanship of the Committee of Ministers of the Council of Europe.

The expert seminar will be coordinated with the 2018 Compendium Authors' meeting that will take place in Rijeka on 9-11 October.

Action required

The CDCPP is invited to:

- thank Mr Stocker for the presentation on Culture and Artificial Intelligence;
- welcome plans for the 2018 expert seminar on Culture and Artificial Intelligence, thank the Croatian Authorities for hosting it as a Chairmanship event on 12-13 October in Rijeka, and participate in the event;
- underline the pertinence for policy makers of the Committee's work on culture and digitisation, including three Recommendations by the Committee of Ministers to member States that derived from it and contribute to promoting human rights, democracy and diversity online.

III. The Compendium of Cultural Policies and Trends Association (CCPT)

Background

On 21 October 2017, the Association of the Compendium of Cultural Policies and Trends was set up in the Netherlands to manage the Compendium project, following a 1½ year negotiation process between the Compendium stakeholders comprising member States, the Council of Europe, ERICarts, Compendium authors, academics and cultural institutions. The Association is a self-sustaining structure, comprising a Board, a General Assembly and an Assembly of Compendium Experts. This new structure reproduces in many ways the decision making processes of the former structure (in operation until 31 December 2017), and in addition enables its members a greater say in the running of the Compendium. Members, comprising member States and cultural research institutions, as well as potentially universities, pay an annual membership fee (Stakeholder members €10 000 and standing members €2 000) which puts an end to the need for ad hoc project fundraising.

The Association's members to date comprise Austria, Albania, Belgium, Croatia, Cyprus, Council of Europe, CUPORE, European Association of Cultural Researchers (ECURES), ERICarts, France, Iceland, Latvia, Romania, Sweden and Switzerland. Since then, requests regarding future membership have been made by Germany, the European Cultural Foundation and Lithuania. In addition, the CCPT is sponsored by the Netherlands government, who in 2018 is donating a contribution of €50 000.

Recent developments

Since the launch in November, the Association's Board has had a further 5 meetings, either face-to-face (thanks to the French Ministry of Culture, Paris) or via Skype. The Board has identified a Service Provider to carry out the daily business of the Compendium, namely the Boekman Foundation/ Amsterdam. A contract to employ the Service Provider, work programme and budget have all been agreed for 2018. Moreover, discussions have commenced with Eurostat in a meeting on 9-10 April to discuss a possible cooperation on the new Compendium grid.

The Board has further completed the administrative and official tasks it had to undertake as a newly incorporated Association set up under Dutch law, including: drafting of the Rules of Procedure of the Board, the General Assembly and the Assembly of Experts and the Association's membership Charter. These will be discussed by the Board with a view to their adoption at its next meeting on 6 April. The Board's first newsletter updating the Compendium Community on recent developments was sent to the Compendium mailing list of some 6 000 subscribers in April 2018. The Boekman Foundation signed the contract on 26 April at its own Board meeting and consequently took up its functions as Service Provider.

Next steps

- Collection of Membership fees in spring 2018 (thanks to the Council of Europe treasurer, Mesut Ozyavuz, these will be paid into the Council of Europe General account pending the Association having its own bank account).
- Setting up of a bank account for the Association.
- The Service provider, under the guidance of the Board and General Assembly, will work on the main projects identified for the year:
 - A new methodological grid for the country profiles and comparative statistical tables and the tables for the monitoring and comparisons sections of the website;
 - Visual and navigation improvements to ensure that the Compendium remains user-friendly on computers and mobile devices such as smartphones and tablets, as well as in step with mainstream ICT trends;
 - Review of the Compendium communication policy particularly with a view to attracting new members;
 - Evaluation and quality control of the Compendium, taking into account the transitional nature of 2018 owing to the change in business and governance model and the change in Service Provider;

Given the transitional year, maintenance of the previous system will be ensured as much as possible, finance and time permitting.
- The Board will continue to meet as often as is necessary to ensure the smooth functioning of the Association and the Compendium Database.
- The 1st Assembly of the new Association will be organised and held in Rijeka, Croatia, 9-11 October, under Croatia's Chairmanship of the Committee of Ministers of the Council of Europe and adjacent to the expert seminar on culture, creativity and artificial intelligence (12-13 October).

Action required

The CDCPP is invited to:

- take note of the positive development of the Association of the Compendium of Cultural Policies and Trends;
- take note of the forthcoming Assembly of the new Association in Rijeka, Croatia, 9-11 October 2018.
- actively consider joining and supporting the Association, if this is not already the case.

IV. Cultural Policy Reviews

Background

In 2017, the Ministry of Culture of Albania requested support with the drawing-up of a national cultural strategy. The new strategy should allow for the update of cultural policies in line with Council of Europe standards and best practice. It should be comprehensive and cover next to governance and institutional aspects also sector analyses, including tourism and cultural and creative industries.

Recent developments

An expert visit took place in November 2017 followed by a strategic multi-stakeholder policy workshop in Tirana in February 2018. The review report, including targeted recommendations for action, was submitted to the Albanian Authorities in March 2018. The Georgian Ministry of Culture has asked for a Cultural Policy Peer Review to be carried out in 2018. The focus will be on issues of arts education - within and outside the formal education system - and awareness-raising and co-operation between relevant stakeholders, including the Ministry of Education and Science.

Next steps

Work on the Cultural Policy Peer Review of Georgia started in spring and a team of experts from peer review countries (Finland, Poland and Spain) will visit the country for a first round of consultations on 24-27 June. The peer review report is expected to become available to the Georgian Authorities in September 2018.

Action required

The CDCPP is invited to:

- welcome the development of a national cultural strategy for Albania and the forthcoming cultural policy peer review of Georgia;
- underline the pertinence of the Council of Europe's technical assistance programme in the cultural and heritage sector, offered in form of Policy Peer Reviews and legal advice to member States, and the need to adequately fund these activities through the Ordinary Budget of the Organisation.
