Introduction

- The present document is based on information from the Treaty Office of the Council of Europe. It also contains information supplied by member States during the regular "tour de table" held during the 4th meeting of the DH-SYSC (9-10 November 2017) and the 89th meeting of the CDDH (19-22 June 2018).¹
- 2. The document contains information on the following treaties:
 - Protocol No. 15 to the European Convention on Human Rights (Appendix I below);
 - Protocol No. 16 to the European Convention on Human Rights (<u>Appendix II</u> below);
 - European Agreement relating to persons participating in proceedings of the European Court of Human Rights (<u>Appendix III</u> below);
 - Council of Europe Convention on Access to Official Documents (<u>Appendix IV</u> below).

¹ It is recalled that, at its 84th meeting (7-11 December 2015, CDDH(2015)R84, § 10), the CDDH decided to entrust the DH-SYSC with the systematic follow-up on the prospects of signatures and ratifications of Protocols Nos. 15 and 16 to the Convention as well as the follow-up on the European Agreement relating to Persons Participating in Proceedings of the European Court of Human Rights and specified that, in addition to requests for information of experts concerned, awareness-raising actions could be envisaged to reach a higher number of signatures and ratifications of these instruments.
