MEETING REPORT

5th meeting

5 - 8 February 2019

Item 1: OPENING OF THE MEETING, ADOPTION OF THE AGENDA AND OF THE ORDER OF BUSINESS

- 1. The Drafting Group on the place of the European Convention on Human Rights in the European and international legal order (DH-SYSC-II) held its 5th meeting in Strasbourg from 5 to 8 February 2019. The list of participants appears in <u>Appendix I</u>.
- 2. The Chair, Ms Florence MERLOZ (France) opened the meeting, evoking the different subjects on the agenda with the aim to advance in the drafting of the future report of the CDDH on the place of the Convention in the European and international legal order. The Chair also informed the Group that one of the co-Rapporteurs for Theme 1, Professor Alexei ISPOLINOV (Russian Federation), was unfortunately unable to attend the meeting.
- 3. Mr Alfonso DE SALAS, Head of the Human Rights Intergovernmental Co-operation Division, informed the Group of recent changes in the Secretariat, namely the arrival of a new assistant working on topics concerning the Unit on the system of the European Convention on Human Rights.
- 4. The Group adopted the agenda (see <u>Appendix II</u>) and the order of business (DH-SYSC-II(2019)OT1).

Item 2: DISCUSSION ON, AND ADOPTION OF THE DRAFT CHAPTERS OF THEME 1 – CHALLENGE OF THE INTERACTION BETWEEN THE CONVENTION AND OTHER BRANCHES OF INTERNATIONAL LAW, INCLUDING INTERNATIONAL CUSTOMARY LAW

- 5. The Group examined two of the four draft chapters of Theme 1 of its future report, which covers the challenge of the interaction between the Convention and other branches of international law, including international customary law. The two draft chapters were the draft chapter of Theme 1, subtheme iv) (Interaction between international humanitarian law and the European Convention on Human Rights), and the revised draft chapter of Theme 1, subtheme ii) (State responsibility and extraterritorial application of the European Convention on Human Rights), as amended following the 4th DH-SYSC-II meeting.
- 6. The Chair thanked the co-Rapporteurs, Mr Alexei Ispolinov and Mr Chanaka WICKREMASINGHE (United Kingdom), as well as the Secretariat in the name of the Group for the considerable work accomplished.

Item 2.1: Subtheme ii) – State responsibility and extraterritorial application of the ECHR

7. The Chair presented the revised draft chapter on State responsibility and extraterritorial application of the European Convention on Human Rights, as amended by the Secretariat, under the responsibility of the Chair, in the light of the discussions at the 4th DH-SYSC-II meeting and the orientations given by the CDDH at its 90th meeting¹ (document DH-SYSC-II(2018)24).²

8. The Group examined the text paragraph by paragraph and agreed on a number of amendments. It provisionally adopted³ paragraphs 1 to 45 included and 57 to 60 included of the revised draft chapter of Theme 1 subtheme ii). The Group decided that the remaining paragraphs of this draft chapter shall be examined at its 6th meeting in May 2019 with a view to its submission to CDDH for information, discussion and possible orientations at its next meeting.

Item 2.2: Subtheme iv) – Interaction between international humanitarian law and the ECHR

- 9. Mr Chanaka Wickremasinghe, the co-Rapporteur of Theme 1, presented the draft chapter on the interaction between international humanitarian law and the European Convention on Human Rights (document DH-SYSC-II(2018)15).
- 10. Following a general discussion, the Group examined the text of the draft chapter paragraph by paragraph and agreed on a number of amendments.
- 11. The Group provisionally adopted⁴ the draft chapter of Theme 1, subtheme iv) with a view to its submission to the CDDH for information, discussion and possible orientations at its next meeting. The draft chapter will equally be integrated into the future report and shall, as a part of that report, be finally adopted by the Group in its last meeting in September 2019.

Item 3: DISCUSSION ON, AND ADOPTION OF THE DRAFT CHAPTER OF THEME 2 – CHALLENGE OF THE INTERACTION BETWEEN THE CONVENTION AND OTHER INTERNATIONAL HUMAN RIGHTS INSTRUMENTS TO WHICH THE COUNCIL OF EUROPE MEMBER STATES ARE PARTIES

- 12. Ms Sofia KASTRANTA (Greece), the Rapporteur of Theme 2, presented the draft chapter on the challenge of the interaction between the Convention and other international human rights instruments to which the Council of Europe member States are parties, as revised by the Rapporteur in the light of the experts' written comments prior to this meeting (document DH-SYSC-II(2019)29).
- 13. Following a general discussion, the Group examined the text of the draft chapter paragraph by paragraph and agreed on a number of amendments.

14. The Group provisionally adopted⁵ the draft chapter of Theme 2 with a view to its submission to the CDDH for information, discussion and possible orientations at its next meeting. The draft chapter will equally be integrated into the future report and shall, as a part of that report, be finally adopted by the Group in its last meeting in September 2019.

Item 4: DISCUSSION ON THEME 3 – CHALLENGE OF THE INTERACTION BETWEEN THE CONVENTION AND THE LEGAL ORDER OF THE EU AND OTHER REGIONAL ORGANISATIONS

- 15. The Chair informed the Group that the *ad hoc* expert for Theme 3, Professor Olivier DE SCHUTTER (University of Louvain, Belgium), was unfortunately unable to attend the meeting, but had sent the Group a video recording of a presentation on Theme 3, that is, the challenge of the interaction between the Convention and the legal order of the European Union and other regional organisations, as well as notes of his presentation (document DH-SYSC-II(2019)33).
- 16. The Group watched the video recording of the presentation by Professor De Schutter.
- 17. Ms Kristīne LĪCIS (Latvia), the Rapporteur of Theme 3, gave an introductory presentation on the future draft chapter on this theme on the basis of the outline of the draft chapter previously distributed to the Group (document DH-SYSC-II(2019)32).
- 18. In its exchange of views on the subject-matter with the aim of providing guidance to the Rapporteur, the Group agreed on the following:
 - (i) The outline of the draft chapter of Theme 3 constituted a good basis for the Rapporteur's work and could still evolve during the Rapporteur's drafting;
 - (ii) As for the interaction between the Convention and the legal order of the European Union, the history of the relationship between the Convention and the European Union should be briefly covered;
 - (iii) Furthermore, the draft chapter should present the reasoning of Opinion 2/13 of the Court of Justice of the European Union and focus on the consequences of the delayed accession of the European Union to the Convention;
 - (iv) As for the analysis of the challenges in this respect, the draft chapter should generally address the challenges from the perspective of risks of fragmentation of the European legal space in the field of human rights protection. For this purpose the analysis could refer to cases concerning the Dublin regulations, the right to a fair trial, the European Arrest Warrant and the right to manifest one's religion;
 - (v) As regards the possible responses to these challenges, these could comprise judicial dialogue, a call to the European Union Member States to draw the European Union institutions' attention to the Convention standards, European Union accession to the Convention and third-party interventions of the European Union before the European Court of Human Rights;

- (vi) It could further be analysed in how far the Bosphorus presumption of equivalent protection could lead to a non-uniform level of protection of the fundamental rights of persons residing in different Member States of the Council of Europe, focusing in particular on the notions of equivalent protection and manifest deficiency;
- (vii) As for the interaction between the Convention and the legal order of other regional organisations, only the Eurasian Economic Union should be covered if sufficient material was available to deal with this topic; the experts, in particular those from Member States which are also parties to the Eurasian Economic Union, were invited to submit relevant material on this topic to the Rapporteur and the Secretariat.

Item 5: ORGANISATION OF FUTURE WORK

- 19. It was recalled that during its 88th meeting, the CDDH agreed that the costs of representatives from ten additional States could also be covered, in addition to those of the eight members of the Group (Bulgaria, Croatia, Czech Republic, France, Italy, Latvia, the Netherlands and Norway), by the budget of the Council of Europe, subject to the availability of budgetary resources and according the following rotation system:
 - 6th meeting (22-24 May 2019): Greece, Poland, Romania, Russian Federation, Serbia, Spain, Sweden, Turkey, Ukraine and the United Kingdom;
 - 7th meeting (11-13 September 2019): It is envisaged that the Council of Europe will cover the costs of all the participants.

Item 6: ADOPTION OF THE MEETING REPORT

20. At the end of its meeting, the Group adopted the present meeting report in the two official languages of the Organisation.
