### **MEETING REPORT**

4<sup>th</sup> meeting 3–5 April 2019

## <u>Item 1</u>: Opening of the meeting, adoption of the agenda and of the order of business

1. The CDDH Drafting Group on Social Rights (CDDH-SOC) held its 4<sup>th</sup> meeting in Strasbourg from 3 to 5 April 2019. The list of participants is contained in <u>Appendix I</u>.

2. The Chair, Mr Vít A. SCHORM (Czech Republic) opened the meeting. He welcomed the presence of Ms Karolina KIRINCIC ANDRITSOU (Greece), Vice-President of the Bureau of the Governmental Committee of the European Social Charter, and Mr Joseph GERADA (Malta), member of the European Social Cohesion Platform (PECS). The Chair also welcomed the fact that several members of the Department of the European Social Charter (ESC) including the Head and Deputy Head of Department were again participating in the meeting and contributing to the work of the CDDH-SOC.

3. The Group adopted the agenda (see <u>Appendix II</u>) and the order of business (CDDH-SOC(2019)OT1).

#### Item 2: Working methods and planning

4. The Chair recalled that in its last meeting, the Group had discussed and agreed on the structure and the essential content of the second report to be submitted by it to the CDDH identifying good practices and making proposals with a view to improving the implementation of social rights in Europe, and had adopted a draft table of contents of the second report (document CDDH-SOC(2018)R3, Appendix IV). He further informed the Group that the CDDH, at its 90<sup>th</sup> meeting in November 2018, had endorsed that draft table of contents (document CDDH(2018)R90, § 38 (i)).

5. Mr Alfonso DE SALAS, Secretary of the CDDH, explained that the CDDH had decided at its 90<sup>th</sup> meeting that the 5<sup>th</sup> meeting of the CDDH-SOC in September 2019 could only be held under the condition that sufficient staff was available in the Secretariat, which currently was not the case.

6. In the light of these elements, the Group agreed with the Chair's proposal not only to discuss the first draft of the second report at the present meeting, as initially foreseen by the planning of the Group's work and the agenda, but also to examine the draft report paragraph by paragraph with a view to its possible adoption at the end of the meeting.

#### <u>Item 3</u>: Discussion on the draft of the second report identifying good practices and making proposals with a view to improving the implementation of social rights in Europe

7. Following a general discussion, the Group examined the excellent draft of the second report, prepared by the Secretariat, identifying good practices and making proposals with a view to improving the implementation of social rights in Europe (document CDDH-SOC(2019)01) paragraph by paragraph, and agreed on a number of amendments to the draft report in the light of the discussion and the written comments received from the experts on the draft report (document CDDH-SOC(2019)02).

8. The Group adopted, with reservation to some adaptations to be prepared by the Secretariat, the draft second report with a view to its submission to the CDDH for consideration and possible adoption at its 91<sup>st</sup> meeting (18–21 June 2019). It appears in document CDDH-SOC(2019)R4 <u>Addendum</u>.

#### Item 4: Organisation of upcoming work

9. With the adoption of the draft second report, the Group considered that it had fulfilled its terms of reference for the biennium 2018–2019. It expressed its appreciation for the constructive approach shown by all members throughout its work and thanked the Chair of the meeting for the way in which the meetings had been conducted. The Group also paid warm tribute to the invaluable work of its Secretariat and the interpreters throughout its deliberations.

10. The Group further suggested that possible comments on the draft second report from participants in the CDDH could be sent to the Secretariat (DGI-CDDH@coe.int) no later than **3 June 2019** in order to allow the latter to compile such comments in due time for the CDDH meeting (18–21 June 2019).

11. For possible future work on the topic, the Chair recalled that the CDDH, at its 90<sup>th</sup> meeting, had considered it appropriate that the CDDH-SOC also work on questions related to university education and professional training on the system of the European Social Charter, similarly to the work undertaken by the Drafting Group on the follow-up to Recommendation Rec(2004)4 of the Committee of Ministers to member States on the European Convention on Human Rights in university education and professional training (DH-SYSC-III). The CDDH had then stated that such work could be combined with the elaboration of proposals regarding an assessment, at the national level, of the impact of draft laws, existing laws and administrative practice on the social rights laid down in the Charter. The results of the work on these two topics could possibly be reflected in a draft Recommendation (see document CDDH(2018)R90, § 38 (ii)). According to the Group, it would be desirable that such future work be undertaken by a CDDH Drafting Group in the next biennium (2020–2021).

12. Finally, the Group welcomes the initiative of the future French Presidency of the Committee of Ministers to organise an event on social rights in September 2019.

#### Item 5: Adoption of the meeting report

13. At the end of its meeting, the Group adopted the present meeting report in the two official languages of the Organisation.
