Within their jurisdiction, member States have certain positive and procedural obligations under the European Convention on Human Rights, as applied and interpreted by the European Court of Human Rights, to protect individuals against human rights abuses by business enterprises. The European Social Charter and its Additional Protocol for a system of collective complaints also afford protection against business-related human rights abuses. This session will cover the main developments in the case law of the Court and the monitoring mechanism of the European Social Charter as well as challenges in the execution of its judgments involving action by business enterprises.
