Meeting of the Bureau of the Congress Friday 12 February 2021

Remote meeting

Summary of decisions CG-BUR(2021)36-DEC¹ 2 March 2021

The Bureau of the Congress,

meeting via videoconference on 12 February 2021 with Anders KNAPE, President of the Congress, in the chair, considered the following items:

- → draft agenda: adopted the agenda [CG-BUR(2021)36-OJprov].
- → decisions taken by the Bureau: took note of the decisions of the remote Bureau meeting of 26 November 2020 adopted by written procedure on 15 December 2020 [CG-BUR(2020)35-DEC].
- → Communication by the President of the Congress: took note of the activities of the President (20.11.2020-5.02.2021) [CG-BUR(2021)36-INF03].
- → Communication by Secretary General of the Congress: took note of the missions and meetings of the Secretary General of the Congress [CG-BUR(2021)36-INF04] and in particular the call for secondments to the Congress secretariat [CG-BUR(2021)36-INF08].

→ Political groups – membership in 2021:

- took note that the 2021 grant to political groups was based on their membership on 1 January 2021 as follows [CG-BUR(2021)36-INF01]:
 - EPP/CCE: 208
 - SOC/G/PD:185
 - ILDG: 91
 - ECR: 30
- took note that there were:
 - 53 non-registered members
 - 14 members who did not want to join any of the political groups
 - 67 vacant seats.

→ Budget of the Congress:

- was informed by the Director of the Congress of the use of the 2020 budget as at 3 February 2021 [CG-BUR(2021)36-INF05];
- was informed by the Director of the Congress of the use of the 2021 budget as at 3 February 2021 and, in particular, the appropriations carried forward from 2020 to 2021 and the exceptional measures for monitoring mechanisms;
- approved the preliminary draft recommendation on the budget of the Congress for 2022-2023 for examination and adoption at the forthcoming 40th Congress session [CG-BUR(2021)36-03] (corapporteurs: Anna MAGYAR, Hungary (R, EPP/CCE), and Barbara TOCE, Italy (L, SOC)).
- → Congress renewal and national delegations (co-rapporteurs: Harald SONDEREGGER, Austria (R, EPP/CCE), and Barbara TOCE, Italy (L, SOC/G/PD)):
 - took note of the Revision of the Rules and Procedures Provisions on ethics adopted by the Statutory Forum on 12 February 2021 [CG-FORUM(2021)01-01];
 - stressed that all members of the Congress are required to sign the Code of Conduct and the Declaration of Interests in order to be able to register for Congress meetings and enjoy speaking and voting rights and defrayal of expenses;
 - took note that the Secretary General would inform new members accordingly asking them to sign electronically the aforementioned documents by 8 March 2021;
 - approved the proposed changes to the composition of the national delegations of Italy, Portugal and United Kingdom concerning the current mandate ending in March 2021 [CG-BUR(2021)36-02] and instructed the secretariat to inform the national authorities and delegations concerned;
 - approved the delegations proposed for the 2021-2026 mandate [CG-BUR(2021)36-01];
 - decided to submit these delegations to the Congress on 23 March 2021 at the opening of its 40th session for ratification subject to signature of the Code of Conduct and Declaration of Interests;
 - approved the composition of committees for the 2021-2026 mandate [CG-BUR(2021)36-07];
 - approved the new official procedure of Ukraine [CG-BUR(2021)36-09];
 - invited the authorities of Bosnia-Herzegovina, Portugal, Slovak Republic and Ukraine to submit a delegation complying with the rules by Friday, 26 February 2021, 13.00 CET;
 - entrusted the rapporteurs on the verification of credentials, together with the three presidents, on behalf of the Bureau, to verify the credentials received and update the composition of committees by Friday, 26 February 2021, 13.00 CET, in order to enable the future members of those delegations to sign the two obligatory documents by 8 March 2021 and be integrated in the list of participants and voters for the session and committees;
 - took note of the deadline of 24 July 2021: expiration of the 4-month extension of mandate of the delegations of Croatia and United Kingdom in application of Rule 3.6 due to local/regional elections held up to 2 months after the renewal session [CG-BUR(2021)36-01];

→ Bureau rapporteurs:

decided to extend the mandate of the Bureau rapporteurs until the Bureau meeting scheduled for the end of May 2021 at the latest to facilitate the continuity of the Congress' activities on the verification of credentials, the Congress budget, the Congress priorities and the Congress' Rules and Procedures and Congress Charter, under the condition that the members still held a Congress mandate [CG-BUR(2021)36-08].

→ Congress meetings in 2021:

- took note that the 40th session, convened for 23-24 March 2021, would be a remote, first part-session, held for constitutive and renewal reasons and to ensure continuity of the Congress' work [CG(2021)40-OJprov] [CG(2021)40-01];
- approved the holding of elections for the President of the Congress, presidents of the chambers, chairs and 1st vice-chairs of committees via the Kudo platform during that part-session and the holding of elections for the vice-presidents of the Congress and 2nd,3rd, 4th and 5th vice-chairs of the three committees via the Scytl platform after the respective sessions and meetings;
- instructed the secretariat to closely liaise with the Council of Europe IT services in order to guarantee the integrity and secrecy of the voting process;
- approved the closing of the voting lists on 15 March 2021;
- entrusted the three presidents and the Secretariat with proposing a date for the second part-session of the 40th Session before the summer;
- approved the preliminary proposals for Congress meetings in 2021 [CG-BUR(2021)36-05];
- took note of the list of youth delegates for 2021 [CG-BUR(2020)36-INF07].
- → Preparation of Congress priorities 2021-2026 (co-rapporteurs: Gunn Marit HELGESEN, Norway (R,EPP/CCE), and Xavier CADORET, France (L, SOC/G/PD)): approved the preliminary draft

resolution on the Congress priorities for 2021-2026 for presentation and adoption at the 40th Session in March [CG-BUR(2021)36-04].

→ Activities of the committees:

- took note of the information from committee chairs on their meetings and activities [CG-MON(2021)18-OJ] [CG-GOV(2021)16-OJ] [CG-CUR(2021)16-OJ];
- endorsed the draft work programmes of the committees [CG-MON(2021)18-02] [CG-GOV(2021)16-01] [CG-CUR(2021)16-01];
- with regard to the work programme of the Monitoring Committee, endorsed the practice of carrying out its monitoring procedures remotely.

➔ Local and regional elections:

- took note of the information concerning the elections held in Mostar on 20 December 2020 provided by the Congress Spokesperson on the Observation of Local and Regional Elections, Stewart DICKSON;
- approved the information report on the local elections held in Bosnia and Herzegovina 15 November 2020 and Mostar, Bosnia and Herzegovina 20 December 2020 [CG-MON(2021)18-09] and endorsed its conclusions;
- took note of the statement of the President of 22 December 2020 on elections held in Mostar, in Bosnia Herzegovina [News-Statement by the President of 22.12.2020];
- took note of the Calendar of local and regional elections 2021 [CG-BUR(2021)36-INF11].

→ Local and regional democracy:

Turkey:

- was informed that the situation of former Congress member Nurhayat ALTUN, currently in detention, remained unchanged;
- was informed that former Congress member Leyla GÜVEN had been sentenced to 22 years' imprisonment on charges of being a member of an armed terrorist group. Decided to continue to follow this issue and ask the rapporteurs on Turkey to enquire further in this respect in the course of their updating of the monitoring report on that country later in 2021.
- → European Local Democracy Week (ELDW): decided to grant the title of "Partner of the European Local Democracy Week 2020" to the 19 local and regional authorities and 1 association as proposed in Document [CG-BUR(2021)36-06].
- → World Forum for Democracy 2020/2021 "Can Democracy Save the Environment?": took note of the <u>News of 13.01.2021</u>.
- → Parliamentary Assembly (PACE) 1st Part of the 2021 Session (Hybrid, 25-29 January 2021):
 - took note of the agenda, the address by Marija PEJČINOVIĆ BURIĆ, Secretary General of the Council of Europe, and questions and answers as well as the address by Heiko MAAS, Minister for Foreign Affairs of Germany, Chair of the Committee of Ministers, and questions and answers;
 - took note of the communication by the Committee of Ministers Chair to PACE on the activities of the Committee of Ministers (February 2020 January 2021);
 - took note of the election of the President and the Vice-Presidents of the PACE.

→ Committee of Ministers (CM):

- took note of the Congress' political dialogue with the Committee of Ministers [CG-BUR(2021)36-INF09];
- heard information on the 12th meeting of the CDDG held remotely on 25-27 November 2020 and took note of the abridged meeting report [CDDG(2020)31].
- → Timetable of events: took note of the Congress timetable of events until October 2021. [CG-BUR(2021)36-INF10].
