 - Origin/DG Remarks The European Committee of Social Rights is established by the European Social Charter. It is composed of 15 independent experts. It works on 2 specific objectives: treating collective complaints and examining national reports on the application of the European Social Charter with a view to rule on the conformity of national situations under the Charter.
 - **Objective(s)** To examine the pending collective complaints.
 - To examine national reports for Conclusions XXII-2 (2021) of the 1961 Charter and Conclusions 2021 of the Revised Charter.
 - To examine developments relating to the procedure on non-accepted provisions.
 - To examine the draft proposal for targeted questions for state reports (Conclusions 2022/XXII-3).
 - To consider the draft amendments to the Rules and to the Working Methods.
 - To hold an exchange of views with the CoE Commissioner for Human Rights.

Output

- 1) During the exchange of views with the CoE Commissioner for Human Rights inter alia the following topics were discussed: general issues of cooperation and synergy between the Committee and the Commissioner, the right to health, including in relation to COVID-19, in the light of the recent Issue Ppaper published by the and on the basis of the Commissioner Committee's own work such as the statements on COVID-19
- 2) The Committee adopted a decision on the merits in the following complaint:

- 3) The Committee took stock of the situation in the following complaint:
