The European Committee of Social Rights is established by the European Social Charter. It is composed of 15 independent experts. It works on two specific objectives: treating collective complaints and examining national reports on the application of the European Social Charter with a view to rule on the conformity of national situations under the Charter.

## Origin/DG Remarks

- To examine the pending collective complaints.
- To adopt Conclusions XXII-4 (2023) of the 1961 Charter and Conclusions 2023 of the Revised Charter.
- To adopt Findings 2023

#### To examine developments relating to the procedure on non-accepted provisions (Implementation of Article 22 of Objective(s) the 1961 Charter).

- To develop the methodology for the examination of ad hoc reports in 2024.
- To examine and adopt the distribution of Rapporteur responsibilities and the composition of sub-committees for 2024 (ad hoc reports).

- To discuss the preparation of the High-level conference in Vilnius, 3-4 July 2024.
- To hold an exchange of views with the UN Committee on the Rights of the Child.
  - The Committee adopted Conclusions XXII-4 (2023) of the 1961 Charter and Conclusions 2023 of the Revised Charter in respect of 34 States Parties;
  - The Committee adopted Findings 2023 on follow-up to decisions in collective complaints in respect of 8 States Parties;
  - 3) The Committee adopted a decision on admissibility in the following complaint:
    - Fédération SUD Santé-Sociaux v. France Complaint No. 226/2023
  - 4) The Committee adopted a decision on the merits in the following complaint:

## Output

- European Trade Union Confederation (ETUC), Netherlands Trade Union Confederation (FNV) and National Federation of Christian Trade Unions (CNV) v. the Netherlands Complaint No. 201/2021
- 5) The Committee examined developments related to upcoming reports and meetings on non-accepted provisions and adopted its report on Latvia.
- 6) The Committee examined and adopted the distribution of Rapporteur responsibilities and the composition of the sub-committees for 2024 (ad hoc reports).
- 7) The Committee discussed the preparation of the Highlevel conference in Vilnius, 3-4 July 2024.
- 8) The Committee held an exchange of views with the UN Committee on the Rights of the Child.

# Conclusions/ Follow Up

The Committee instructed the Secretariat:

- To notify Conclusions 2023/Conclusions XXII-4 (2023) to States with a view to making them public on 20 March 2024;
- To notify Findings 2023 to States with a view to making them public on 20 March 2024
- To follow the collective complaints procedure with the Rapporteurs for the pending complaints;
- to transmit to the parties and publish the decision on admissibility;
- To notify the decision on the merits in accordance with the usual procedure;
- to be in contact with States concerned by reports and meetings on non-accepted provisions and in particular to transmit the report on Latvia to its authorities.
