## To the members of the Committee on Migration, Refugees and Displaced Persons

# Synopsis of the meeting held in Paris, on 11 May 2023

**The Committee on Migration, Refugees and Displaced Persons**, meeting in Paris, on 11 May 2023, from 10:00 to 11:45 am and from 14:00 to 16:30 pm, with Mr Paul Gavan (Ireland, UEL), First Vice-Chairperson, in the Chair, as regards:

- **Immigration, one of the answers to Europe's demographic aging** (*Rapporteur: Ms Kate Osamor, United Kingdom, SOC*): considered a draft outline;
- Ad hoc Sub-Committee to carry out a fact-finding visit to Calais (France): constituted an ad hoc sub-committee to carry out the visit in question, subject to the authorisation by the Bureau of the Assembly and approved its composition (see Appendix);
- Social inclusion of migrants, refugees and internally displaced persons through sport (*Rapporteur: Ms Nigar Arpadarai, Azerbaijan, EC/DA*): considered a revised draft report and unanimously adopted a draft resolution;
- Addressing the humanitarian consequences of the blockade of the Lachin corridor (*Rapporteur: Mr Paul Gavan, Ireland, UEL*): agreed to change the title of the report as follows: "Ensuring free and safe access through the Lachin Corridor" and decided to ask the Bureau to hold an urgent debate on this issue during the June 2023 part-session;
- Missing migrants, refugees and asylum seekers a call to clarify their fate (*Rapporteur: Mr Julian Pahlke, Germany, SOC*): had an exchange of views with the participation of Ms Tania Delabarde, Forensic anthropologist, Institute of Forensic Medicine, Paris, and Mr Syd Bolton, co-founder, Last Rights Project, United Kingdom;
- Addressing the specific challenges faced by the Belarusians in exile (*Rapporteur: Mr Paul Galles, Luxembourg, EPP/CD*): considered a draft report and unanimously adopted a draft resolution;
- France: Call for the respect of fundamental rights in Mayotte in the framework of operation "Wuambushu": considered and unanimously adopted a declaration as amended;
- Work programme:
  - Call for candidates for rapporteur: called for candidates for report on "The use of explosive weapons as a major driver of justified displacement" and took note of Mr Domagoj Hajdukovic's interest (Croatia, SOC);
- **Next meetings:** took note of its next meetings as follows:
  - Strasbourg, during the third part-session 2023 of the Assembly (19-23 June);
  - Reykjavik (Iceland), 21-22 September 2023;
  - Strasbourg, during the fourth part-session 2023 of the Assembly (9-13 October);
  - Paris, 8 December 2023 (Council of Europe Office).
