# Synopsis of the meetings held in Strasbourg on 22, 23 and 25 January 2024

**The Committee on Migration, Refugees and Displaced Persons**, meeting in Strasbourg, on 22, 23 and 25 January 2024:

- on Monday 22 January 2024, from 6:00 to 7:00 pm, with first Lord Leslie Griffiths (United Kingdom, SOC), eldest member present, and then Mr Oleksii Goncharenko (Ukraine, EC/DA), Chairperson, in the Chair, as regards:
- Election of the Bureau of the Committee: elected by acclamation:
  - Mr Oleksii Goncharenko (Ukraine, EC/DA), Chairperson,
  - Ms Kate Osamor (United Kingdom, SOC), 1st Vice-Chairperson,
  - Mr Emmanuel Fernandes (France, UEL), 2<sup>nd</sup> Vice-Chairperson,
  - Ms Tamara Vonta (Slovenia, ALDE), 3rd Vice-Chairperson;
- The theme of migration and asylum in election campaigns and the consequences on the welcoming and rights of migrants involved (Rapporteur: Mr Pierre-Alain Fridez, Switzerland, SOC): took position on 4 amendments which had been tabled to the draft resolution;
- Urgent debate on "The situation of the children of Ukraine": appointed Ms Sandra Zampa (Italy, SOC) as rapporteur for opinion and heard her declaration of absence of conflict of interest;
- Follow-up on "Deportations and forcible transfers of Ukrainian children and other civilians to Russian Federation or to Ukrainian territories temporarily occupied: create conditions for their safe return, stop these crimes and punish the perpetrators" Rapporteur: Mr Paulo Pisco (Portugal, SOC):
  - Consideration of the reply by the Committee of Ministers to Assembly Recommendation 2253
    (2023): took note of the Committee of Ministers' Reply and heard a statement by the Rapporteur on this
    issue:
  - Statement by the rapporteur: heard a statement by the rapporteur on his participation to the Bureau ad-hoc Committee on "The situation of the children of Ukraine" held on Friday 15 December 2023 in Paris.

- Work programme: Considered and approved the work programme:
  - **Authorisations by the Committee**: authorised Mr Domagoj Hajduković (Croatia, SOC), to participate in the Fundamental Rights Forum of the European Union Agency for Fundamental Rights in Vienna on 11-12 March 2024;
- Consideration of the reply by the Committee of Ministers to Assembly Recommendation 2238
  (2022) on "Safe third countries for asylum seekers": took note of the Committee of Ministers' Reply
  and heard a statement by the rapporteur, Ms Stephanie Krisper (Austria, ALDE), on this issue;
- Gender equality in the functioning of the Assembly: heard a statement by Mr Oleksii Goncharenko (Ukraine, EC/DA), Chairperson;
- on Tuesday 23 January 2024, from 11.30 am to 12.30 pm, with Mr Oleksii Goncharenko (Ukraine, EC/DA), Chairperson, in the Chair, as regards:
- Follow-up on "Addressing the specific challenges faced by the Belarusians in exile": Rapporteur
  Mr Paul Galles (Luxembourg, EPP/CD): heard a Statement by the rapporteur on his participation to
  different events linked to the follow-up of his report;
- Urgent debate on "The situation of the children of Ukraine": Rapporteur: Ms Sandra Zampa (Italy, SOC): considered and approved a draft opinion;
- Open discussion on current issues
  - Heard an introduction by Mr Julian Pahlke (Germany, SOC) on "The UK-Rwanda deal" and its consequences in Europe;
- on Thursday 25 January 2024, from 9.10 to 9.50 am (started at 9.25 am and finished at 9.45 am), with Mr Oleksii Goncharenko (Ukraine, EC/DA), Chairperson, in the Chair, as regards:
- Consideration of a draft motion for resolution with a view to its adoption by the Committee, and for tabling on its behalf on "An urgent call to Europe and its partners: envisioning immediate and long-term policy solutions and support for displaced people from Ukraine": considered and approved a draft motion for a resolution proposed at the initiative of the chair, Mr Oleksii Goncharenko (Ukraine, EC/DA), to be tabled on behalf of the Committee;
- Call for candidates for two reports on:
  - "Saving migrants' lives at sea and protecting their human rights";
  - "The challenges and needs of public and private actors involved in migration management";
- Reconstitution and composition of the Sub-Committees: reconstituted its three sub-committees and approved their composition (see Appendix):
  - Sub-Committee on Diasporas and Integration,
  - Sub-Committee on Refugee and Migrant Children and Young People,
  - Sub-Committee on Migrant Smuggling and Trafficking in Human Beings;
