### Synopsis of the meeting held in Paris on 8 and 9 January 2024

The Committee on the Election of Judges to the European Court of Human Rights, meeting on 8 and 9 January 2024, first with Mr Titus Corlăţean (Romania, SOC), and then Mr Sergiy Vlasenko (Ukraine, EPP/CD), in the Chair, as regards:

  - held interviews with the candidates in respect of Luxembourg and adopted its recommendation for the attention of the Assembly;

  - held an exchange of views with the chairperson of the Advisory Panel of experts, Mr Luis López Guerra;
  - held interviews with the candidates in respect of Bulgaria and adopted its recommendation for the attention of the Assembly;
- ***Consideration of a list of candidates for a post of judge in the European Court of Human Rights (Lithuania):***
  - held an exchange of views with the chairperson of the Advisory Panel of experts, Mr Luis López Guerra;
  - held interviews with the candidates in respect of Lithuania and adopted its recommendation for the attention of the Assembly;
