## To the members of the Committee on the Election of Judges to the European Court of Human Rights

### Synopsis of the meeting held in Paris on 10 and 11 June 2024

The Committee on the Election of Judges to the European Court of Human Rights, meeting on 10 and 11 June 2024, first with Ms Petra Bayr (Austria, SOC), then Mr Serhii Kalchenko (Ukraine, EC/DA), and then again Ms Petra Bayr in the chair, as regards:

- **Consideration of a list of candidates for a post of judge in the European Court of Human Rights (Andorra):**
  - held an exchange of views with the chairperson of the Advisory Panel of experts, Mr Luis López Guerra;
  - held interviews with the candidates in respect of Andorra and adopted its recommendation for the attention of the Assembly;
- **Held an exchange of views with Ms Síofra O’Leary, President of the European Court of Human Rights;**
- **Consideration of a list of candidates for a post of judge in the European Court of Human Rights (Austria):**
  - held an exchange of views with the chairperson of the Advisory Panel of experts, Mr Luis López Guerra;
  - held interviews with the candidates in respect of Austria and adopted its recommendation for the attention of the Assembly;
- **Procedure for the election of judges to the European Court of Human Rights:** adopted a motion for a resolution for tabling on behalf of the Committee;
- **Consideration of a list of candidates for a post of judge in the European Court of Human Rights (Finland):**
  - held an exchange of views with the chairperson of the Advisory Panel of experts, Mr Luis López Guerra;
  - held interviews with the candidates in respect of Finland and adopted its recommendation for the attention of the Assembly;
- **Consideration of a list of candidates for a post of judge in the European Court of Human Rights (Serbia):**
  - held an exchange of views with the chairperson of the Advisory Panel of experts, Mr Luis López Guerra;
  - held interviews with the candidates in respect of Serbia and adopted its recommendation for the attention of the Assembly;
