# Synopsis of the meeting held in Paris on 30 November and 1 December 2023

The Committee on Legal Affairs and Human Rights, meeting in Paris on 30 November 2023 (from 2.30-6pm) with Mr Constantinos Efstahtiou (Cyprus, SOC) in the Chair, then on 1 December 2023 (9.30-5.30pm) with Mr Damien Cottier (Switzerland, ALDE) in the Chair:

- On Thursday 30 November 2023 (from 2.30-6pm), as regards,
- Election of the Council of Europe Commissioner for Human Rights by the Parliamentary
   Assembly: approved a memorandum prepared by the Secretariat at the request of the Chairperson of
   the Committee on Legal Affairs and Human Rights;
- Reparation and reconciliation processes to overcome past conflicts and build a common peaceful future – the question of just and equal redress (Rapporteur: Lord Richard Keen, United Kingdom, EC/DA): considered a draft report and adopted of a draft resolution and a draft recommendation, the latter unanimously;
- Countering SLAPPs: an imperative for the democratic society (Rapporteur for opinion: Mr Davor Ivo Stier, Croatia, EPP/CD) (Rapporteur for the Committee on Culture, Science, Education and Media: Mr Stefan Schennach, Austria, SOC): considered and approved an opinion on the report of the Committee on Culture, Science, Education and Media;
  - Abolition of the death penalty: Re-appointed Mr Aleksandar Nikoloski, (North Macedonia, EPP/CD)
    as General Rapporteur on the abolition of the death penalty for a second term (first term: appointed on
    12.12.2022). Considered a revised information note and agreed to its declassification;
  - Sanctions of persons on the "Kara-Murza list" (Rapporteur: Mr Eerik-Niiles Kross, Estonia, ALDE)
     held a hearing with the participation of:

Ms Evgenia Kara-Murza, wife of the Russian opposition activist and Advocacy Coordinator at the Free Russia Foundation"

Mr Bill Browder - Head of Sergei Magnitsky Justice Campaign, United Kingdom (online);

- Election of the Council of Europe Commissioner for Human Rights by the Parliamentary
   Assembly [in camera]: held interviews with the three shortlisted candidates for the post of
   Commissioner for Human Rights and agreed on its report to be sent to the Bureau of the Assembly with
   the committee's recommendation;

- On Friday 1 December 2023 (from 2.30-5pm), as regards,
- Human Rights Defenders: Whistleblowers (General Rapporteur: Mr Emanuelis Zingeris (Lithuania, EPP/CD) held a hearing with the participation of:

Mr Sergei Cristo, Whistleblower

Ms Anna Myers, Executive Director of the Whistleblowing International Network (WIN), United Kingdom Mr Jean-Philippe Foegle, Expert on whistleblowers and researcher and doctoral student in public and European law;

Follow-up to the meeting of the Sub-Committee on the implementation of judgments of the European Court of Human Rights in Zagreb (13-14 November 2023): heard an oral report by the Rapporteur on the implementation of judgments of the European Court of Human Rights (12<sup>th</sup> Report), Mr Constantinos Efstathiou, (Cyprus, SOC). Considered a revised information note on "Reykjavik Follow-Up: The Role of PACE and National Parliamentarians in Improving the Timely and Effective Implementation of Judgments of the European Court of Human Rights" and agreed to its declassification;

#### References transmitted to the committee:

- The detention of Julian Assange and its chilling effects on human rights (<u>Doc. 15777</u>): made a call for a Rapporteur to be appointed during the January part-session;
- Reference transmitted for inclusion in another report:

The role of sanctions as a protective measure for human rights and democracy (<u>Doc. 15812</u>): took note of this reference to be taken into account in the framework of the report on "Sanctions of persons on the "Kara-Murza list";

- Support for the reconstruction of Ukraine (<u>Doc. 15732</u>): agreed to request the Bureau to be seized for an opinion on the report being prepared by the Committee on Political Affairs and Democracy;
- Replies from the Committee of Ministers to recommendations emanating from the Committee: took note of the following replies from the Committee of Ministers concerning:
  - Recommendation 2241 (2022) on "The impact of the Covid-19 restrictions for civil society space and activities" adopted at the 1 473<sup>rd</sup> meeting of the Ministers' Deputies on 6 September 2023. Took note of the reply;
  - Recommendation 2242 (2022) on "The impact of the Covid-19 pandemic on prison population in Europe" adopted at the 1 477<sup>th</sup> meeting of the Ministers' Deputies on 4 October 2023. Noted the concerns of the Rapporteur and his intention to follow them up.;
- Hearings during the next meeting: agreed to hold the following hearings during the January partsession (open to the public if the experts agree), subject to the availability of funds and subject to time constraints in meeting slots allocated to the Committee:

"Abolition of the death penalty", on the abolition of the death penalty in observer and "partner for democracy" States

"Legal and human rights aspects of the Russian Federation's aggression against Ukraine" (Rapporteur: Mr Davor Ivo Stier, Croatia, EPP/CD): hearing focused on the compensation mechanism and possible use of Russian assets for purposes of reparation of the damage caused to Ukraine;

#### Other business

Legal aspects of the accession of the European Union to the European Convention on Human Rights (Rapporteur: Mr Titus Corlăţean, Romania, SOC): decided to request the Bureau for an extension of the reference until 30 June 2024;

#### Sub-committees:

- Sub-Committee on the implementation of judgments of the European Court of Human Rights: agreed that Mr. Saša Magazinović, (Bosnia and Herzegovina, SOC), who was on the waiting list, be given a recently vacated seat as titular member. Agreed that the previous members of the French delegation (Mr Frédéric Mathieu and Mr André Vallini) be replaced by M. Alain Milon (EPP/CD) and Mme Michelle Greaume (UEL) as titular members;
- Sub-Committee on Human Rights: agreed that Ms Domenica Spinelli (Italy, EC/DA), who was on the waiting list, be given a recently vacated seat as titular member. Agreed that the previous members of the French delegation (Mr André Gattolin and Mr Frédéric Mathieu) be replaced by M. Olivier Bltz (ALDE) and Mr Christophe Chaillou (SOC) as titular members;
- **Call for nominations for the** 2024 Vigdís Prize for Women's Empowerment made a call for candidatures and noted the details available on the PACE site;
- Helsinki Dialogue on Belarus

   ad hoc Sub-Committee of the Committee on Political Affairs
   and Democracy, 11-12 January 2024
   – agreed to the participation of Ms Sunna Aevarsdóttir
   (Iceland, SOC) and the possible participation of Mr Oleksii Goncharenko (Ukraine, EC/DA) either
   in his own right (subject to the availability of funds) or as substitute to Ms Aevarsdóttir;
- Platform for dialogue between the Assembly and the Russian democratic forces/ civil society: took note of the participation of Sir Christopher Chope (United Kingdom, EC/DA), in his capacity as third Vice-Chairperson, in this meeting on 14 December 2023;
- Exchange of views with the Steering Committee for Human Rights (CDDH) of the Council of Europe: heard an oral report by the Chair on his participation in this exchange held on 29 November 2023, during the 99<sup>th</sup> meeting of the CDDH;
- Next meetings: confirmed the meeting on 4 March 2024 at the Paris office.
