Synopsis of the meeting held in Paris on 5 March 2024

The **Committee on Political Affairs and Democracy**, meeting in Paris on 5 March 2024, with Mr Bertrand Bouyx (France, ALDE), Chairperson, in the Chair, as regards:

- Promoting the revised Code of Good Practice on Referendums (rapporteur: Ms Isabel Meirelles, Portugal, EPP/CD): considered a draft report and unanimously adopted a preliminary draft resolution;
- Relationship between the parliamentary majority and the opposition in a democracy (rapporteur: Ms Elvira Kovács, Serbia, EPP/CD): considered a draft report and unanimously adopted a preliminary draft resolution as amended;
- Statutory Opinion on the application for membership set out in the letter of 12 May 2022 addressed to the Secretary General of the Council of Europe, in line with Statutory Resolution (51) 30 (rapporteur: Ms Dora Bakoyannis, Greece, EPP/CD): heard a statement by the rapporteur following her fact-finding visit to Brussels on 21 February 2024, considered an Information note, and held an exchange of views;
- Death of Alexei Navalny Current situation in Russia: held an exchange of views;
- General Rapporteur for a Democratic Belarus: approved the terms of reference of a General Rapporteur for a Democratic Belarus, and decided to transmit them to the Bureau of the Assembly in line with rule 50.7 of the Assembly's Rules of Procedure;
- Strengthening democracy through participatory and deliberative processes (rapporteur: Mr George Papandreou, Greece, SOC): heard a statement by the rapporteur and held a hearing with the participation of Ms Kalypso Nicolaïdis, Transnational Democratic Odyssey, Chair in Global Affairs, School of Transnational Governance, European University Institute (Italy), Emeritus professor, University of Oxford (United Kingdom), and her collaborator Mr Niccolò Milanese, followed by an exchange of views;
- Call for Famagusta's return to its lawful inhabitants (rapporteur: Mr Piero Fassino, Italy, SOC): heard
 a statement by the rapporteur following his fact-finding visit to Ankara on 15 February 2024 and held an
 exchange of views:
- The situation in Iran and protection of Iranian human rights defenders in Council of Europe member States (rapporteur: Mr Max Lucks, Germany, SOC): held a hearing with the participation of Ms Nargess Eskandari-Grünberg, Deputy Mayor of the City of Frankfurt am Main and Head of the Department for Diversity, Anti-Discrimination and Social Cohesion, and Mr Ali Fathollah-Nejad, Director of the Center for Middle East and Global Order (CMEG), Berlin, followed by an exchange of views;
- Meeting of the Committee in Oslo: took note of the preliminary draft programme and the practical information;

 Changes in the composition of the Sub-Committees: agreed to the changes in the composition of the Sub-Committee on the Middle East and Arab World, the Sub-Committee on External Relations, and the Sub-Committee on the Western Balkans (as indicated in bold in the appendix);
