# Revised synopsis of the meeting held in Strasbourg on 10 and 12 October 2023

The **Committee on Culture, Science, Education and Media**, meeting in Strasbourg on Tuesday 10 October 2023 from 8.30 am to 10.30 am, and on Thursday 12 October 2023 from 11.30 am to 12.30 pm, with Mr Stefan Schennach (Austria, SOC) and Ms Laura Castel (Spain, UEL) in the chair,

## Tuesday 10 October 2023 from 8.30 am to 10.30 am, as regards:

- Minutes
  - approved the minutes of the meeting held in London on 1 June 2023;
  - approval and declassified the addendum of the minutes of the hearing on "Protecting human rights in and through sport: obligations and shared responsibilities";
  - approved the minutes of the meeting held in Strasbourg on 19, 20 and 22 June 2023;
  - approved and declassified the minutes of the joint public hearing on "SLAPPs as a threat to media
    pluralism and measures implemented to counteract them" with the Committee on the Honouring of
    Obligations and Commitments by Member States of the Council of Europe held in Strasbourg on 20
    June 2023.
- Committee representation: designated Ms Yevheniia Kravchuk (Ukraine, ALDE) as representative to the Network of Contact Parliamentarians for a healthy environment, subject to her declaration of absence of conflict of interests;
- Countering SLAPPs: an imperative for a democratic society (Rapporteur: Mr Stefan Schennach, Austria, SOC): took note of the explanatory memorandum, then unanimously adopted a draft resolution and a draft recommendation, thereby approving the report;
- Strengthening a youth perspective in the work of the Parliamentary Assembly (Rapporteur: Mr Anastasios Chatzivasileiou, Greece, EPP/CD):
  - took note of the change of title of the report by the Committee on Political Affairs and Democracy (which was previously "Establishment of a "youth partnership" status with the Parliamentary Assembly");
  - appointed Ms Yevheniia Kravchuk (Ukraine, ALDE), in her absence, rapporteur for opinion to replace Ms Inka Hopsu (Finland, SOC), subject to her declaration of absence of conflict of interests; agreed that Ms Fiona O'Loughlin (Ireland, ALDE), Chairperson of the Sub-Committee on Education, Youth and Sport, would present the opinion;
  - unanimously adopted an opinion of the committee and tabled ten amendments to the draft resolution presented by the Committee on Political Affairs and Democracy;
- **Cultural heritage and climate change** (Rapporteur: Mr Andries Gryffroy, Belgium, NR): considered a preliminary draft report and held an exchange of views with Mr Tero Mustonen (online), Professor of human geography, Finland, and lead author of the 6<sup>th</sup> assessment report of the Intergovernmental Panel on Climate Change (IPCC);

- Guaranteeing media freedom and the safety of journalists: an obligation of member States (Rapporteur: Mr Mogens Jensen, Denmark, SOC): considered a preliminary draft report;
- Committee work programme

References to the committee and appointment of rapporteurs: appointed Ms Luz Martinez Seijo (Spain, SOC) rapporteur on "The role of sites of remembrance: places of commemoration and education for democratic citizenship" (Doc. 15471) to replace Ms Nina Kasimati (Greece, UEL), and heard her declaration of absence of conflict of interests;

- approved, subject to the availability of funds, the participation of Mr Andries Gryffroy, Rapporteur on "Cultural heritage and climate change", in the meeting of the EPICO project on 14-15 December 2023 in Versailles, France;

#### Thursday 12 October 2023 from 11.30 am to 12.30 pm, as regards:

- Risks and opportunities of the Metaverse (Rapporteur: Mr Andi-Lucian Cristea, Romania, SOC): held an exchange of views with Ambassador Aloisia Wörgetter, Thematic Co-ordinator on Information Policy (TC-INF), Council of Europe; agreed that the exchange of views could be filmed and published on YouTube by Mr Ričards Šlesers (Latvia, NR); and declassified an introductory memorandum;
- Excluding the athletes and officials of the Russian Federation and Belarus from participating in the international Olympic movement (Rapporteur: Ms Denisa Elena Neagu, Romania, ALDE): heard a statement by the rapporteur and approved the rapporteur's request to change the title to "Olympic movement and peacekeeping: is sport neutrality serving sport values?";
- **Propaganda and freedom of speech in Europe** (Rapporteur: Ms Tonia Antoniazzi, United Kingdom, SOC): considered an introductory memorandum;
