## Synopsis of the meeting held in Strasbourg on 23, 24, 25 January 2024

**The Committee on Legal Affairs and Human Rights**, meeting in Strasbourg on 23, 24, and 25 January 2024:

- **on Tuesday 23 January 2024 at 8.30am**, with Sir Christopher Chope (United Kingdom, EC/DA), oldest member present, in the Chair, as regards:
- Election of the Bureau of the Committee: elected, by acclamation, Lord Richard Keen (United Kingdom, EC/DA), as Chairperson, Ms Lesia Vasylenko (Ukraine, ALDE) as 1st Vice-Chairperson, Mr Pablo Hispán (Spain, EPP/CD) as 2<sup>nd</sup> Vice-Chairperson and Ms Thorhildur Sunna Ævarsdóttir (Iceland, SOC) as 3<sup>rd</sup> Vice-Chairperson;

Then with Lord Richard Keen (United Kingdom, EC/DA), Chairperson, presiding:

- Minute's silence in honour of Mr Dick Marty: held a minute of silence in memory of Mr Dick Marty, former member and former Chairperson of the committee;
- Committee on Artificial Intelligence (CAI): current state of the negotiations on the Draft Framework Convention on Artificial Intelligence, Human Rights, Democracy and the Rule of Law: held an exchange of views with the Chairperson of the Committee on Artificial Intelligence, Mr Thomas Schneider;
- Constitution of Sub-Committees: agreed to constitute the Committee's current three subcommittees for 2024, namely:
  - i. Sub-Committee on Human Rights
  - ii. Sub-Committee on Artificial Intelligence and Human Rights
  - iii Sub-Committee on the implementation of judgments of the European Court of Human Rights;
- **Composition of sub-committees:** approved the composition as in the attached appendix<sup>1</sup>;
- Motion for a resolution on the protection of Whistle-blowers: considered and agreed to table a motion for resolution on this subject on behalf of the Committee;
