Synopsis of the meeting held in Strasbourg on 25, 26, 27 April 2023

The Committee on Legal Affairs and Human Rights, meeting in Strasbourg on 25, 26, and 27 April 2023:

- on Tuesday 25 April 2023 from 8.30am 9.30am, as regards:
- Joint hearing with the Committee on Political Affairs and Democracy (open to the public) on "Ensuring accountability for the Russian Federation's aggression against Ukraine: the role of the Council of Europe", with Mr Damien Cottier (Switzerland, ALDE), Chairperson of the Committee on Legal Affairs and Human Rights, in the Chair and then Mr Zsolt Németh Chairperson of the Committee on Political Affairs and Democracy (Hungary, EC/DA) in the Chair, with the participation of:

Mr Tiny Kox, President of the Parliamentary Assembly Mr Christos Giakoumopoulos, Director General, Directorate General Human Rights and Rule of Law (DGI), Council of Europe Mr Jörg Polakiewicz, Director of Legal Advice and Public International Law, Council of Europe;

- **on Tuesday 25 April 2023 from 9.30am 10.30am**, with Mr Damien Cottier (Switzerland, ALDE), in the Chair, as regards:
- **European Convention on Human Rights and national constitutions** (Rapporteur: Mr George Katrougalos, Greece, UEL): took position on one amendment to the draft resolution;
- The arbitrary detention of Vladimir Kara-Murza and the systematic persecution of anti-war protesters in the Russian Federation (Rapporteur: Ms Thorhildur Sunna Ævarsdóttir, Iceland, SOC) with the participation of Ms Evgenia Kara-Murza, wife of the Russian opposition activist Vladimir Kara-Murza, and Advocacy Coordinator at the Free Russia Foundation, and of Mr Vadim Prokhorov, Vladimir Kara-Murza's lawyer, considered an introductory memorandum, agreed to a future hearing with invited experts, subject to the availability of funds;
- On Wednesday 26 April 2023 from 11.30am-12.30pm, as regards:
- **Examining the legitimacy and legality of the ad hominem term-limit waiver for the incumbent President of the Russian Federation** (Rapporteur: Mr Pieter Omtzigt, The Netherlands, EPP/CD): held a hearing with the participation of:

Ms Claire Bazy Malaurie, President of the Venice Commission Ms Simona Granata-Menghini, Secretary of the Venice Commission;

- Sub-Committee on Human Rights: took note of an oral report by the Chairperson of the Sub-Committee on the meeting held in on Tuesday 25 April 2023 and endorsed the proposals of the Sub-Committee concerning the lists of candidates to the European Committee for the Prevention of Torture (CPT) submitted by the delegations of San Marino, Cyprus, Belgium, the Czech Republic, Lithuania and Finland for transmission to the Bureau;
- The implementation of judgments of the European Court of Human Rights 11th report (Rapporteur: Mr Constantinos Efstathiou, Cyprus, SOC) – took position on 2 amendments to the draft resolution;

– Appointment of rapporteurs:

Reparation and reconciliation processes to overcome past conflicts and build a common peaceful future – the question of just and equal redress <u>Doc. 15676;</u> appointed Lord Richard Keen (United Kingdom, EC/DA) as Rapporteur and heard from him a statement of no conflict of interest;

Legal and human rights aspects of the Russian Federation's aggression against Ukraine (Bureau decision); appointed Mr. Davor Ivo Stier (Croatia, EPP/CD) as Rapporteur and heard from him a statement of no conflict of interest;

- Call for candidates for the General Rapporteur for political prisoners: made a call for a general rapporteur to be appointed at the next meeting. Noted the interest of Ms Thorhildur Sunna Ævarsdóttir (Iceland, SOC), who, if appointed, would relinquish her current rapporteurship as General Rapporteur on the situation of human rights defenders and whistleblowers. A conditional call for candidates was made for the latter so that both General Rapporteurs could be appointed at the next meeting;
- Follow-up to the Committee's proposal to establish an ad hoc sub-committee to visit Ukraine in the near future: noted that this matter was now foreseen for consideration by the Bureau on Friday 27 April 2023 (please see the Bureau's decision in <u>AS/BUR 005</u>);
- Václav Havel Human Rights Prize 2023: noted the deadline for submission of nominations;

- Joint hearing on "Threats to life and safety of journalists and human rights defenders in Azerbaijan" (Rapporteur: Ms Hannah Bardell, UK, NR), (Rapporteur for opinion (AS/Cult): Stefan Schennach, Austria, SOC): held a joint hearing with the Committee on Culture, Science, Education and Media and the Committee on the Honouring of Obligations and Commitments by member States of the Council of Europe (Monitoring Committee), with the participation of :

Ms Arzu Geybullayeva, Journalist; Mr Ulvi Hasanli, Founder and Executive Director of AbzasMedia and Ms Jeanne Cavelier, Head of Eastern Europe & Central Asia Desk, Reporters without borders;
