# Synopsis of the meetings held in Strasbourg on 25, 26 and 27 June 2024

The **Committee on Culture, Science, Education and Media**, meeting in Strasbourg on Tuesday 25 June 2024 from 2 pm to 3.30 pm, together with the Committee on Social Affairs, Health and Sustainable Development, with Ms Linda Hofstad Helleland (Norway, EPP/CD) and Mr Simon Moutquin (Belgium, SOC) as co-chairs, on Wednesday 26 June from 2 pm to 3.30 pm, with Ms Linda Hofstad Helleland (Norway, EPP/CD) in the chair, and on Thursday from 2 pm to 3 pm, with Ms Fiona O'Loughlin (Ireland, ALDE) in the chair,

# Tuesday, 25 June 2024 from 2 pm to 3.30 pm, as regards:

Joint meeting with the Committee on Social Affairs, Health and Sustainable Development: agreed to open the meeting to public; held a hearing on Countering addiction to sport betting with the participation of Ms Sylvie Andreau, journalist, France; Mr Jann Schumacher, Chair of the Expert Group on Online addictions of the Pompidou Group, Switzerland; Mr Jean-Yves Lourgouilloux, Chair of MARS, Network of Magistrates / Prosecutors responsible for Sports, Enlarged Partial Agreement on Sport (EPAS), Council of Europe; Mr Ioannis Simosis, athlete, Greece; and Mr Dimitrios Davakis, Greek Legal Counsel / Integrity Manager, Hellenic Football Federation, Greece;

- Risks and opportunities of the Metaverse (Rapporteur: Mr Andi-Lucian Cristea, Romania, SOC): took note of the explanatory memorandum, then unanimously adopted a draft resolution, thereby approving the report;
- Towards a Parliamentary Alliance for Good Governance and Integrity in Sport: heard a statement by Mr Mogens Jensen (Denmark, SOC), General Rapporteur on Governance and Ethics in Sport, concerning a consultation of Assembly members on the establishment of a Parliamentary Alliance;
- Doping in sport: agreed to open the exchange of views to the public; held an online exchange of views with Mr Steven Teitler, Legal Director, Doping Authority Netherlands;
