Synopsis of the meeting held in Strasbourg on 25 and 27 April 2023

The **Committee on Culture, Science, Education and Media**, meeting in Strasbourg on Tuesday 25 April 2023 from 8.30 am to 12.30 pm and on Thursday 27 April 2023 from 8.30 am to 11.30 am, with Ms Yevheniia Kravchuk (Ukraine, ALDE) and Mr Stefan Schennach (Austria, SOC) in the chair,

Tuesday 25 April 2023 from 8.30 am to 10.30 am, as regards:

- **Declaration of absence of conflict of interests:** heard the respective declarations of absence of conflict of interests from:
