Synopsis

of the meetings held in Paris on 18-19 March 2024

The Committee on Equality and Non-Discrimination, meeting in Paris on 18-19 March 2024, with Ms Mariia Mezentseva (Ukraine, EPP/CD), Chairperson, in the Chair, as regards:

- Monday 18 March, from 9am to 12.30pm and from 2 to 5pm:
- Election of the Bureau of the Committee: elected by acclamation Ms Nina Kasimati (Greece, UEL), as Third Vice-Chairperson;
- Statutory Opinion on the application for membership set out in the letter of 12 May 2022 addressed to the Secretary General of the Council of Europe, in line with Statutory Resolution (51) 30 (Rapporteur for opinion: Ms Béatrice Fresko-Rolfo, Monaco, ALDE; Rapporteur for report: Ms Dora Bakoyannis, Greece, EPP/CD): heard a statement by the Rapporteur for opinion;
- Appointment of general rapporteurs: appointed:
 - following a vote, Mr Fourat Ben Chikha (Belgium, SOC) as General Rapporteur on combating racism and intolerance;
 - by acclamation, Ms Béatrice Fresko-Rolfo (Monaco, ALDE) as General Rapporteur on the rights of lesbian, gay, bisexual, transgender and intersex (LGBTI) people;

and heard their declarations of absence of conflict of interest;

- Freedom of expression and assembly of LGBTI people in Europe (Rapporteur: Mr Christophe Lacroix, Belgium, SOC): approved a draft report and unanimously adopted a draft resolution as amended;
- Overcoming age-based discrimination against older persons (Rapporteur: Ms Andrea Eder-Gitschthaler, Austria, EPP/CD): considered an information memorandum and held a hearing with the participation of:
 - Mr Daris Lewis Recio, Legal and Policy Officer, European Network of Equality Bodies (EQUINET), Brussels:
 - Ms Nena Georgantzi, Human Rights Manager, AGE Platform Europe (online);
- Work programme: adopted a motion for a resolution entitled Promoting the Istanbul Convention and improving its implementation: building on lessons learnt, for tabling on behalf of the Committee;
- Appointment of rapporteurs: appointed by acclamation:
 - Mr Fourat Ben Chikha (Belgium, SOC) as rapporteur for report on For a ban on so-called conversion therapies,
 - Ms Yevheniia Kravchuk (Ukraine, ALDE) as rapporteur for opinion on Violence and hate speech against politicians: a threat to democracy;

and heard their declarations of absence of conflict of interest;

- due to a lack of candidates, postponed to its next meeting the appointment of a rapporteur for report on The situation of national minorities in Ukraine;

- Gender-sensitive parliaments: heard a presentation of EIGE's toolkit for gender-sensitive parliaments by Ms Carlien Scheele, Director of the European Institute for Gender Equality (EIGE) and Ms Elena Anchevska, EIGE Gender Mainstreaming team;
- o **Promoting inclusive participation in parliamentary and political life** (*Rapporteur: Ms Maryna Bardina, Ukraine, ALDE*): heard a statement by the Rapporteur;
- o Protecting women human rights defenders and people who defend women's rights in Europe (Rapporteur: Ms Petra Bayr, Austria, SOC): heard a statement by the Rapporteur on her fact-finding visit to Warsaw on 4-5 March 2024;
- Sexual violence against men and boys (Rapporteur: Mr Fourat Ben Chikha, Belgium, SOC): considered an information memorandum and held a hearing with the participation of:
 - Mr Gary Williams, CEO of SurvivorsUK, London;
 - Ms Katherine Gambir, Senior Research Advisor at the Women's Refugee Commission (online);
- Tuesday 19 March, from 9.30 to 10.30am:
- o **International Day for the Elimination of Racial Discrimination, 21 March 2024**: considered and adopted a declaration as amended;
- Activities of the Parliamentary Network Women Free from Violence: heard a communication by Ms Etilda Gjonaj (Albania, SOC), General Rapporteur on violence against women;
- Commission on the Status of Women (CSW 68) (New York, United States, 11-22 March 2024): heard a communication by Mr Georgios Stamatis (Greece, EPP/CD), Chairperson of the *Ad Hoc* Sub-Committee, on the participation in the side-event *Parliamentarians as drivers for women's empowerment* on 11 March 2024 and other events;
- Appointment of representatives (subject to the availability of funds): following a written consultation, took note of the appointment of the following members to the ad hoc committee of the Bureau to participate in the Women Political Leaders Summit "Democracy for the 21st century" (Athens, 19-21 March 2024): Ms Nina Kasimati (Greece, UEL) and Ms Maria Syrengela (Greece, EPP/CD);
