Synopsis of the meeting held in Strasbourg on 23, 24, 25 and 26 January 2023

The Committee on Legal Affairs and Human Rights, meeting in Strasbourg on 23, 24, 25 and 26 January 2023:

- **on Monday 23 January 2023 at 2.15pm**, with Lord Richard Keen (United Kingdom, EC/DA), oldest member present, in the Chair, as regards:
- Election of the Bureau of the Committee: elected, by acclamation, Mr Damien Cottier (Switzerland, ALDE) as Chairperson, Mr Davor Ivo Stier (Croatia, EPP/CD) as 1st Vice-Chairperson, Ms Margreet de Boer (Netherlands, SOC) as 2nd Vice-Chairperson and Sir Christopher Chope (United Kingdom, EC/DA) as 3rd Vice-Chairperson;

Then with Mr Cottier (Switzerland, ALDE), Chairperson, in the Chair:

- Constitution of Sub-Committees: agreed to constitute the Committee's current three subcommittees for 2023, namely:
 - i. Sub-Committee on Human Rights
 - ii. Sub-Committee on Artificial Intelligence and Human Rights
 - iii Sub-Committee on the implementation of judgments of the European Court of Human Rights;
- Appointment of representatives of the Committee: agreed to propose to the Bureau that the following members and substitutes be appointed to represent the Committee at meetings of the following bodies in 2023 in the framework of the Assembly's institutional representation:
 - European Commission for Democracy through Law (Venice Commission) Mr Constantinos Efstathiou (Cyprus, SOC) – titular Mr Serhii Vlasenko (Ukraine, EPP/CD) - substitute
 - ii. Council for Democratic Elections (of the Venice Commission)Mr. Davor Ivo Stier (Croatia, EPP/CD) titularMs Khatia Dekanoidze (Georgia, EPP/CD) substitute
 - iii. Group of States against Corruption (GRECO)Mr Titus Corlatean (Romania, SOC) titularMs Elena-Simona Spătaru (Romania, ALDE) substitute

- iv. MoneyvalMs Maria-Gabriela Horga (Romania, EPP/CD) titularMs Klotilda Bushka (Albania, SOC) substitute
- v. Committee of Experts on the Protection of the Environment through Criminal Law (PC-ENV)
 Ms Sunna Aevarsdottir (Iceland, SOC) titular
 Mr Ziya Altunyaldiz (Turkey, NR)- substitute
- Addressing the issue of Daesh foreign fighters and their families returning from Syria and other countries to the member States of the Council of Europe (Rapporteur: Mr Pieter Omtzigt, the Netherlands, EPP/CD)- took position on 10 amendments to the draft resolution and 3 to the draft recommendation:

- Debate under urgent procedure: Legal and human rights aspects of the Russian Federation's aggression against Ukraine (Rapporteur: Mr Damien Cottier, Switzerland, ALDE): took position on 7 amendments to the draft resolution;

- **on Thursday 26 January 2023 at 2pm**, with, first, Mr Davor Ivo Stier (Croatia, EPP/CD), 1st Vice-Chairperson, in the Chair as regards:
- Emergence of lethal autonomous weapons systems (LAWS) and their necessary apprehension through European human rights law (Rapporteur: Mr Damien Cotter (Switzerland, ALDE): took position on 5 amendments to the draft resolution;

 - Legal aspects of the accession of the European Union to the European Convention on Human Rights (Rapporteur: Mr Titus Corlatean, Romania, SOC);
