Synopsis of the meetings held in Strasbourg on 24-26 January 2023

The Committee on Social Affairs, Health and Sustainable Development, meeting in Strasbourg on Tuesday, 24 January 2023, at 8.30 am, with first Mr Jean-Pierre Grin (Switzerland, ALDE), oldest member present, and then Ms Selin Sayek Böke (Türkiye, SOC), re-elected Chairperson, in the Chair, as regards:

- **Election of the Bureau of the Committee:** re-elected by acclamation:
 - Ms Selin Sayek Böke (Türkiye, SOC), Chairperson
 - Mr Alain Milon (France, EPP/CD), first Vice-Chairperson
 - Ms Olena Khomenko (Ukraine, EC/DA), second Vice-Chairperson
 - Ms Sibel Arslan (Switzerland, SOC), third Vice-Chairperson
 - **Standing invitation:** decided, in accordance with Resolution 1376 (2004) and the decision of the Bureau of the Assembly of 4 October 2004 approved the same day by the Assembly, and according to Article 48.7 of the Rules of Procedure, to invite the elected representatives of the Turkish Cypriot community to attend its meetings during the Assembly's 2023 Ordinary Session;

 - **Taking into consideration the impact of the fight against the Covid-19 pandemic on the mental health of minors and young adults** (*Rapporteur: Mr Simon Moutquin, Belgium, SOC*): considered and agreed to declassify a preliminary draft report, and held a public hearing with the participation of Mx Anna Knobbout, member of the Advisory Council on Youth (CCJ) of the Council of Europe;
