Synopsis

of the meeting held in Strasbourg on 24 and 26 January 2023

The Committee on the Honouring of Obligations and Commitments by Member States of the Council of Europe (Monitoring Committee), meeting in Strasbourg on 24 and 26 January 2023 in camera, with Mr Bernard Fournier (France, EPP/CD), oldest member present, Mr Piero Fassino (Italy, SOC) and Mr Joseph O'Reilly (Ireland, EPP/CD) in the Chair:

- on Tuesday, 24 January 2023 at 2.00 pm., as regards:
- **Election of the Chairperson of the Committee:** elected Mr Piero Fassino (Italy, SOC), Chairperson by acclamation;
- **Election of the three Vice-Chairpersons of the Committee:** elected the following Vice-Chairpersons by acclamation:
 - Mr Samad Seyidov (Azerbaijan, EC/DA), First Vice-Chairperson,
 - Mr Joseph O'Reilly (Ireland, EPP/CD), Second Vice-Chairperson,
 - Mr Eerik-Niiles Kross (Estonia, ALDE), Third Vice-Chairperson;
- **Sub-Committee on Conflicts concerning Council of Europe Member States:** decided to reconstitute the Sub-Committee (the list of members is attached in appendix);
- **Post-monitoring dialogue with Montenegro** (*Co-rapporteurs: Mr Damien Cottier, Switzerland, ALDE and Mr Nicos Tornaritis, Cyprus, EPP/CD*): heard a statement by the co-rapporteur;
- The honouring of obligations and commitments by Hungary (*Co-rapporteurs: Mr Eerik-Niiles Kross, Estonia, ALDE and*): elected and, after hearing his declaration of absence of conflict of interest, appointed Mr Eerik-Niiles Kross (Estonia, ALDE) as co-rapporteur; elected Mr George Papandreou (Greece, SOC) with a view to appointing him as co-rapporteur, subject to hearing his declaration of absence of conflict of interest at the next meeting;
- **Council for Democratic Elections of the Venice Commission**: decided to propose to the Bureau the following nominations to the Council for Democratic Elections (Venice Commission) for 2023: Mr Aleksander Pociej (Poland, EPP/CD) as member and Ms Laura Castel (Spain, UEL) as substitute;
- The honouring of obligations and commitments by Türkiye (*Co-rapporteurs: Mr John Howell, United Kingdom, EC/DA and Mr Stefan Schennach (Austria, SOC*): considered an information note following the fact-finding visit of the rapporteurs (12-13 January 2023); took note of Mr John Howell's intention to introduce technical amendments and agreed to declassify the amended note; heard a declaration of absence of conflict of interest by Mr Stefan Schennach (Austria, SOC) and appointed him as co-rapporteur to replace Mr Boriss Cilevičs (Latvia, SOC);
- **Post-monitoring dialogue with Bulgaria** (Co-rapporteurs: Ms Thórhildur Sunna Ævarsdóttir, Iceland, SOC and Ms María Valentina Martínez Ferro, Spain, EPP/CD): heard a statement by the co-rapporteurs;

No. 5599) and on the law on National Minorities (Communities) of Ukraine;
- The honouring of obligations and commitments by the Republic of Moldova (*Co-rapporteurs: Mr Pierre-Alain Fridez, Switzerland, SOC and* ...: took note that no amendments have been tabled to the draft resolution; made a call for candidates to replace Ms Inese Lībiņa-Egnere (Latvia, EPP/CD);
- The honouring of obligations and commitments by Georgia (*Co-rapporteurs: Mr Claude Kern, France, ALDE and Ms Edite Estrela, Portugal, SOC*): heard a declaration of absence of conflict of interest by Ms Edite Estrela (Portugal, SOC) and appointed her as co-rapporteur to replace Mr Titus Corlăţean (Romania, SOC);
- The honouring of membership obligations to the Council of Europe by San Marino (Corapporteurs: Mr Andrej Hunko, Germany, UEL and Mr Joseph O'Reilly, Ireland, EPP/CD): heard a declaration of absence of conflict of interest by Mr Joseph O'Reilly (Ireland, EPP/CD) and appointed him as co-rapporteur to replace Mr Viorel-Riceard Badea (Romania, EPP/CD);
