# Synopsis of the meeting held in Strasbourg from 15 to 18 April 2024

The Committee on Legal Affairs and Human Rights, meeting in Strasbourg from 15 to 18 April 2024, with Lord Richard Keen (United Kingdom, EC/DA), Chairperson, in the Chair:

- on Monday 15 April 2024 at 2pm, as regards:
- Debate under urgent procedure on "Alexei Navalny's death and the need to counter Vladimir Putin's totalitarian regime and its war on democracy" (Rapporteur: Mr Emanuelis Zingeris (Lithuania, EPP/CD); heard a statement of absence of conflict of interests by the Rapporteur who was appointed in absentia on 4 March 2024; considered a draft report and unanimously adopted a draft resolution;
- Application by Kosovo¹ for membership of the Council of Europe (Rapporteur for opinion: Ms Azadeh Rojhan, Sweden, SOC; Rapporteur for the Committee on Political Affairs and Democracy: Ms Dora Bakoyannis, Greece): approved a draft opinion;
- on Tuesday 16 April 2024 at 8.30am, as regards:
- Debate under urgent procedure on "The arbitrary detention of Vladimir Kara-Murza and the systematic persecution of anti-war protesters in the Russian Federation and Belarus" (Rapporteur: Ms Thórhildur Sunna Ævarsdóttir (Iceland, SOC): heard an intervention by Ms Evgenia Kara-Murza, wife of the imprisoned Russian opposition politician and anti-war activist, Mr Vladimir Kara-Murza; considered a draft report and unanimously adopted a draft resolution;
- Debate under urgent procedure on the Draft Framework Convention on Artificial Intelligence, Human Rights, Democracy and the Rule of Law (Rapporteur: Ms Thórhildur Sunna Ævarsdóttir (Iceland, SOC)): considered a draft report and unanimously adopted a draft opinion;
- Private military companies, mercenaries, foreign fighters and their impact on human rights
  (Rapporteur: Mr Andrea Orlando (Italy, SOC)): considered an introductory memorandum and
  agreed to its declassification; agreed to a future hearing with invited experts, subject to the
  availability of funds (open to the public should the experts agree);

- Ad hoc committee of the Bureau to visit the ICRC headquarters in Geneva in the framework of the follow-up to Resolution 2529 (2024) on "The situation of the children of Ukraine": agreed to propose the following members to the Bureau to participate in this ad hoc committee: Ms Lesia Vasylenko (Ukraine, ALDE) and Ms Lucia Plaváková (Slovak Republic, ALDE) as titular members and Mr Damien Cottier (Switzerland, ALDE) as substitute with the proviso that the date, when confirmed, is convenient for them;

Committee of Experts on the Protection of the Environment through Criminal Law (PC-ENV), Strasbourg, 27-29 February 2024: oral report by Mr Constantinos Efstathiou (Cyprus, SOC); Committee on Artificial Intelligence (CAI), Strasbourg, 13-14 March 2024: oral report by Ms Thórhildur Sunna Ævarsdóttir (Iceland, SOC); 138th Plenary Session of the Venice Commission of the Council of Europe, Venice (Italy) 15-16 March 2024: oral report by Mr Antonio Gutiérrez Limones (Spain, SOC); Committee of Legal Advisers on Public International Law (CAHDI) Seminar on the Special Tribunal for the Crime of Aggression against Ukraine, Strasbourg, 10 April 2024: oral report by Lord Richard Keen (United Kingdom, EC/DA);

- Debate under urgent procedure on the Draft Framework Convention on Artificial Intelligence, Human Rights, Democracy and the Rule of Law (Rapporteur: Ms Thórhildur Sunna Ævarsdóttir (Iceland, SOC)): noted that no amendments had been tabled to this opinion;
- Hearings during the next meeting: agreed to hold a hearing at the next meeting on "Transnational repression as a growing threat to the rule of law and human rights" (Rapporteur for follow-up: Sir Christopher Chope, United Kingdom, EC/DA) with invited experts, subject to the availability of funds (open to the public provided that all experts agree);

- **Reference extensions:** agreed to request the Bureau for extensions to the following references until 31 December 2024:
  - Threats to life and safety of journalists and human rights defenders in Azerbaijan (Rapporteur: Ms Hannah Bardell, UK, NR)
  - Legal aspects of the accession of the European Union to the European Convention on Human Rights (Rapporteur: Mr Titus Corlăţean, Romania, SOC);
- Authorisation of participation of members at forthcoming events:
  - Committee of Experts on the Protection of Lawyers (to be held on 13-15 May, in Strasbourg): agreed for Sir Christopher Chope (United Kingdom, EC/DA) to attend, subject to the availability of funds;
- Next meetings: agreed to a request by the Committee on the Honouring and Commitments by Member States of the Council of Europe to swap the dates of the September meeting which will now be held on 10<sup>th</sup> September 2024 in Paris instead of 11 September 2024 as originally foreseen:
