**Report on the 29th Plenary of the Cybercrime Convention Committee** 

Bucharest, 11 – 12 December 2023

# 29<sup>th</sup> Plenary Meeting of the T-CY

11 – 12 December 2023

### 1. Introduction

The 29<sup>th</sup> Plenary of the T-CY Committee, meeting in Bucharest on 11 and 12 December 2023, was chaired by Pedro Verdelho (Portugal), opened by Patrick Penninckx (Head of Information Society Department, Council of Europe) and addressed by Hanne Juncher (Director of Information Society and Action against Crime, Council of Europe).

Some 185 representatives of 87 Parties and Observer States as well as of international organisations and Council of Europe committees participated in person (149) or online (36) in this meeting.

The T-CY Plenary was followed by the Octopus Conference on 13 – 15 December.

### 2. Decisions

The T-CY decided:

### Item 1 – Opening of the 29th Plenary and adoption of the agenda

- To note the increasing interest in the Convention on Cybercrime and its Protocols in recent months as reflected in accessions and requests for accession.
- To underline that cooperation within the framework of the Convention on Cybercrime is now more relevant than ever given current international challenges – such as threats to peace, security, democracy, justice and human rights – that may be accompanied by cybercrime and related threats.

# Item 2 – State of signatures, ratifications and accessions to the Convention on Cybercrime and its Protocols

- To welcome signature of the Second Additional Protocol to the Convention on Cybercrime since the last Plenary by Armenia.
- To encourage all Parties to the Convention to sign and ratify this Protocol as soon as possible so that its tools become available to practitioners and, in this connection, to recall that capacity building projects are available to support implementation of this Protocol.
- To welcome the invitations to Kiribati, Rwanda and Sao Tomé and Príncipe to accede to the Convention on Cybercrime.
- To remind States of the mandatory declararation with regard to the authorities to be made with respect to Articles 24 (extradition), 27 (mutual assistance) and 35 (24/7 point of contact) when depositing the instrument of ratification or accession to the Convention on Cybercrime.
- To encourage T-CY representatives to support the ongoing process of consultations with regard to requests for accession in line with the T-CY workplan.
- To recall that invitations to accede are valid for a period of five years, and that once a State has acceded to the Convention, accession to the first Protocol and signature and ratification of the Second Protocol are possible at any time.

### Item 3 – Information provided by Parties and Observers

- To welcome the information provided by Argentina, Armenia, Australia, Azerbaijan, Benin, Brazil, Cameroon, Chile, Colombia, Costa Rica, Côte d'Ivoire, Ecuador, France, Grenada, Kazakhstan, Kiribati, Republic of Korea, Lithuania, Mexico, Netherlands, Nigeria, Peru, Philippines, Rwanda, Sao Tomé and Príncipe, Senegal, Serbia, Sierra Leone, Sri Lanka, Spain, Tonga, Tunisia, Türkiye, Ukraine, Uruguay and Vanuatu as well as the European Union Commission.
- To underline the impact of capacity building activities on cybercrime and electronic evidence supported by the Cybercrime Programme Office of the Council of Europe (C-PROC) in many Parties and Observer States; and in this respect, thank Japan, the United Kingdom and the USA for recent voluntary contributions and the European Union for co-funding of new joint projects.
- To note the considerable increase in the use of the tools of the Convention on Cybercrime for investigations and prosecutions in and cooperation between Parties.
- To underline that criminal law provisions including in laws on cybercrime that restrict the freedom of expression must meet human rights and rule of law requirements.

### Item 4 – T-CY Workplan 2024 – 2025

• To adopt the T-CY Workplan for 2024 – 2025.

### Item 5 – Financial resourcing of the T-CY

- To take note that the T-CY is partially funded by the Ordinary Budget of the Council of Europe but also relies on voluntary contributions given that many Parties to the Convention are not members of the Council of Europe and, therefore, do not contribute to the Ordinary Budget of the organisation.
- Therefore, to strongly encourage Parties and observers to the T-CY to provide voluntary contributions to the Octopus Project in line with the decision taken by the T-CY in 2013 and as foreseen in Article 12.1 of the T-CY Rules of Procedure to permit the functioning of the T-CY also in 2024 and 2025.

### Item 6 – T-CY assessments

- To welcome the draft assessment report on Article 19 of the Convention and the examples of implementation presented during the Plenary.
- To thank the Parties that had provided their replies to the questionnaire, and the Bureau members, Secretariat and consultants for the analysis of the information received.
- To invite:
  - those Parties that have not yet submitted their replies to do so by 31 January 2024;
  - any Party to submit comments on the draft report, if any, by 31 January 2024;
  - the T-CY Secretariat and Bureau to share a complete version of the draft assessment report with Parties by early May 2024 for comments and for consideration by the 30<sup>th</sup> Plenary of the T-CY in June 2024.

### Item 7 – Functioning of the 24/7 Network of contact points

- To take note of the annual meeting of the 24/7 network of contact points held in The Hague in October 2023 with 140 participants from 66 Parties, 12 observer States and 4 organisations.
- To welcome that 24/7 contact points are in place in all 68 Parties to the Convention, that almost all are able to respond in an expedited manner and, in particular, the increasing operational use of the network and level of cooperation among its members.
- To invite T-CY members to assist the T-CY Secretariat should issues arise related to the functioning of contact points.
- To request the T-CY Secretariat to prepare the draft of a complementary directory of authorities for mutual assistance (Article 27) and extradition (Article 24) under the Convention on Cybercrime for consideration by the T-CY.
- To underline that projects implemented by C-PROC are available to set up or further strengthen the capacities of 24/7 contact points, if necessary.

### Item 8 – UN treaty process (AHC)

- To encourage Parties, signatories and States invited to accede to contribute to the UN treaty
  process and to participate in the concluding session of the Ad Hoc Committee in New York from
  29 January to 9 February 2024 to ensure full consistency of a future additional treaty with the
  Budapest Convention on Cybercrime and with the necessary human rights and rule of law
  safeguards.
- To invite Parties and observers to share comments on the draft text of the Convention with the T-CY Secretariat by 23 December 2023 in order to permit the Secretariat and Bureau to prepare a T-CY briefing note by early January 2024.

#### **Item 9 – Any other business**

- To take note that:
  - following the 28<sup>th</sup> T-CY Plenary in June 2023, a number of non-member States of the Council of Europe that are Parties to the Budapest Convention, decided to join the negotiation of a convention on artificial intelligence by the Committee on Artificial Intelligence (CAI) of the Council of Europe;
  - while this treaty is to be finalised by Spring 2024, additional States may still join these negotitations which would then permit them to contribute in substance and subsequently to sign and ratify this future instrument.
- To take note that also non-member States of the Council of Europe are able to participate in the enlarged partial agreement on the Register of Damage Caused by the Aggression of the Russian Federation Against Ukraine established by the Council of Europe in May 2023.

#### Item 10 – Date of the 30<sup>th</sup> T-CY Plenary

• To hold T-CY 30 on 18 – 20 June 2024 in Strasbourg.
