With respect to the procedure applied for the election, it is proposed to the Representatives of States Parties to refer to <u>Appendix 1 to Resolution CM/Res(2021)3</u> - Rules of Procedure for Council of Europe intergovernmental committees - Article 12.d: "*Election of the Chair and Vice-Chair shall require a two-thirds majority of members entitled to vote at the first ballot, a simple majority of members entitled to vote at the second ballot and the highest number of votes at the third ballot. In steering committees, the election shall be held by secret ballot, in other committees by a show of hands, unless a member of the committee requests a secret ballot".*
