I. OPENING

1. WELCOME

The Chair welcomed the participants to this 9th meeting, organised on the sidelines of the 18th Council of Europe Conference of Ministers responsible for Sport (8-10 October). He thanked the Portuguese authorities for hosting the meeting on this important occasion and for their kind hospitality.

2. AGENDA

The Follow-up Committee adopted the agenda of the meeting as appearing in Appendix I. The list of participants features in Appendix II.

3. RECENT DEVELOPMENTS AT COUNCIL OF EUROPE LEVEL

The Committee took note of the information provided by the Secretariat, notably:

- ✓ The election of the new Secretary General, Alain Berset, who took up his duties on 18 September 2024.
- ✓ The transfer of the Sport Division from Directorate General on Democracy and Human Dignity to Directorate General on Human Rights and the Rule of Law.

The Committee adopted the 2025-2027 strategic vision and encouraged the Secretariat to establish links with other entities of the Council of Europe, including notably those focusing on combating money laundering, corruption, cybercrime, etc.

II. STANDARD SETTING AND LEGAL ISSUES

4. STATE OF SIGNATURES AND RATIFICATIONS

The Follow-up Committee took note of the information provided by the Secretariat. It welcomed the upcoming ratifications announced by several countries, such as Spain and Morocco, and is pleased with the potential upcoming signatures from Romania and Sweden.

The Committee also noted the interest shown by several South American countries, particularly Brazil and Mexico. It also thanked CONMEBOL for its active support in promoting the Convention.

The Committee approved the declaration marking the 10th anniversary to be endorsed by the Conference to be held on 8 October, which aims to mobilise all countries to sign or ratify the Convention.

The Committee took note of the study carried out on the history of the legal and institutional deadlock.

5. INFORMATION SHARING AND DATA PROTECTION

The Follow-up Committee took note of the draft data-sharing agreement aimed at facilitating the exchange of information between public authorities. It also took note of the draft agreement facilitating the exchange between sports organisations and regulatory authorities and held an exchange of views on some specific matters such as data retention limits.

The working group is encouraged to continue its efforts by finalising the agreements and further developing the Macolin data protection toolbox.

6. REASONABLE BETTING

The Follow-up Committee took note of the presentation by Christian Kalb and invited the Working group to finalise the guidelines for the next plenary meeting.

7. ILLEGAL BETTING

The Follow-up Committee took note of the presentation by Christian Kalb and invited the Working group to finalise the guidelines for the next plenary meeting.

8. Money Laundering and sports betting

The Committee took note of the presentation by Pim Verschuuren and invited the Secretariat to publish the report once finalised based on the latest comments provided.

III. MONITORING OF THE CONVENTION

9. NATIONAL EVALUATION

The Committee took note of the draft report on the evaluation of Norway. For the next meeting, the Committee proposed to continue with the evaluations of Portugal and the Republic of Moldova as outlined in the strategy.

IV. NATIONAL AND INTERNATIONAL COOPERATION

10. DEVELOPMENTS AT INTERNATIONAL AND NATIONAL LEVEL

The Follow-up Committee took note of the developments of the last months during the roundtable by the States Parties, the invited countries and the observers.

11. ADVISORY GROUP

The Follow-Up Committee took note of the activities implemented and of the objectives of the 7th meeting to be held on 14 and 15 November 2024 in Strasbourg.

12. ACT PROJECT (ADDRESSING COMPETITIONS' MANIPULATION TOGETHER)

The Follow-up Committee thanked Switzerland for its additional contribution to be provided at the end of 2024. It invited other countries and organisations to provide such a financial support.

It took note of the possible organisation of the project's closing event in Canada during the first half of 2025. It welcomed the preparation and launch of the ACTII project, which is essential for the effective implementation of the Convention.

13. NETWORK OF MAGISTRATES/PROSECUTORS (MARS)

The Follow-up Committee took note of the information provided on the development of country profiles on national judicial systems and the content of the annual meeting held on June 18-19 at INTERPOL headquarters.

The Follow-up Committee decided to address the issue of the criteria and the process for integrating new observers during its next plenary meeting.
