I. OPENING

1. WELCOME

The Advisory Group thanked the Moroccan authorities for hosting this 5th meeting and their warm hospitality.

The Group welcomed the participation of 10 countries of the African continent, invited as guests for the open session: Cameroon, Egypt, Ghana, Guinea, Guinea-Bissau, Ivory Coast, Nigeria, Sierra Leone, Tunisia, and Uganda.

2. AGENDA

The Advisory Group adopted the meeting agenda as attached in Appendix I. The list of participants appears in Appendix II, with a total of 93 participants from 39 countries and representing other stakeholders.

The Advisory Group welcomed, in accordance with the rules of procedure, the open nature of the first session of the meeting (8 November) enabling the participation of invited partners.

3. RECENT DEVELOPMENTS AT COUNCIL OF EUROPE LEVEL

The Advisory Group took note of the information provided by the Secretariat, notably:

- √ 4th Summit of Heads of State and Government of the Council of Europe, 16-17 May 2023, in Reykjavik, Iceland, was an historical reaffirmation of their union around common values.
- ✓ The important work of the Enlarged Partial Agreement on Sport (EPAS) in protecting sport integrity and formalising the Network of Magistrates and Prosecutors responsible for Sports (MARS), which held its meeting on 18-19 September 2023 in Paris (France), with participation of the Minister of Justice and the Minister of Sports, Olympic and Paralympic Games of France.
- ✓ The adoption by the Committee of Ministers of the Council of Europe of a **Declaration on sport integrity** (adopted on 27 September 2023) which notably stresses the importance of ratifying and implementing the Macolin Convention.

The Secretariat also presented the on-line free HELP course on sport and human rights, soon available in Arabic, French and Spanish.

II. NATIONAL AND INTERNATIONAL COOPERATION

4. RECENT DEVELOPMENTS AT INTERNATIONAL AND NATIONAL LEVEL

The Advisory Group took note of the rich and varied developments presented by the participants from over 30 countries. A compilation of contributions will be sent to members and observers.

5. PARTNERSHIPS

The Advisory Group took note of the work undertaken by the Working Group in 2023 and welcomed the excellent collaboration with the sports sector, law enforcement agencies, betting operators, and other international institutions engaged in safeguarding the integrity of sport.

The Group decided to entrust its Bureau for any relevant follow-up.

6. NETWORK OF MAGISTRATES/PROSECUTORS RESPONSIBLE FOR SPORTS (MARS)

The Advisory Group took note of the information provided by the Secretariat.

The Group highlighted the importance of each national platform working closely with prosecutors and invited each country, if not already done, to help identify a national point of contact in the public prosecutors' offices.

III. DETECTION AND INVESTIGATION

7. ALERTS

The Advisory Group took note of the presentation by the French national platform and ULIS on the alerts logbook and highlighted the importance of this tool to better understand the phenomenon of manipulation.

The Group took note of the work undertaken by the Working Group in 2023 and the current results of the survey on alerts, presented by the Danish national platform. All the national platforms are invited to respond to the questionnaire before the end of the year.

The Group tasked the Working Group to submit Terms of Reference for 2024 before the end of this year. Additionally, it requested an analysis of the new IT platform's functionalities, specifically designed for exchanging alerts, to be presented at the next plenary meeting.

8. SHARING BEST PRACTICES

The Advisory Group took note with great interest of 4 presentations as follows:

- Presentation of a case study by the Estonian national platform on the "TT-Cup" table tennis competition and the exclusion of 5 players;
- Presentation by the Portuguese national platform on the biggest challenges to overcome and the landscape of sports betting;
- Presentation by the Swedish national platform on the limitation of sports betting supply;
- Presentation by the Slovakian national platform on the betting on cards, ghost matches, and fake investors in football.

9. MONITORING OF INTERNATIONAL SPORT COMPETITIONS

The Advisory Group took note of the presentation by the external consultant, Chiel Warners, on the lessons learned from events monitored by the Group over the last two years.

The Group thanked the Maltese national platform for its presentation on the action plan and tasked the Working Group to submit Terms of Reference for 2024 before the end of the year.

IV. AWARENESS RAISING, EDUCATION AND CAPACITY BUILDING

10. UPGRADING NATIONAL PLATFORMS

The Advisory Group took note of the presentation by the external consultant, Christian Kalb, on the development of the national platforms.

The Group requested the Working Group to validate the 5-level framework and to submit Terms of Reference for 2024 before the end of this year.

11. ACT PROJECT (ADDRESSING COMPETITIONS' MANIPULATION TOGETHER)

The Advisory Group welcomed the development of a comprehensive education programme developed in close cooperation with UEFA.

Each national platforms are invited to express - before the end of the year - interest in participating in the training which is scheduled to take place at the end of the first quarter of 2024. Given the limited number of seats, each platform is invited to submit its application as soon as possible.

12. OPERATIONAL WORKSHOP IN COLLABORATION WITH INTERPOL AND THE IOC

The Advisory Group thanked INTERPOL and the IOC for organising a dedicated workshop for participants, which highlighted the importance of national cooperation in establishing platforms and of international cooperation across all continents.

The Group took note of the presentation by UNODC on the legal approaches to tackling the manipulation of sports competitions.

V. RESEARCH AND DEVELOPMENT OF NEW APPROACHES

13. ESPORTS

The Advisory Group took note of the presentation by the Maltese platform on the fundamentals of Esports and the Moroccan platform's overview of alerts since 2020, as well as the next steps proposed for the work to be carried out on this matter.

The Group tasked the Working Group to submit Terms of Reference for 2024 before the end of the year.

VI. INTERNAL ORGANISATION, COMMUNICATION AND VISIBILITY

14. ELECTIONS

The Advisory Group elected (or re-elected) by acclamation:

15. ACTIVITY REPORT

The Advisory Group took note of the proposed activity report for the 2022-2023 period and requested each national platform to provide additions or modifications before the end of the year.

16. STRATEGIC WORKSHOP

The Advisory Group tasked its Bureau to develop a roadmap for 2024, based on the outcome of the roundtable organised in Rabat around the following two questions:

- What is the Group's vision for the next two years?
- What is the possible level of involvement of each national platform in the Group's activities during this period?

VII. SUPPORT TO THE FOLLOW-UP COMMITTEE

17. STATE OF SIGNATURES AND RATIFICATIONS

The Advisory Group welcomed the recent ratification by France, which has become the ninth State Party to the convention.

The Group took note of the positive developments announced, among others, by the representatives of Australia, Belgium, Morocco, the Netherlands, Spain, and Sweden.

18. FOLLOW-UP COMMITTEE

The Advisory Group took note of the update provided by Georgios Mavrotas, Chair of the Follow-Up Committee, regarding the 6th meeting of the Committee (9-10 May, Paris) in Paris and the upcoming meeting in Athens, scheduled for 29-30 November 2023 during the Sport Integrity Week. The main agenda items of this meeting are data protection, Responsible/Reasonable betting, as well as Anti-Money Laundering in sports betting.

The Chair of the Follow-Up Committee invited each member or observer country of the Advisory Group to sign and/or ratify the Convention, which will celebrate its 10th anniversary in 2024. Several events will be organised to mark this occasion.

VIII. CLOSING

19. ANY OTHER BUSINESS

The Chair of the Advisory Group alerted participants about the problem of gambling addiction among professional athletes. Indeed, in England, France, and Italy, signs of an intensification of this problem have emerged in recent weeks. Major match-fixing scandals have notably shown that the gambling addiction of some athletes, referees, or coaches is often exploited by criminal networks to facilitate the manipulation of sports competitions.

Each national platform is invited to assess the situation in its country and to relay this information to the Secretariat, which will then contact the Pompidou Group (Council of Europe International Cooperation Group on Drugs and Addictions) for the organisation of a joint event on this theme.

20. Dates of future meetings

The Advisory Group took note of the possible dates for its 6th meeting, scheduled for the end of May or beginning of June 2024.
