Memorandum by the Secretariat on elections

I - RULES OF PROCEDURES OF THE CONSULTATIVE COMMITTEE

The Rules of procedures of the Committee stipulate:

“Article 10: Chair and Vice-Chairs

1. The Chair, the first Vice-Chair and the second Vice-Chair shall be elected by a majority of the members present from among the representatives for a period of two years. The elections shall not, by default, be held by secret ballot unless specifically requested.
2. The Chair and Vice-Chairs shall be eligible for re-election for a second consecutive term of office. In exceptional cases, the Chair and Vice-Chairs shall be eligible for a third consecutive term of office. However, the term shall end if they cease to be a member of the Committee.

Article 10 bis: Membership, functions and competences of the Bureau

1. The Bureau shall be composed of the Chair and two Vice-Chairs of the Committee, together with four elected members and the outgoing Chair who may remain a member *de iure* of the Bureau during the mandate(s) of the new Chair. The other members shall be elected from among the representatives on the Committee for a period of two years. The members shall be eligible for re-election.
2. If a member of the Bureau ceases to be a member of the Committee or resigns his/her office before its normal expiry, the Committee may elect a successor for the remainder of the term of that office”.

II- PRESENT SITUATION

The Bureau of the Committee comprises eight members and its current membership is as follows:

- Ms. Elsa Mein (Germany), Chair, elected in November 2022 for a term of two years.
- Ms Caroline Gloor Scheidegger (Switzerland), First Vice-Chair, elected in 2022 for a term of two years.
- Vacant, Second Vice-Chair, since May 2024
- Ms Virpi Koivu (Finland), elected in November 2023 for the remainder of the term.
- Mr Pablo M. Mateos Gascueña (Spain), elected in November 2022 for a term of two years.
- Ms Anamarija Mladinić (Croatia), elected in November 2022 for a term of two years.
- Mr Gonzalo Sosa Barreto (Uruguay), elected in November 2022 for a term of two years
- Ms Alessandra Pierucci (Italy), member *de jure* of the Bureau as outgoing Chair.

III- ELECTIONS FOR THE COMMITTEE IN NOVEMBER 2024

During its 47th Plenary meeting, from 4 to 6 November 2024, the Committee is invited to hold elections for the following posts:

- Chair of the Committee for two years
- 1st Vice-Chair of the Committee for two years
- 2nd Vice-Chair of the Committee for two years
- 4 Committee Bureau members for two years

(The remaining seat of the Bureau is attributed *de jure* to the outgoing Chair).

IV- PROCEDURE FOR ELECTIONS

Representatives of Parties to the Convention who wish to be candidates or who would like to propose another candidate are invited to inform the Secretariat of the Committee as soon as possible and no later than Monday 4 November 2024 18.00 (CET). An election by secret ballot will, when necessary, take place in Tuesday afternoon 5 November 2024 .

All candidates will be invited to send a CV a motivation letter to the Secretariat prior to the meeting and present themselves briefly under corresponding agenda item before the voting.

A valid decision on the composition of the Bureau is reached when the number of votes cast are equal to or in excess of the quorum requirement of the majority of the members of the Committee as specified in Article 9 of the Rules of procedure. For the purpose of calculating the quorum, an abstention should be seen as evidence of the committee member's participation within the meaning of Article 9.

In case of several candidates for one post (Chair or Vice Chairs), the one obtaining the highest number of votes will be elected. The other candidates can run for other posts or Bureau membership.
