- Item 1 **Opening of the meeting / Statement by the Chair and the Secretariat**
The Committee took note of the information provided by the Chair and the Secretariat.
- Item 2 **Adoption of the agenda**
The Committee adopted the agenda.
- Item 3 **Convention 108+ state of play**
The Committee took note of the information provided by the Secretariat on the signatures and ratifications of the Protocol amending Convention 108 (CETS No. 223, hereafter Convention 108+): 46 signatures out of which, 31 ratifications.
- The Committee held a tour de table on the state of play of the internal signature/ratification process in the State Parties, took note of the information provided by the T-PD members, and strongly encouraged all State Parties to sign and ratify Convention 108+ as soon as possible.
- As regards Costa Rica, the Committee took note of the information provided by the Chair and the Secretariat on the latest developments regarding the internal legislative process.
- Item 4 **Transborder data flows of personal data (MCC, Interoperability, other possible tools)**
The Committee took note of the presentation by the expert, Mr Eduardo Ustaran and the information provided by the Secretariat. The Committee held a tour de table on the actual and planned use of the adopted MCC and agreed to continue to have regular tour de table on the matter, decided to further reflect on whether to develop more tools or instruments to facilitate free flow of data at next meetings. The Committee also took note of the first forum on interoperability and convergence organised by the Secretariat in the first quarter of 2025.
- Item 5 **Interpretation of Article 11 of modernised Convention 108**
The Committee took note of the information provided by the rapporteur, Mr Gonzalo Sosa and the Secretariat, held an exchange of views on the draft text, invited delegations to send comments by 13 December and instructed the Secretariat, together with the rapporteur and the working group (GT-Art.11), to further amend the text in view of its possible adoption at the next plenary meeting in June and decided to further develop guidance at a later stage.
- Item 6 **Privacy Enhancing Technologies (synthetic data, LLMs)**
The Committee took note of the presentation by the expert Prof Chris Russell (via videocall), the information provided by the Secretariat on the privacy and data protection considerations in the context of federated machine learning and Large Language Models (LLMs). The Committee held an exchange of views and agreed on the importance and relevance of the topic.
- Item 7 **Work Programme 2022-2025 (follow up)**
The Committee held an exchange of views on the state of play of the implementation of the work programme and decided to start to work on privacy and data protection considerations in federated machine learning and Large Language Models (LLMs) as the next topic.
- Item 8 **Draft Guidelines on Data Protection in the context of neurosciences**
The Committee took note of the information provided by the rapporteur, Ms Alessandra Pierucci, the experts Dr Eduardo Bertoni and Dr Marcello Ienca and the Secretariat, held an exchange of views, and invited delegations to send comments by 30 November and instructed the Secretariat, together with the rapporteur to further amend the text for discussion at the next meetings.

- Item 9 **Cooperation with other Council of Europe bodies and entities**
The Committee took note of the information provided by the Secretariat of the Venice Commission, the Steering Committee for Human Rights in the fields of Biomedicine and Health (CDBIO), and the Committee on Artificial Intelligence (CAI). The Committee encouraged its members to reply to the questionnaire to be sent out by the Secretariat in connection of the update of the Rule of Law Checklist by the Venice Commission.
- Item 10 **Developments and activities in the field of data protection**
The Committee took note of the information provided by the participants and Secretariat, notably on the following events: Privacy Symposium (10-14 June, Venice), International Working Group on Data Protection in Technology (18–19 June 2024, Oslo), EuroDIG (17-19 June, Vilnius), International Conference QUO VADIS AI (18 June, Athens), GR-J (20 June, Strasbourg), 10th Session of the OECD Working Party on Data Governance and Privacy (28 June, Paris), 37th International Conference on Privacy Laws & Business (1 July, Cambridge), a global privacy sweep by GPEN (July 9 2024), Data Protection Academy for the Western Balkans and Eastern Partnership Region (9-13 September, Brussels), Summer Course on European Data Protection Law (16-20 September, Trier), the first Atlantic Inter-Network Meeting of Personal Data Protection Authorities (26 September 2024, Rabat), EU-LAC High-Level Dialogue on Data Governance (30 September - 1 October, Montevideo), G7 Privacy Roundtable (10 October, Rome) and 46th Global Privacy Assembly (28 October - 1 November, Jersey).
- Item 11 **Cooperation**
The Committee took note of the various cooperation programmes relevant to data protection, in particular on the on-going institutional support to beneficiaries of the Southern Mediterranean region (South V and the upcoming VI Programme), notably in Jordan, Lebanon, Libya, Egypt, Algeria and Tunisia as well as on-going and possible future cooperation with data protection authorities under several Council of Europe Action Plans, notably on Moldova, Ukraine and Armenia. The Secretariat provided information also on the potential of further cooperation projects.
- Item 12 **Elections**
The Committee organised the elections of the Bureau. The following members have been elected: Beatriz de Anchorena, Argentina (Chair), Caroline Gloor Scheidegger, Switzerland (1st Vice-chair), and Anamarija Mladinic, Croatia (2nd Vice-chair). Alessandra Pierucci, Italy, Virpi Koivu, Finland, Gonzalo Sosa Barreto, Uruguay and Ousmane Thiongane, Senegal, were elected as Bureau members.

The Committee thanked the out-going members for their outstanding contribution to the work of the T-PD and congratulated the in-coming Bureau members.
- Item 13 **Data Protection Commissioner**
The Committee took note of the information provided by the Data Protection Commissioner and the Secretariat regarding the Commissioner’s activities during his ad interim period.
- Item 14 **Observers**
The Committee took note of the information provided by the observers and participants to the meeting, notably by the representatives of ICRC, Israel, EDPS, GPA, Brazil related to recent and forthcoming events and ongoing internal legal works towards potential future cooperation with the committee.
- Item 15 **Next meetings**
The Committee took note of the dates of the next plenary meeting to be held on 17-19 June 2025 (48th) in Strasbourg, as well as of the next Bureau meetings on 19-20 March 2025 (63rd) and 17-18 September 2025 (64th) (TBC) in Paris.
