The Council of Europe supports Ukraine in reforming its justice system through the project "Support to the implementation of the judicial reform in Ukraine". In that context, it is looking for a Provider for the provision of intellectual services for delivery of a sociological survey on the attitude of citizens to the judiciary in Ukraine and their assessment of various aspects of the courts.

A. TENDER PROCEDURE RULES

This tender procedure is a competitive bidding procedure. In accordance with Rule 1395 of the Secretary General of the Council of Europe on the procurement procedures of the Council of Europe¹, the Organisation shall invite to tender at least three potential providers for any purchase between ξ 5,000 for intellectual services and ξ 55,000 tax exclusive.

This specific tender procedure aims at concluding a **one-off contract** for the provision of deliverables described in the Act of Engagement (See attached). A tender is considered valid for 120 calendar days as from the closing date for submission. The selection of tenderers will be made in the light of the criteria indicated below. All tenderers will be informed in writing of the outcome of the procedure.

The tenderer must be a legal person except consortia.

Tenders shall be submitted **by email only** (with attachments) **to the email address indicated in the table below, with the following reference in subject:** "*Purchase of intellectual services in Ukraine_8563/2020/9*". Tenders addressed to another email address **will be rejected**.

A. EXPECTED DELIVERABLES

The expected deliverables are described in Section A of the Act of Engagement (see attached).

B. FEES

All tenderers are invited to fill in the **table of fees** as reproduced in **Section A of the Act of Engagement**. Tenderers should take into account that the total amount of fees cannot exceed **30 000 euro**.

Tenderers **<u>subject to VAT</u>** shall also send **a quote (Pro Forma invoice)** on their letterhead including:

- the Service Provider's name and address;
- its VAT number;
- the full list of services to be provided;
- the fee per type of deliverables (in the currency indicated on the Act of Engagement, tax exclusive);
- the total amount per type of deliverables (in the currency indicated on the Act of Engagement, tax exclusive);
- the total amount (in the currency indicated on the Act of Engagement), tax exclusive, the applicable VAT rate, the amount of VAT and the amount VAT inclusive.

C. ASSESSMENT

Exclusion criteria and absence of conflict of interests

(by signing the Act of Engagement,² you declare on your honour not being in any of the below situations) Tenderers shall be excluded from participating in the tender procedure if they:

- have been sentenced by final judgment on one or more of the following charges: participation in a criminal organisation, corruption, fraud, money laundering;
- are in a situation of bankruptcy, liquidation, termination of activity, insolvency or arrangement with creditors or any like situation arising from a procedure of the same kind, or are subject to a procedure of the same kind;
- have received a judgment with res judicata force, finding an offence that affects their professional integrity or serious professional misconduct;
- do not comply with their obligations as regards payment of social security contributions, taxes and dues, according to the statutory provisions of their country of incorporation, establishment or residence;
- are or are likely to be in a situation of conflict of interests.

Eligibility criteria

- Tenderer should be registered as a legal entity under the Ukrainian legislation and should be authorised to provide the services in question;
- At least 3 (three) years of experience of provision of services in the fields of sociological surveys, research and analysis;
- Tenderer should have its own sociological service present in different regions of Ukraine.

Award criteria

- Quality of the offer (70%), including:
 - questionnaire and the methodology of the survey proposed (30%);
 - demonstrated expertise of the Tenderer in conducting sociological surveys on the rule of law and functioning of the judiciary in Ukraine, experience of cooperation with Ukrainian authorities or international organisations (40%).
 - Previous engagement by Council of Europe projects would be considered as an advantage;
- Financial offer (30%).

The Council reserves the right to hold interviews with eligible tenderers.

Multiple tendering is not authorised.

D. NEGOTIATIONS

The Council reserves the right to hold negotiations with the bidders in accordance with Article 20 of Rule 1395.

² The Council of Europe reserves the right to ask tenderers, at a later stage, to supply an extract from the record of convictions or failing that an equivalent document issued by the competent judicial or administrative authority of the country of incorporation, indicating that the first three above listed exclusion criteria are met, and a certificate issued by the competent authority of the country of incorporation indicating that the fourth criterion is met.

Tenderers are invited to submit:

- A completed and signed copy of the Act of Engagement³ (see attached)
- Copies of documents certifying the registration of the Tenderer under the Ukrainian legislation;
- A detailed description of the Tenderer and its experience in provision of services in question;
- A report of the Tenderer, prepared following a sociological survey with regard to the rule of law and functioning of the judiciary in Ukraine;
- Examples of other analytical documents prepared by the Tenderer in English;
- Draft questionnaire for a sociological survey of the general population and of court users on the trust to the judiciary (at least 20 questions).
- Detailed financial offer;
- For tenderers subject to VAT <u>only</u>: **a quote, describing their financial offer**, in line with the requirements of section C of the Tender File (see above);

All documents shall be submitted in English, failure to do so will result in the exclusion of the tender.

If any of the documents listed above are missing, the Council of Europe reserves the right to reject the tender.

The Council reserves the right to reject a tender if the scanned documents are of such a quality that the documents cannot be read once printed.
