The Council of Europe is currently implementing the project "Further support for the execution by Ukraine of judgments in respect of Article 6 of the European Convention on Human Rights" (hereinafter – the Project), which assists the Ukrainian authorities in providing accessible, full and effective justice through the execution of judgments of the European Court of Human Rights in which violations of Article 6 of the European Convention on Human Rights are established. The Project started in November 2019 and will continue until June 2021.

In that context, it is looking for a Provider for the provision of book publishing services including designing, proofreading, printing, and delivering of the publication (see Section A of the Act of Engagement).

A. TENDER PROCEDURE RULES

This tender procedure is a competitive bidding procedure. In accordance with Rule 1395 of the Secretary General of the Council of Europe on the procurement procedures of the Council of Europe¹, the Organisation shall invite to tender at least three potential providers for any purchase between €2,000 (or €5,000 for intellectual services) and €55,000 tax exclusive.

This specific tender procedure aims at concluding a **one-off contract** for the provision of deliverables described in the Act of Engagement (See attached). A tender is considered valid for 120 calendar days as from the closing date for submission. The selection of tenderers will be made in the light of the criteria indicated below. All tenderers will be informed in writing of the outcome of the procedure.

The tenderer must be a legal person except consortia.

Tenders shall be submitted by email only (with attachments) to the email address indicated in the table below, with the following reference in subject: *Tender – 8683/2021/6 Publishing services*. Tenders addressed to another email address will be rejected.

B. EXPECTED DELIVERABLES

C FFFS

Tenderers subject to VAT shall also send a quote (Pro Forma invoice) on their letterhead including:

- the Service Provider's name and address;
- its VAT number;
- the full list of services to be provided;
- the fee per type of deliverables (in the currency indicated on the Act of Engagement, tax exclusive);
- the total amount per type of deliverables (in the currency indicated on the Act of Engagement, tax exclusive);
- the total amount (in the currency indicated on the Act of Engagement), tax exclusive, the applicable VAT rate, the amount of VAT and the amount VAT inclusive.

D. ASSESSMENT

Exclusion criteria and absence of conflict of interests

(by signing the Act of Engagement,² you declare on your honour not being in any of the below situations) Tenderers shall be excluded from participating in the tender procedure if they:

- have been sentenced by final judgment on one or more of the following charges: participation in a criminal organisation, corruption, fraud, money laundering, terrorist financing, terrorist offences or offences linked to terrorist activities, child labour or trafficking in human beings;
- are in a situation of bankruptcy, liquidation, termination of activity, insolvency or arrangement
 with creditors or any like situation arising from a procedure of the same kind, or are subject to a
 procedure of the same kind;
- have received a judgment with res judicata force, finding an offence that affects their professional integrity or serious professional misconduct;
- do not comply with their obligations as regards payment of social security contributions, taxes and dues, according to the statutory provisions of their country of incorporation, establishment or residence;
- are or are likely to be in a situation of conflict of interests.

Eligibility criteria

- Minimum 3 years of experience in providing of publishing and printing or similar services;
- The tenderer should be registered as a legal entity under the Ukrainian legislation and should be authorised to provide the services on publishing and other printing production.

Award criteria

- Quality of the offer (60%), including:
 - Human resources allocated to perform the deliverables described in the Terms of reference;
 - Technical capacity to meet the deadlines indicated in the Terms of reference.
- Financial offer (40%).

Multiple tendering is not authorised.

E. NEGOTIATIONS

The Council reserves the right to hold negotiations with the bidders in accordance with Article 20 of Rule 1395.

F. DOCUMENTS TO BE PROVIDED

Tenderers are invited to submit:

• A completed and signed copy of the Act of Engagement³ (see attached)

² The Council of Europe reserves the right to ask tenderers, at a later stage, to supply an extract from the record of convictions or failing that an equivalent document issued by the competent judicial or administrative authority of the country of incorporation, indicating that the first three above listed exclusion criteria are met, and a certificate issued by the competent authority of the country of incorporation indicating that the fourth criterion is met.

- For tenderers subject to VAT <u>only</u>: **a quote, describing their financial offer**, in line with the requirements of section C of the Tender File (see above);
- Registration documents (scanned copies of registration documents certifying the type of economic activity of the tenderer) with short summary in English;
- Brief description of the company's experience in provision of the publishing services;
- CVs / description of experience of the allocated persons in provision of the services under the contract;
- Description and/or photo(s) of the technical equipment and tools to be used for performing the contract.

All documents shall be submitted in English, except for registration documents (to be submitted in Ukrainian with short summary in English), failure to do so will result in the exclusion of the tender.

If any of the documents listed above are missing, the Council of Europe reserves the right to reject the tender.

The Council reserves the right to reject a tender if the scanned documents are of such a quality that the documents cannot be read once printed.
